# **FROM THE PRESIDENT**

I received a lot of comments about my letter in last month's newsletter - both complimentary/ supportive & critical. That's fine. We need to know what you are thinking, also what your concerns are. Unless you give us your thoughts & feedback, we don't know.

Since United filed Chapter 13 bankruptcy, key things that have affected retirees are pass travel, then health insurance and now pension issues. The company has made the decision not to make pension contributions while in bankruptcy. According to the company, the renegotiated bankruptcy financing preempts making pension payments. Beyond that, United has made no further decision regarding the pension plans. Several employee groups & unions are challenging the legality of this. A lot of individuals, groups & the media are speculating all over the map on this. There is a lot of misinformation and incomplete information being circulated. Be cautious and discriminating of what you read, hear & pass on to others.

RUAEA's primary position is for United Airlines to survive, successfully exit bankruptcy & become a viable sustainable company. If United does not survive, all the retiree benefit issues including travel & health insurance is moot. Our pensions will be decided by the Pension Benefit Guarantee Corporation. We are committed to assist and support the company in whatever ways we can in its recovery.

Secondly, after the company's survival, our concerns are the retirees' interests. United's stated financial needs that affect retirees benefits must be confirmed and be a legitimate necessity for survival. We believe all retirees should be treated equally and consistently. One group should not be given benefits to make concessions at the expense of another group. Legally, each union represents the retirees from the class & craft it represents. An example of this working was the negotiation and coalition of groups in the health insurance issue.

We are interested that the concerns and issues of all retirees are heard, communicated & considered when the tough decisions are being made., Remember, RUAEA is the only organization of all retirees regardless of the job or position held.

We are working on getting better in communicating with you through the Newsletter, our Website & our Regional Directors. This is a two-way street. We want to communicate more effectively with you; we are working on ways you can communicate more effectively with us & on better ways to do this. It's through this free exchange that we can better reflect your interests, issues & concerns. My criteria of "good information" is it must be accurate, complete, current & timely.

Our second thrust is to be your "voice" reflecting your interests, issues & concerns with the principals in United who are making the decisions that affect you. As I mentioned, there are legal issues as to who legally represents whom. Our focus is to represent our retirees and provide the kind of input that would influence the decisions being made. We have never been in this role before. This is something that does not happen quickly. We need to earn our credibility. We are working very hard in this area.

A number of your officers, directors & appointees are working on these areas right now. Over the next couple of months we will be implementing some of these strategies. We will keep you informed on these developments. We will be counting on each of you for your support & inputs. Together we retirees can make a difference.

### FROM THE MEMBERSHIP TEAM

I've been asked if I would write an article on how to get access to the web newsletter, or how to return to receiving the paper copy of the newsletter. As you know, if you elect to get your newsletter via the web, you will no longer receive a paper copy and vice-versa. This is due to the economics of the newsletter. Also, you "Must" have Adobe Acrobate to read the newsletter on the WEB. It is easy; to acquire & download as there is a link right at the web to get the "FREE" software. If you can't get it

to download, contact me at <a href="mailto:ruaea@aol.com">ruaea@aol.com</a>. This is the e-mail address at the office.

#### **Accessing the Web Newsletter**

First lets look at the process to get access to the WEB newsletter. First you must send an e-mail to the Membership Secretaries requesting to get access to the web newsletter. The information we need is your name, file number & a statement that you want to receive your newsletter via the web. As a reminder, you must be current with your dues. If not we will let you know. As soon as we receive your current dues we will notify the Web Master that you are now eligible to access the web.

Once you have completed the above, wait for about five days, then go to the website at <a href="https://www.ruaea.org">www.ruaea.org</a>. On the left of the page look for the word Newsletter. Click on this; another screen will appear. If you aren't registered, click in the line to register. Another page will appear; follow the directions as they are spelled out. The Web Master will need your file number, e-mail address & a password so that may become part of your profile.

Once your profile is established, the Web Master will notify you that you have access. Also once a year on your birthday the Web Master will notify you when your dues are due. This will prevent interruption to your access.

#### **Return to receive the Paper Newsletter**

If you decide that you no longer wish to receive the newsletter via the web, the following is the process to receive the paper newsletter.

Send an e-mail to the Membership Secretaries, CC'ing the Web Master at <a href="Support@RUAEA.ORG">Support@RUAEA.ORG</a> stating you wish to receive the paper newsletter. You will receive the next available mailing of the newsletter. Depending on when we receive your request will determine when you will receive the next paper edition. Sending in your request at the beginning of the month will almost assure there will be no interruption to the newsletter. Again, with this change you will not have access to the Newsletter on the WEB.

One last item, our secretaries are only in the office on Mon., Wed. & Fri. Their hours are normally between 9:00 a.m. to 1:00 p.m. on these days. So if you need to speak to them, these are the days & hours to call.

# UNITED AIRLINES HISTORICAL FOUNDATION

Sara Dornacker, President of the United Airlines Historical Foundation, was employed Aug. 2, 1967 as a Flight Attendant, progressing to Supervisor of Onboard Services in Washington, D.C., New York City & Cleveland. From there, she moved to Chicago as Safety Manager, then Media Relations Manager, returned to Onboard Services to help with the communications during United's international expansion in the 1990s. 2003, Sara joined the Airport Operations Division where she is the recognition advocate for 21,000 employees at 113 airports around the world. Sara serves on the board of 3 non-profit organizations, including the Soong Ching Ling Foundation of the China Welfare Institute in Shanghai, China. Her involvement in the UAHF came about through her longtime membership in Clipped Wings. She has been directly involved in planning the 40<sup>th</sup> 50<sup>th</sup> & 65<sup>h</sup> anniversary celebrations honoring Ellen Church & the "Original Eight" stewardesses. Sara has a strong commitment to preserving & acknowledging United's past as well as inspiring the youth of today.

### **UAHF FLIGHTS INTO THE PAST**

The weekend of Sept. 25-26 promises to be an exciting and memorable one for the United Airlines Historical Foundation (UAHF).

## September 25

After a two-year effort by the Experimental Aircraft Association and our Foundation, on Satuday, the 25<sup>th</sup>, a 1926 Swallow Mailplane will take to the air out of the Aurora Regional Airport in Aurora, IL. The Swallow, fully restored and all decked out in the colors of United's original predecessor, Varney Air Lines, will make several lift-offs carrying its pilot and a single passenger on an open-air tour of the Chicago suburbs.

Further, former United pilot, Captain Clay Lacy of Van Nuys, CA, will be on hand with his beautifully restored DC-3, which sports the UAL colors of the early 1950s & a modern corporate

lounge passenger cabin. This aircraft too will offer several flights over the nearby countryside.

# September 26

On Sunday, the 26<sup>th</sup> both aircraft will be flown from Aurora to the Schaumburg, Regional Airport in Schaumburg, IL where they will be featured in static display from 1 p.m. to 4:30 p.m. at Schaumburg's annual Family Aviation Day event. UAHF will also present a large historical display, former United flight attendants in vintage uniforms, active & retired United pilots who will share their flying experiences with attendees. Additionally, the Foundation will make available a selection of branded items for sale. We are still exploring other features to add to our exhibit.

If you are in the Chicago area, we cordially invite you to visit with us the weekend of Sept. 25 & 26. Chances are you will be greeted by friends from RUAEA, who have volunteered to help host the events. UAHF truly appreciates RUAEA's participation & support.

As this newsletter goes to press, a number of details are still being coordinated, including scheduled take-offs, flight availability, air fares, etc. These specifics will be announced shortly. # NONSTOP DENVER-PITTSBURGH SERVICE

Oct. 4, United will begin service between DEN & PIT with 2 daily nonstop flights.

We serve more domestic cities from DEN than any other carrier; launching PIT service reinforces our commitment to the DEN area.

The new route will be flown with 737-300s. Flights from DEN depart 10:00 a.m. & 6:30 p.m.; flights from PIT depart 9:00 a.m. & 5:45 p.m.

### NONSTOP CHICAGO-SHANGHAI SERVICE

On Oct. 31, United will begin new daily, nonstop flights between Chicago O"Hare International Airport & Shanghai Pudong International Airport.

United will operate combined passenger & cargo service between CHI & Shanghai using Boeing 777 aircraft configured with 10 United First Suite seats, 45 United Business seats & 198 United Economy class seats, which includes an Economy Plus section.

Flight 835 will depart CHI 12:15 p.m. beginning Oct. 31 & arrive in Shanghai 4:50 p.m. the following day. Beginning Nov. 1,United Flight 836 will depart Shanghai 7:10 p.m & arrive in CHI 7:05 p.m. the same day. Flight times are subject to change.

### SFO-VIETNAM SERVICE VIA HONG KONG

United will begin daily SFO-Ho Chi Minh City service via Hong Kong effective Dec. 9, 2004, following completion of the application process with the government of Vietnam. The first flight will arrive in Ho Chi Minh City on Dec. 10, 2004.

Service will combine passenger & cargo service using Boeing 747-400 aircraft configured with 14 United First Suite seats, 73 United Business seats & 260 United Economy class seats.

United Flight 869 will depart SFO 12:10 p.m. on Dec. 9, arrive in Hong Kong 7:00 p.m. Dec. 10. The continuing flight will depart Hong Kong 8:55 p.m., arrive in Ho Chi Minh City 10:25 p.m. Beginning Dec. 11, United Flight 862 will depart Ho Chi Minh City 6:15 a.m., arrive in Hong Kong 9:40 a.m. The continuing flight will depart Hong Kong 1:05 p.m., arrive in SFO 8:40 a.m. the same day.

# **CHICAGO-MAUI-KONA SERVICE**

Dec. 16, United will begin flying its 2<sup>nd</sup> nonstop flight from CHI to the Hawaiian Islands with direct service to Maui, continuing service to Kona. This daily roundtrip route will originate at CHI O'Hare, fly nonstop to Maui, travel on to Kona. Then return nonstop to CHI, making it the only nonstop flight from Kona to CHI in the marketplace.

Flight #3, Boeing 777, will depart CHI 10:00 a.m. CST, arriving in Maui 2:51 p.m. local time. The aircraft then will depart Maui 4:00 p.m., arriving in Kona 4:40 p.m. For the flight's last leg, it will depart Kona 6:00 p.m., arrive in CHI 5:54 a.m. the following morning.

United currently provides 23 daily nonstop flights to HWI from LAX, SFO, DEN & CHI. DEN & CHI have been serving HWI since 1947. Also United flies to HNL nonstop from both Tokyo & Oaska.

# NEW SERVICE WITH U.S. FALL SCHEDULE

With the fall schedule change, United & United Express will begin additional daily nonstop service to 11 markets, including new service to Myrtle Beath, from CHI & Washington Dulles hubs.

The U.S. fall & winter schedule change includes the following new service.

### Oct. 4, from CHI -

- 2 daily nonstop roundtrip mainline flights to Albuquerque, NM
- 2 daily nonstop roundtrip mainline flights to Tucson, AZ
- 1 daily nonstop roundtrip mainline flight to Palm Springs, CA
- 2 daily nonstop roundtrip United Express flights to Edmonton, Canada, operated by SkyWest.

# Oct. 4, from Washington Dulles

- 3 daily nonstop roundtrip United Express flights to Memphis, TN, operated by Air Wisconsin
- 3 daily nonstop roundtrip United Express flights to Wilkes-Barre/Scranton, PA, operated by Shuttle America
- 2 daily nonstop roundtrip United Express flights to Milwaukee, WI, operated by Air Wisconsin.

### Oct. 17, from Washington Dulles

• 2 daily nonstop roundtrip United Express flights to Houston with a 3<sup>rd</sup> daily flight to begin on Oct. 31. Chautaqua Airlines will operate these flights.


