FROM THE PRESIDENT

I have been meeting with many retirees around the country. Most questions & concerns center on pensions, health insurance & passes. Last month I mentioned that I would discuss health insurance this month. But first I want to comment very briefly about passes & pensions.

Passes. The only change to retiree pass travel has been the establishment of service charges. In our discussions with the principals at United it is reconfirmed that there are no further changes planned. Service charges for retirees will remain in effect. After United exits bankruptcy we are invited to discuss retiree travel policies & procedures

Pensions. We have written a number of articles about our pensions, the PBGC, etc. over the past 10 months. What we discussed last Nov. & Jan. is now occurring. You are currently receiving information from the PBGC. I encourage you to read all of it very carefully; fill out, return any & all the information they are requesting.

Medical insurance. (Mort Wax wrote a comprehensive article about this in the Jan. 2005 Newsletter. I will reiterate many of the things Mort said.) Almost all the questions & concerns are:

- One, about United canceling or changing our medical insurance.
- Two, are there better plans out there in the marketplace – cheaper & better benefits?

Regarding item one. Last summer the bankruptcy judge appointed unions & individuals to represent groups of retirees in negotiating medical insurance benefits & costs with United. These groups collaborated with each other for fairness & consistency. The Judge approved the agreements. Under Section 1114 of the Bankruptcy Code the company cannot change any of the provisions agreed upon. (The only exception is if United files Chapter 7, liquidates or comes out of Chapter 11 and subsequently files Chapter 11 again.) Bottom line, as long as United is a viable company, United cannot cancel or change our current medical insurance.

Regarding item two. Last Dec. Mort Wax, Chuck McErlean, two people from the Retired United Pilots Association & I met with financial advisors & insurance underwriter analysts. We presented them with United's medical insurance plans and asked them to research what's available in the marketplace. Are there better plans in terms of benefits & costs than what United is offering? Their recommendation was, "Keep what you have!" Mind you they are in the business of selling these services; they recommended; "Keep what you have." A key reason is that United is paying part of the costs of the medical insurance they are providing us. An independent underwriter prices their benefits to recoup their costs, plus a profit margin. Thus they are unable to offer the benefit package at the premium United is charging us.

Given this, RUAEA's position is to support the medical insurance that is offered by United.

Even after sharing this advice, many retirees have asked us what else is available. If you have doubts & want to explore this further on your own, I encourage you to check it out. To explore this further I suggest:

- [www.chooseyourbenefits.com] In this website you can input the features and benefits important to you. It will search companies offering that along with the costs.
- [www.Medicare.gov] Their telephone number is 1-800-633-4227.
- AARP is popular with retirees. They have good information, a large consumer base, are easy to access & get information.

- Most health insurance companies offer the 10 standard Medicare supplemental plans A – J. You can contact any of them for detailed feature and benefit information along with costs.

If you decide to search independently do your homework, make a very informed & deliberate decision. If you decide to cancel what United offers you probably will not be able to rejoin. This is an important decision.

"This year's RUAEA convention was a mix of concern over the situation that the airline industry finds itself in now and nostalgia for times past. It looks like the heydays of the Legacy Carriers are numbered. Like many things over the past fifty years, the airline industry is changing. Just be grateful that we were not in the typewriter repair business. Airlines will be around for a long time to come, but they will look different from what many of us remember. Current employees will never have the memories of what we can look back on as the "Golden Age of Aviation."

Remember when there were basically two groups of people who traveled? Those who were wealthy enough & those of us who worked for an airline. Women wore their nicest dresses & jewelry while men wore suits & ties. Flying was expensive and considered glamorous. How many times did you hear neighbors and friends ask if you could smuggle them onto a flight, even in "steerage"?

I was reminded of when our airplanes had lounges, both in Coach and in First Class. They were supposed to be for the use of the paying passengers who could sit across from each other, while playing cards or just chatting. Often, though, they were filled up with those of us who were going standby.

One retiree reminded us of Red Carpet Service, when an actual red carpet was rolled out for passengers flying First Class. Passengers in first class had gold embossed nametags to block their seats. Also, match packages were embossed with first class passenger's names.

Some folks remembered an exotic service on some of our long haul flights. The chef would fly in First Class and don his chef's garb, tall hat and all. He would then serve the meal along with the stewardesses, often carving Beef Wellington at your individual seat.

Many remembered the Royal Hawaiian Service between the mainland & Hawaii. Menehune dolls on swizzle sticks were in each drink. Polynesian meals were leisurely served in courses along with plenty of libations. The movies, something new with jet travel, would have been edited just for airline watching. 'Guess-the-halfway-point'

contests were played by filling out your estimate on a contest form; the pilots would announce the winners. Bottles of champagne were given to the passengers who had guessed the closest time when the plane would cross the "halfway point" between the West Coast & Honolulu.

I remembered Executive Flights for Men Only from Chicago to New York. These flights offered cigars & slippers, plus steak dinners. Gifts of golf balls, cuff links, and cigarette lighters were given onboard. Pat Smith was possibly one of the few women who was a passenger on an Executive Flight. We were traveling home from New York, the only flight to Chicago was the Men's Only one. We were riding standby; the agent boarded us on the Executive flight, since we would have been stuck in New York if we hadn't gotten on that plane. It was extravagant!

People remembered the Mainliner Clubs, with annual picnics & Christmas parties. These were parties where dozens of envelopes with free passes on other airlines were given away as door prizes.

Another nostalgic memory was of the Interline Parties. These were the parties where all the airlines got together and enjoyed eating, drinking and dancing together. We were all in the same business - we didn't really compete with each other. Those were the parties where you hoped your ticket would not be picked for a domestic pass on United, because you wanted it left in the drawing for "anywhere on the system" for Pan Am, JAL, or Philippine Airlines.

The airline industry is changing. Airlines will be around for a long time, but the airline world of the past is something only we few retirees will remember. The people now working in our industry will never experience that exciting time we lived through. Many concessions are being made to insure that United continues to exist, but none of us will ever have to give up our memories of the Golden Age of Aviation."

Non-revenue travel & interline travel has been more difficult due to the increase in load factors. Bruce has expressed his desire to step down as Pres. at the end of this year.

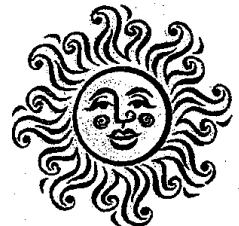

Ned introduced our DEN guests: Nancy Goodyear & Marilyn Lade, thanking them for bringing their husbands, Tom & Marlin, respectively.

Tom, our Regional Director, was first up, addressing RUAEA conventions past & future. Next year it will be at the Marriott in Washington, DC over Memorial Day, May 22-27. He recognized old friends in the audience, mentioning several by name. We'd like to tell you everything that he said, but that would spoil it for those chapters yet to be called upon. Marlin, RUAEA president, very effectively gave us the vital

information & assurances we were hoping to hear, but first he recognized Bob & Joyce Wicklund who were there to hear Marlin's speech. He & Bob worked together in various customer service jobs, & are long-time friends. It was like old home week in Boise, the City of Trees.

Marlin's talk was in three parts: 1) the state of UA, 2) our benefits (pensions, insurance & passes), & 3) the new role of RUAEA. I wish time & space permitted us to repeat it all. I made copious notes, which I couldn't possibly read; were mostly over my head anyway, so I'll only recap a few highlights, knowing that you have already read most of them printed earlier in the RUAEA Newsletter. Another progress report from Marlin will appear in the upcoming Newsletter.

He stressed the serious impact that fuel costs are having on airlines, preventing nearly all from showing a profit. For example: an increase of only one cent a gallon would set UA back \$20 million a year, however, considering money taken in vs. money paid out, UA had an operating gain for the second quarter of \$48 million. This doesn't count the write-off costs, which affect the bottom line. Marlin also explained the tricky legal steps in exiting bankruptcy, which will result in the resolution of all claims, debts, & reorganization plans. This was expected to happen this fall, but UA has since postponed the exit to better improve its chances of success. It is known that the judge wants assurance that once relieved of its debts that UA would prove to be a viable company & not return to bankruptcy.

Marlin next gave a comprehensive overview of how benefits will be impacted. This is not the place for the details, since they are being detailed in the Newsletter. Marlin did assure us though that he, Mort Wax & Ed Tolly meet with UA management on a regular basis. The meetings are constructive & productive. It is the goal of RUAEA to ensure fair & equitable treatment of retirees. Thank you Tom & Nancy, & Marlin & Marilyn. It was thoughtful of you to devote your weekend to us. We're glad you visited Boise, the Warhawk Air Museum, & the GEMS. We all feel better for your assurances.

On a sad note, we must tell you of the loss of a very dear friend, Capt. Charles W. Law, on July 18. He had been ill since Thanksgiving. Charlie was born in Baker City, OR. He loved sports of all

kinds & was an active participant in most. His love for flying began when he joined the Army Air Corps in Oct. 1939. He served his country as a pilot during three wars. 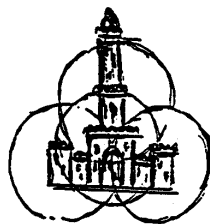

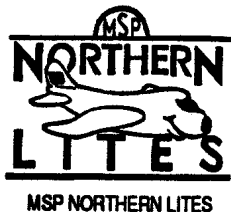

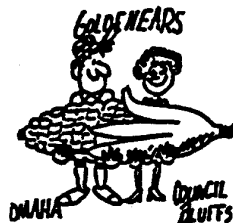
