## Sacramento and Beyond

Come out West! May 27 – June 2, 2007



The 2007 RUAEA Convention will be in Sacramento at the Hyatt Regency at Capital Park. The State Capital & Capital Park are just across the street. Old Sacramento is about a dozen blocks to the west on the Sacramento River. There are many attractions in "Old Sac' most notable is the California Railroad Museum. This area was the western terminus of the Pony Express. In future issues we will highlight other points of interest in Sacramento. The surrounding area has a plethora of inviting sites. There are wonderful wineries with not so famous names, old gold mines, many picturesque towns that date back to the Gold Rush days.

So just where is Sacramento? It is located in the upper San Joaquin Valley, 90 northeast of SFO, 383 miles north of LAX & about 120 miles west of Reno & Lake Tahoe. The city dates back to 1839. After the Gold Rush was central to many types of agriculture. Tomato crops, rice paddies along with fruit & nut orchards made up the surrounding area. Sacramento is presently home to approximately 500,000 inhabitants with almost 2 million in the metropolitan area. The Sacramento Visitors and Convention Bureau have a great website, check it out at <a href="https://www.discovergold.org">www.discovergold.org</a>.

Next...how does one get to Sacramento? SMF is served by 13 airlines with about 161 flights daily. United is the number 2 carrier in town with 28 flights; 5 from DEN, 5 from CHI, 1 from Washington Dulles, 5 from LAX & 9 from SFO. Most of the LAX flights & all of the SFO flights are operated by United Express. The other airlines serving Sacramento are Alaska, Aloha, American, America West/USAirways, Continental, Delta, Frontier, Hawaiian, Jet Blue, Mexicana, Northwest & Southwest. The 'big guy' in town is Southwest with 80 some flights. All of these airlines with the exception of Southwest & Jet Blue offer retirees 90% discounts on space available travel. Southwest & Jet Blue offer retirees \$25 one-way & \$50 round trip plus taxes. To get interline tickets call the Interline Ticket Center at 1-888-874-1581. Their hours are 7 am to 9 pm central time 7 days a week. For Southwest you will need a letter of introduction from the Benefits Center, their number is 1-888-825-0188.

More next month, hope to see you in Sacramento in 2007.

#### FROM THE PRESIDENT 8/6/06

Over the past few weeks, several of our members have asked for answers to a number of questions. Some have come up over the past months, others have come up recently. The following is to let you know the results of the discussions which have taken place on their, and your, behalf.

We have received many questions regarding the distribution of stock & cash from the proceeds of the sale of stock to retirees and/or their beneficiaries. One of the most frequently asked questions is why payroll taxes were deducted from the distributions of cash/stock arising from payment for the unsecured Section 1114 claim from the medical plan revision. In a June 16 meeting Ed Tolle & I had with Frances DeBlasio, United's Director - Restructuring Office, we determined an explanation, if not an answer, to the questions. The company, along with its legal & tax advisors, determined that the sale of stock and distribution of cash to retirees for Section 1114 claims was considered, therefore, would be taxed, as wages. The determination was based on interpretation of the IRS Tax Code, court cases & related precedents. Moreover, United's counsel discussed the rationale behind the taxation of these claims distributions with Section 1114 Coalition Committee's counsel acting as liaison between the Company & the various retiree group constituencies, providing them with various cases & rulings on the subject. The counsel could not object to United's tax treatment of these claims distributions on the basis of the cases & rulings on the subject. Finally, it's important to note, that in accordance with tax law, the company had to pay the employer's portion of FICA on these distributions which was a considerable addition to its own costs. Based on this explanation, I think it best to repeat that if you don't agree with that interpretation you (and your tax advisor) might consider challenging it in your tax filing, not with the company. I know this is not an answer or explanation which will make anyone experiencing the deduction happy. Each individual is going to have to make his/her own decision on how far they want to push this question with the government through their own advisors.

Questions have also been asked about what cost basis should be used for the calculation of capital gains/losses for those that received stock (for those that received cash in the form of a check, this is not an issue). If or when you sell your stock, your capital gain/loss will need to be determined in order to calculate how much you may owe in taxes. There are multiple ways in which the cost basis can be established, among which are the opening market price on the day of receipt, average market price during the day of receipt, etc. Again, I am going to have to suggest that you discuss the cost basis issue with your tax advisor.

On July 18, again with Ed Tolle, I met with Glenn Tilton, Sara Fields & Randy Rotondo (Director of Human Resources). Ed & I gave Glenn feedback on the Washington convention. Glenn described for us the Continuous Improvement program by which the Company intends to enhance its operations. Ed & I described how difficult it is for retirees to find a Company resource for an answer to their question if an out-of-the-ordinary issue is unable to be handled by either the Benefits Service Center or the Retiree Service Center.

We have also been questioned about the eligibility of some of our recent retirees for cash payment arising from the sale of the convertible notes issued by the Company as part of the Plan of Reorganization to partially offset the retirement benefits that active employees lost when United's pension plans were terminated. Such sale has been approved by each union's leadership, & by United's senior leadership on behalf of Salaried & Management employees. The determination of eligibility & the formula(s) by which the allocations will be accomplished was also determined by the unions & United's senior leadership, as appropriate. Eligible individuals will be notified by the Company of the specifics applicable to their allocation.

As they have become available, I have been collecting the eligibility rules and have received them for SAM & IAM employees. As I get the balance (from wherever) I will post them on the website and publish them in the Newsletter.

Eligibility for SAM employees (from Lynn Hughitt's 7/20 letter) - Those who were active employees as of Dec. 31, 2005 with at least 4 years of continuous service with United at that time.

Eligibility for IAM employees (from the IAM's Weekly Review e-mail of 7/29) - Those members who have retired since May 1, 2003 or become qualified to retire - reaching the early retirement age of 55 - by the end of the current Agreement, Dec. 31, 2009.

#### FROM THE EXECUTIVE VICE PRESIDENT

This is my first time at Bat for a column in the Newsletter. The topic for today will be Zonal Employee Discount (ZED) fares. Before I get into the details of ZED I would like to take a moment to thank the members who voted for me in the last election. But more important, I would like a special THANK YOU to those members who took the time to vote. Let's plan on a bigger voter turnout next year.

ZONAL EMPLOYEE DISCOUNT (ZED) FARES: Is an interline fare program used by many carriers worldwide for space available travel. The program applies when two carriers each agree to offer ZED fare to each other's employees. ZED fares replace the industry discount ID90/95 fares for interline travel on specific carriers. These fares simplify & significantly reduce pricing for non-revenue space available interline pleasure travel.

The Zed program fare does not affect the eligibility for interline travel. The program only addresses the fare paid, once the eligibility is determined. In addition, ZED tickets are purchased & refunded in exactly the same manner as interline tickets are currently handled.

#### ZED-eligible carriers:

United currently has ZED agreements with the following carriers: American, Lufthansa, Air Jamaica, Great Lakes, ATA. BMI, LOT, QATAR & Asiana. Other airlines will be added in the future.

ZED pricing is based on the mileage between a point-to-point origin & destination, rather than the percentage of the market fare. ZED fares also offer a larger discount compared to ID fares because surcharges on interline pleasure travel is eliminated, except for government-mandated fees, for example the ZED fare for New York to Buenos Aires is \$82.60 compared to ID90 of \$321.60 - that's a saving of 74%.

ZED fares in some cases could be cheaper than United pass travel service charges on some routes. Keep in mind that United employees, retirees & their eligibles also companions travel at a higher boarding priority on United flights than interline travel on other airlines.

#### FORD AIR TRANSPORT



The first CAM airmail flight in the U.S., Detroit - Cleveland Feb. 15, 1926, "Aviation" mag. March 1, 1926 - Den. Pub. Lib.

Ford Air Transport, Henry Ford's private freight line, was the first "regularly scheduled U.S. airline".

The airline began daily operations on April 13, 1925, flying between Ford Field, Dearborn, MI and Chicago. Flights were added to Buffalo on April 23, 1925 and to Cleveland in July 1925.

Ford Air Transport used Stout "Pullman" all-metal airplanes (photo). These Liberty-powered planes were designed and built by William Benton Stout of Stout Metal Airplane Company, Inc. of Dearborn. In July 1925, the Stout company became a division of Ford and the Ford Tri-motor was developed, based on the design of the Pullman.

In the first year of operation, Ford Air Transport flew over 1000 flights with a 97 percent completion record to Chicago (649 of 663 flights). Flights to Cleveland had a 99 percent completion record.

Ford received the CAM 6 & 7 contracts and flew the first U. S. CAM airmail flight on CAM 7, Detroit to Cleveland, Feb. 15, 1926 (photo).

Ford Air Transport Service's last flight was in 1932. Ford Field officially closed Oct. 21, 1947 and the (Stout Air Lines) passenger terminal at Ford Field was razed in 1961.

#### OPERATIONS CENTER IN ELK GROVE, MOVES CORPORATE HEADQUARTERS

United is moving its corporate headquarters to Chicago & creating an Operations Center at Elk Grove. Early 2007, 350 management employees will move to 77 W. Wacker in downtown Chicago; employees from other suburban facilities who support the day-to-day operations will be relocated to the Operations Center.

United expects to consolidate facilities it currently leases in Schaumburg, Chancellory Park & Bryn Mawr into the Operations Center, with employees currently in those buildings moving to the Elk Grove campus.

Corporate functions, such as legal, corporate affairs, planning & finance, are expected to move to CHI.

Under the agreement, United is receiving 5.25 million dollars in tax increment financing from the city of Chicago. United also will receive 1.35 million dollars in grants from the Illinois Dept. of Commerce & Economic Opportunity for infrastructure improvements and job training.

#### DRESS CODE DURING PLEASURE TRAVEL

Being inappropriately dressed for space-available travel can result in denied boarding for employees, retirees, travel eligibles & companions.

Employees, Retirees, their travel eligibles & companions have been turned away at the gate for being inappropriately dressed for non-revenue, space-available travel. The purpose of United's dress code -- which applies to travelers age 12 & above -- is to ensure that the appearance of NRSA's & their eligible travelers reflects favorably upon customers.

Not allowed in any class of service are flip-flops or thong sandals, shorts, T-shirts, tank tops, mini skirts, bare midriffs, workout attire or jogging suits. Jeans are prohibited for NRSA travelers listed for the first-class cabin. For full dress-code details, go to SkyNet, "Travel," and click "Employee" under "Travel Benefits Summary." Please be aware that other carriers may have even stricter dress codes for space-available travel.

Loose-fitting, knee-length Bermuda shorts are permitted in the coach cabin on flights within the United States, Canada, Mexico & Puerto Rico.

If you're still looking for recollections of World War 11 experiences, I remember a few.

I left CHI on a troop train one frigid Feb. day bound for Marine boot camp in Sunny SAN. The weather there wasn't that great but the transition from civilian to Marine made that a minor concern. We knew if we could just survive, everything from that point forward could only be better. It was & it is!

During continued training I was assigned to the classified intelligence unit of the Fifth Amphibious Corps. In the remaining months in the States our liberty time was great. We could play golf for free at a nearby course, were invited to Sun. dinners by some very nice local citizens. This was balanced out by expensive visits to Del Mar Race Track, courtesy of some very slow & patriotic horses.

We shipped out of SAN bound for HWI our first staging area for future operations. My first venture from paradise was Guam where in a swamp site my enemy was a mosquito. It gave me Dengue Fever, my only fear was that I was going to live. We did move on to a higher elevation only to catch the tail end of a typhoon. I vowed then that I would never voluntarily camp out again. Sailing back to Maui we were already planning for our next operation – some small island called Iwo Jima. The ship we were on was a Dutch East Indies vessel with tea & orange marmalade jelly, in lieu of coffee & butter. I've Managed to avoid both since then.

Some highlights between duties included a Bob Hope USO Tour, a five day pass at the Royal Hawaiian Hotel. A wartime blackout on Maui afforded us the most spectacular view of the stars & planets.

Iwo Jima was all the horrible things that have been written about it. I accompanied the Corps Artillery in & was told not to dig my foxhole too deep if I wanted to use my ear drums later. I did view the now famous raising of the flag & the landing of the first crippled B29 on its return from a bombing raid on Japan. The one souvenir I should have kept was a particular piece of shrapnel. As we were selling scrap iron to Japan before the war I still wonder if a test would have found "Made in Pittsburg" on it.

Flying back to Maui we were getting ready for the invasion of Japan itself. The dripping of the Atomic Bomb made that operation unnecessary. Although the war was soon over, we sailed from Japan to occupy the area we were going to invade. As we were stationed in Fukuoka, a city about equal distance between Hiroshima & Nagasaki, we were anxious about how we'd be received.

It couldn't have been better, I was invited into their homes, rode public transportation, shopped, all in all without incidents (unlike Iraq).

Following occupation we sailed from Japan to SAN, troop train to CHI & discharged at Great Lakes, IL. I came back an old "salt" 22 years old on a frigid Feb. day 3 years later.
