### **MORE THAN 1,000 APPLICATIONS ALREADY IN FOR NEW PILOT POSITIONS**

Just 10 days after opening the application process on July 16 for new pilots to join United, the company has received more than 1,000 applications for 100 positions.

Of these, nearly 350 applicants were referred by employees through SkyNet.

"We are impressed by the volume of applications and, more importantly, by the caliber and diversity of the candidates applying for these positions," said Captain Hank Krakowski, Vice President, Flight Operations. "Thank you" to everyone who has submitted referrals - by and large, they've been excellent."

This is the first time the company has hired new pilots since 2001. The hiring is being driven primarily by our expansion of international flying.

The online application site, <http://www.united.com/pilot>, remains open for interested candidates. Employees may still refer candidates they think would make great United pilots by logging on to SkyNet, clicking Career Gateway, clicking "Job forms you need," selecting "Pilot referral form" and completing the form in its entirety.

Note: It is critical that the e-mail address you enter for the candidate you are referring, is the same one the candidate used, when he or she applied.

Newly hired pilots will begin training at the Flight Training Center in Denver as early as October, with the first group expected to be flying by the end of the year.

### **UNITED ANNOUNCES NEW ZED AGREEMENT WITH AIR CANADA, EXPANDS OFFLINE TRAVEL PRIVILEGE PROGRAM**

Beginning July 30, United employees and retirees can take advantage of expanded interline travel privileges with Air Canada, Canada's largest domestic and international full service airline.

Air Canada is a founding member of Star Alliance and provides direct service to over 170 destinations on five continents.

"We've been working with Air Canada for some time to bring this travel privilege to United employees and retirees," said Christine Sanchez, senior specialist, International Sales. "We are pleased to announce this new agreement, which increases travel opportunities for all eligible United employees and retirees."

For more information about the new and existing fare agreements between United and other airlines, visit SkyNet at Travel, Interline Travel Privilege, Individual Carrier Agreements. Carrier eligibility requirements and restrictions are continually updated.

United is continuously working toward additional arrangements with carriers to offer employees and retirees additional interline travel privileges. Discussions with other carriers are currently underway and other announcements will be forthcoming.

Note: For all interline space-available travel, tickets should be obtained as far in advance as possible. Also, employees and their travel eligible passengers are required to follow each airline's policies regarding dress code, minimum check-in time and baggage limits.

### **EAST MEETS WEST: UNITED AIRLINES PROPOSES NEW DAILY NONSTOP AIR SERVICE TO CHINA FROM TWO MAJOR CALIFORNIA CITIES**

United announced 8/13/07 it will apply to the U.S. Department of Transportation to begin daily, nonstop service from Los Angeles and San Francisco to China. Only six new daily route opportunities will be awarded to U.S. carriers over the next couple of years, and UAL's application addresses the rapidly rising, unmet demand for service to China

from the West Coast.

- ✈ UAL's application proposes nonstop service between San Francisco and Guangzhou in 2008. San Francisco has the largest Chinese-American population of any city in the nation and the proposed route would be the first daily, nonstop U.S. carrier service between the U.S. and Guangzhou. Guangzhou is the business center of the Pearl River Delta region of China and home to a large number of U.S. and other manufacturing facilities. It is also, the third most populous city in China. The San Francisco area has more Guangzhou traffic than any other metropolitan area without nonstop service.
- ✈ United also proposes the first ever, daily nonstop service by a U.S. carrier between Los Angeles and Shanghai in 2009. The Los Angeles region has a population of more than 18 million people and is the largest metropolitan area in the U.S., without nonstop service to China by a U.S. carrier. California accounts for nearly one-third of all Shanghai traffic, far more than any other state. Shanghai is the largest city in the People's Republic of China.
- ✈ *"Our East-meets-West proposal is simple: add capacity to those urban areas with the least service and most pressing demand. Awarding frequencies to San Francisco and Los Angeles in 2008 and 2009 will serve the most customers, and provide them the greatest opportunities for nonstop service to China and beyond,"* said Michael Whitaker, Sr. VP of Alliances, International and Regulatory Affairs.
- ✈ In its application to the U.S. Department of Transportation, United also proposed new flights between Washington, D.C., and Shanghai, as an alternative to the Los Angeles-Shanghai service. The application explained that should service from Los Angeles be awarded to another airline, United's top priority is the Washington, D.C. - Shanghai service. Within the east coast, the Washington, D.C., area is the fastest growing region and is the largest area without nonstop service to Shanghai. The recent success of the Capital-to-Capital route underscores the public need for more direct flights from Washington, D.C., to China.

#### **TRAVEL DRESS CODE REMINDER, AVOID BEING TURNED AWAY AT THE GATE**

With the warm summer weather, United employees and their travel eligibles are reminded of appropriate

dress, when flying space available on United, United Express & Ted or on interline flights. There have been dress code violations which have caused customer service representatives (CSRs) at the gate to divert their attention and time away from revenue passengers. Remember, space-available travel is a privilege and dress should be in accordance with policy. The dress code also applies to NRPS company business travel.

- ✈ Most frequent violations by employees who have been turned away at the gate by CSRs or have not been seated in their preferred class include: shorts, T-shirts, tank tops, flip flops or thong sandals, workout attire, jogging suits and bare midriffs.
- ✈ Jeans are NOT allowed for NRSA travelers listed for the first-class cabin.
- ✈ If first class is desired, or if in doubt, about the appropriate type of clothing, dress more conservatively.
- ✈ For specific information on dress code for all classes of service, go to the "Travel" section of SkyNet, and click "Pleasure" under "Travel Policy (Series 10)." United's travel dress code may also be found in Apollo under HOW TO DRESS.

When traveling on a space-available basis on other carriers, remember that the carrier may have stricter dress codes that must be observed. Be sure to check the airline's regulations before traveling.

#### **TRAVEL TIPS BY BOB**

Most of us are getting familiar with SkyNet as it is the primary means we now have to list ourselves for flights and to obtain other information concerning retiree issues. In this issue of Travel Tips by Bob, I thought it would be helpful to review some of the features of "Web List", and other travel related features.

There are Five Steps to building a PNR:

1. When we go to Web List, the first thing we see is the words, "*Space Available Listing*". The first box that appears is the "*Search Flights*" box. This is where we start to build our PNR. We then select Round Trip, One Way or Multi-city and then enter the cities in the From and To boxes. Next, select the dates, times and number of days. Note: The number of days option is a neat feature. You may select from 1 to 3 days in each box and the system will display the flight schedules for the number of days you have selected. Try it and see for yourself. Then click the "*Search Flights*" icon and the flight schedule appears that represents your selections.
2. Again we see "*Space Available Listing*" but the box says "*Available Flights*". This represents

the flights available per our itinerary, date and time selection made in step #1. Select the flights you desire and then click on the “*Select Flights*” icon at the bottom of the last display.

3. Again we see “*Space Available Listing*” but the box now says “*Selected Flights*”. This box represents the flights we selected for the itinerary, date and time. It also auto lists us for “First Class” when available. From this box you can delete flights, or start over with flight selection. If you are satisfied with the flights, then the next step is to click on the “*Add Passenger Information*” icon.
4. Again we see the words “*Space Available Listing*” but the box states “*Passenger Information*”. This is the box that you use to list yourself, your spouse and other eligible dependents. It is also used to list your companions. You and your dependents’ names will be in the “*Dependent Names*” box. Just click in the small square to list. To list your companions for the first time you must enter their names in the yellow first and last name boxes. After that, the system remembers them and you just follow the instructions to list them. When you are done listing passengers, click on the “*Continue*” icon.
5. Finally, we are done. You will again see the words “*Space Available Listing*” but the box will say “*Confirmation*” with a confirmation number following. You may also search flights again, from this location. This box sums up your selections. It lists your itinerary, date, time passengers and your conformation number.

To view your completed PNR, simply click on the “*View PNR*” box which is located next to the blue “*Build PNR*” box that is located below the words “*Space Available Listing*”. This box has all the information that the box in Step #5 has, plus it has the feature that allows you to check load status. To do this simply click on the underlined words, “*Check Load Status*”. I strongly suggest you print this display and take it with you on your trip. It contains all the information you will need for your journey. Note: You can also edit your PNR by clicking on the “*Edit PNR*” icon located at the bottom of the display.

Finally, it’s 24 hours from your departure time. When you view your PNR as indicated above you will see the words, “*Employee Check-In Online*” at the top right side of the box. Click here to print your boarding pass from your computer. While the Boarding Pass page is displayed, notice that there is additional information available by clicking on the various links on the Boarding Pass page. This information includes airport amenities and etc.

**Letters for the “Letters” column:** If possible, please send your letters to us via email or send the letter typed on a white piece of paper so we can scan it into a word document. Send it, “*Attn. Letters Column*”, in the subject line. By sending the letters to us in a digital format (email) or typed, we don’t have to manually retype them. But, if you are unable to send your submission to us other than hand written, we will gladly accept it. The “Letters” section is popular as it is a means of letting our friends know what is happening with us.

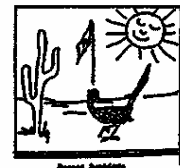

Ending with a most important note from **Bob & Jo Cuff** regarding Identity Theft ... "March 25<sup>th</sup> our income tax file was stolen by identity thieves at or in the Folsom Post Office. Shortly thereafter, we received fraudulent credit cards from eight different stores. Following is a short summary of how we fought the thieves.

1. We filed a fraud alert with all three credit agencies: Equifax, Experian, and Trans Union immediately, effective for seven years.
2. Called all eight stores, notified them that they had issued fraudulent cards and to close them immediately. We also asked that they advise us in writing that the accounts were fraudulent.
3. Fortunately for us, the cards were all financed by Citi Bank Group. We were contacted by Jeremy, who helped us immensely, by providing us with a check list to follow.
4. Immediately call the police department, report the theft and get a copy of the police report and



report number.

5. In California, you can place a security "freeze" on all three credit agencies. We don't use credit so we placed a freeze on our accounts.

General Information ... If the thieves get the following information about you ... social security number, birth date, address, drivers license number ... "you are toast" ... Remembering when battling them that they are after your money, citizenship status, drivers license, to name a few.

You need to block their access to all of these sources as soon as possible by placing new PIN, changing acct. # etc.

After four months of hard work, Jo & I, believe we've blocked almost every source. If you would like to take time at one of our meetings for a more complete discussion of this subject, please let us know."

Personally speaking, I've had some medical inconveniences lately which led my doctor to have me take a series of vaccinations which are actually **recommended for all seniors**, i.e. pneumonia, tuberculosis booster and shingles (Herpes Zoster). The following is excerpted from a paper by the Department of Health & Human Services Centers for Disease Control and Prevention, telephone 1-800-232-4636: "*Shingles is caused by the Varicella Zoster virus, the same virus that causes **chickenpox**. Only someone who has had a case of chickenpox can get shingles. **The virus stays in your body**. It can reappear many years later to cause a case of shingles and is far more common in people 50 and older than in younger people. A vaccine for shingles was licensed in 2006. It is not recommended for people with cancer.*" Continuing on, my mother had an ugly & very painful case of the shingles rash, when she came to live with us. Nothing helped. She had to wait it out, over one year. Remembering her misery, and because I had chickenpox as a child, I made the decision to have the shingles vaccination. It is called Zostavax. Now for the bad news: it costs \$170 and neither Medicare (I don't have Part D) or Blue Cross Blue Shield of Illinois offer coverage. I telephoned both. No luck. So, I just reasoned that keeping up with my body's maintenance is like taking care of my car and my house. Actually, they cost more. And that's supposed to make me feel better! Just a word to the wise, folks.

### **SHOOTING TOUCH AND GO'S**

*I remember that Sunday afternoon quite clearly.*

*Our Dad took me to watch Carl fly. I was about nine and was proud of my big brother. It took place at the small grass-covered, country airport near New Paltz, New York on Springtown Road. I remember lots of grass but can't recall cement anywhere. There were a couple of small buildings that served as the airport. We lived a few miles further down Springtown Road in a modest two-story, rented farmhouse.*

*It was in the late 1940's and Carl, barely driving age, was taking flying lessons. His instructor was Bill Cobelt. The name was popular in our house. There was a short silence, then Dad continued, "See those three getting ready to come in now? That's my son in the middle one". 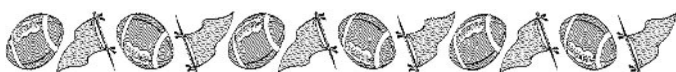

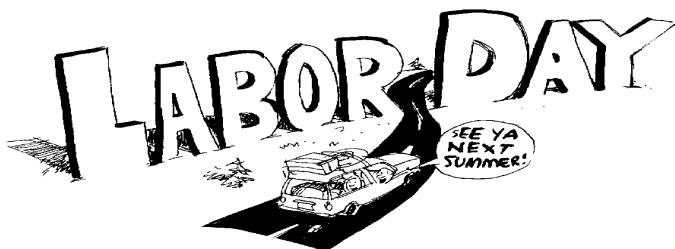

## BOEING



Boeing Model 4 "EA" 1917 - land version of "C".

After failing to interest the Navy in the "B & W" seaplane, William Boeing hired T. Wong, an airplane designer, to develop another seaplane. The result was the "all-Boeing" Model 2 "C", a twin-float seaplane. During test flights, it proved unstable and a larger rudder was installed.

Following the modification, Boeing again headed East to try to sell the new plane to the Navy. They liked it and ordered 50 "C"s to be used as trainers.

Then T. Wong resigned and Boeing once again needed airplane designers, draftsmen and engineers. He contacted the University of Washington where three recently graduated engineers were recommended. They were Philip G. Johnson, Clairmont L. Egtvedt and Roland Mayer.

Boeing hired all three at \$90 per month. Johnson was a production man and a salesman. Egtvedt was a draftsman and became a master at aircraft stress design, remaining with Boeing for 50 years.

In April 1917, the organization was renamed the "Boeing Airplane Company".

Later in 1917, the Army contracted with Boeing for two land-based

trainer versions of the "C". Boeing designated the planes as Model 4 "EA".

Boeing's "C" seaplanes used 200 hp Hall-Scott L-6 engines and had tandem seating; the Army wanted 90 hp Curtiss OX-5 engines and side-by-side seating (photo).

Boeing used a sequential numbering system for each "design change". The "B & W" was Model 1, the first "C" was Model 2, the second version of the "C" was Model 3, etc. This design-numbering method continued through 1933 and the "100" series. Thus the 1925 Boeing Model 40 was the 40<sup>th</sup> airplane design built by Boeing. (see below)
