Emerald Slickers attended United's 787 "First Look" event at Boeing's Everett WA Plant ***By David Jones (SFOFO), President, Emerald City Slickers, Seattle***



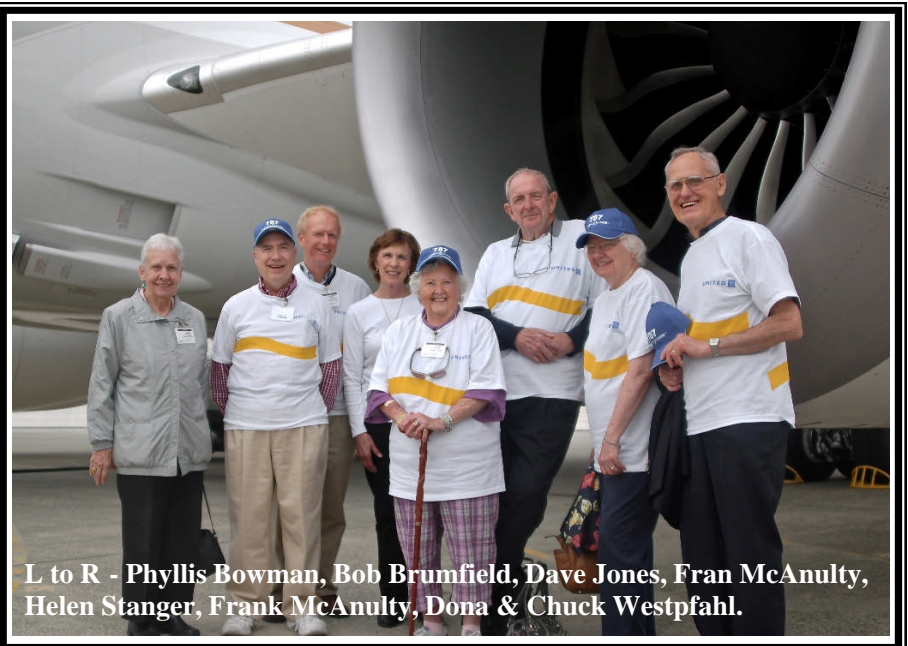
The long-delayed delivery of United's first 787 is now planned for late September and a group of Seattle area retirees from the Emerald Slickers joined United Northwest area employees on August 2nd for a preview of the first airplane at a "First Look" event at Boeing's Everett factory. United graciously invited 10 retirees to join approximately 100 employees. Our Seattle group was honored and proud to represent all RUAEA members at the first of several celebrations marking the delivery of this 21st century high-technology airplane to United. We got an up-close look at the special livery of this beautiful airplane, which features a distinctive flowing gold line that runs the full length of the fuselage, as pictured in the accompanying photo.

Emerald Slickers in attendance were: **Dave Jones**, current President, Past President **Frank McAnulty**, and wife **Frances McAnulty**, **Phyllis Bowman**, **Bob Brumfield**, **Tom Holford**, **Helen Stanger**, and **Chuck & Dona Westpfahl**. We were all smiles on this fantastic day, as evidenced in our photo.

After brief celebratory remarks by Boeing and United executives, we were treated to "walk arounds" of the airplane, a look inside at the new interior and flight deck, and a tour of the 787 production line. Boeing teamed each employee and retiree attendee with a Boeing host who served as a gracious escort through the day. We experienced this composite airplane up close, with its eye catching aerodynamic sloped nose, swooping wing tips, and sculptured engine exhaust contours that reduce noise.

Inside, we were awed by a cabin that feels even more open than our spacious 777s. It is configured with flat bed sleeper seats in First/Business, and 3'3"3" across seating in Economy Plus and Economy sections. The cabin windows are significantly larger than previous Boeing airplanes and feature unique dimmable windows that replace cabin shades. We were able to try this feature first hand.

Cabin altitude is pressurized to only 6,000 feet versus 8,000 feet of all previous airplanes, which should result in passengers and crew experiencing less fatigue after long flights. The lower altitude is possible because the 787 is constructed of a continuous composite tube rather than being built of numerous sheets of skin material that are joined together by heavier and leak-prone lap joints. We finished our tour with a look at the 787's modern flight deck. It's "glass cockpit" builds on the 777 and features five flat panel LCD screens, dual heads-up guidance, dual "electronic flight bags", and electronic virtual circuit breakers, replacing mechanical breakers.

Letter From The President



As we are about to move into autumn, many questions persist about the new pass travel policy. Last month, we provided a comprehensive review of the new policy. We qualified that review with the fact that some of the policy is still changing and that was the best information we had at the time of printing. So far, there has been only one major change reported. The item about listing for one class of service and being by-passed because that cabin is full is not correct per the Employee Travel Center. Regardless of which cabin one lists for, the boarding is strictly by Board Date (years of service). Another change is that Shares has been updated so that employees now show Years, Months and Days of Service. The retirees are still shown with only Years of Service. By the end of the year, the retirees will be shown as the employees with years, months and days of service. Actually for the time being, this slightly favors retirees as the system assumes January 1 for the retirees years.

Many retirees are traveling and their experiences are mixed. Some travel with no problems and others with nightmares. Although we do not agree with some parts of the new program, it is what we have and remember the employees are also learning and having to cope with the new system. One more point of interest is Emergency Travel. Under the new policy, emergency travel is only for retirees and their spouse or domestic partner.

Retiree Emergency Travel: *Retirees, their spouse or domestic partner are eligible for fee-waived positive space emergency travel when the retiree, spouse or domestic partner becomes ill while traveling. In the event of the death of the retiree while traveling, the surviving spouse or domestic partner will be provided fee-waived positive-space emergency travel to accompany the retiree's human remains. For details, see the Retiree Pass Travel Program in the Travel section on Flying Together.*

→ *Retiree's dependents are not eligible for emergency travel.*

→ *Surviving spouse or domestic partner and their dependents are not eligible for emergency travel.*

On the positive side, we approached the company to see if retirees could be involved in the delivery ceremony for the new Boeing 787. If possible, we wanted to have some retirees from the Seattle Chapter attend that ceremony. We got approval for ten members of the Seattle Chapter to attend the delivery ceremony. Chapter President **Dave Jones** coordinated as to who the lucky ten members would be. As it turned out, we got a bonus and our ten members were invited to the "First Look" on August 2nd. See Dave's in depth report of what sounds like a great day at the Boeing facility.

More good news is that there is interest in a new chapter in California. There will be a gathering in the Fairfield/Vacaville/Suisun area on September 20th at Denny's in Vacaville. Writers' Column - Honor Flight of Northern Colorado, by Ed Eson and Gil Rohde



I cannot tell you how honored I felt to be a member on this Flight on Sunday the Sixth & Seventh of May 2012. My friend Gill Rohde and I, Ed Eson were selected to go on this, the Eighth Flight, for Veterans of WWII, Korea and Purple Heart Vietnam Veterans. Ed Eson is a Navy Korean Vet and Gill Rohde is a WWII Air Force vet. The start of our trip to Washington DC War Memorials started at the Embassy Hotel in Loveland, CO. To start with, there was a send off

continental breakfast for every one there (approximately 400 relatives and friends) to celebrate our departure to DC.

When we left the hotel, headed for Denver International Airport there were Firefighters, Policemen, a Sheriffs posse, and an awesome motor cycle club escorting our four busses full of Veterans. The response of every one along the route to the airport was great! The 100 or so motor cycle escorts and others stretched about one mile long. The firefighters near Firestone, CO came with the “mile of flags” and people on the overpasses waved flags and there were two escort helicopters that led the way. The journey to the airport was very impressive. The tour arrived at the US Airways Hangar at the airport where the plane was ready to go. After a brief check by the TSA, every one was boarded including 20-30 guardians on the rolling steps with help from military members.

On board were flight attendants who were volunteers just for this flight. This was a trip on a plane that will never happen on a commercial flight. Camaraderie was out of this world, red, white and blue ribbons, balloons and American Flags decorated the plane and many cameras recorded the event. The US Airways specially selected Flight Attendants, were friendly and out going. They kept everyone on their toes with friendly attitudes just for the Veterans on their plane.

It was a very emotional trip especially on arrival at Baltimore. During our taxi to the gate, two airport fire trucks sprayed water over our plane in a salute to all of the Veterans. And to our surprise, during deplaning at the gate, there was a huge reception of Baltimore officials and soldiers. As the 122 Veterans and the many guardians proceeded through the airport, hundreds of people applauded continuously as the Veterans walked down the concourse or were pushed in wheel chairs by our guardians. The people kept saying “thanks for your services”. We felt, with great emotion, very honored. We then arrived at the Baltimore Hilton for a great dinner, flag ceremony and speeches.

The main event on Monday, after a good breakfast, was an all day visit to the WW II, Korean, Air Force and Lincoln Memorials and finally the Vietnam Wall. A well planned box lunch was presented at the Air Force Memorial near the Pentagon before we went to the Marine Corps War Memorial with the flag on Mount Suribachi of Iwo Jima. We visited Arlington Cemetery before we returned to the airport.

On the return flight, it was even more like a group of close friends that were really having fun, talking and taking pictures. Even the flight attendants wanted a picture of every one on board and wanted us to sign their own pendent flag.

The going home music played on board, was songs from the fifties and sixties that fit into the mood during of our flight home. The final song “*We’ll be seeing you*” was a great ending to a memorable few days.

Update on Travel Pass Overview

Kirk Moore, RAFA and RUAEA, has written an excellent Rumor/Answers document which follows. Kirk has verified with ETC that the policy as written, should be adhered to.

However, we have heard from some members that issues Connie wrote about, for example, being put last on the list for economy when first came up filled, did happen to them. One member who called suggests that, if you have problems, that you document them, where, date, time, names, situation and send the information to ETC.

SHARES: Rumors, answers July 27, 2012

SHARES is the passenger operating system that was selected by United Airlines effective March 2012. It houses all revenue passenger and pass rider reservations records for boarding purposes.

Before March 2012, sCO used SHARES and sUA used Apollo/Fastair. employeeRES is the software that allows United employees and retirees to book pass travel.

Rumor: SHARES is boarding some pass riders out of seniority order. It bypasses standby passengers who listed in a cabin that has filled up.

Answer: The following information is verbatim from the Employee Travel Center:

“The system does NOT bypass any standby passengers (revenue or pass riders) based on desired cabin and aircraft availability.

The listing-to-boarding process is as follows;

- ➔ *Booking/listing in employeeRES in the cabin desired for seating*
- ➔ *The employeeRES record is automatically transferred to SHARES*
- ➔ *Pass Riders check in*
- ➔ *The check-in status is automatically and immediately transferred to SHARES*
- ➔ *Checked in pass riders are automatically placed on a list in SHARES in boarding priority order, regardless of cabin booked/listed*
- ➔ *The agent clears pass riders in boarding priority order, regardless of cabin booked/listed*
- ➔ *If the next pass rider to be cleared is listed in first & first class is full but economy is available, that pass rider will be cleared and given an economy seat*
- ➔ *If a pass rider is listed for economy & economy is full but business/first is available, the agent will advise the pass rider accordingly and ask if they want the business/first seat as there may be a service charge involved. If the pass rider says no, the agent moves to the next pass rider on the list. If that pass rider is booked/listed for economy, they will do the same as with the previous pass rider. If that pass rider is booked/listed in business/first, the agent will clear them.*
- ➔ *Agents cannot manipulate the clearance order of standby customers, revenue or pass riders*
- ➔ *The SHARES system does not allow reordering of the standby list*
- ➔ *The only thing available to an agent is the “SKIP” entry, which is needed. If, for example, the last names on the clearance list are a party of two and only one seat remains. If the two pass riders choose to take a later flight so that they can remain together, the agent can “SKIP” the name items of the two pass riders and clear the next single pass rider into the sole remaining seat.*

This system and process has been in place for many years and continues to work with precise accuracy today. I ask that you please reassure retirees of these facts.”

Rumor: Some gate agents are not rolling pass riders to the next flight.

Answer: *“Currently in SHARES, once a flight has been closed the gate agent cannot alter the placement of passengers unless they contact the HP Service Center to re-open the flight. In APOLLO, the flight close out process was different. As airport agents become more and more familiar with SHARES, this will improve. There is a Technology Work Request submitted to correct this situation by making the ability to re-open a flight segment available to UA agents through a controlled entry available to the ATO help desk. This will help in those situations when the agent forgets to roll the pass rider list over to the next flight.*

If you are not cleared for the flight, politely ask the gate agent if they have rolled the standby list to the next flight. Also note: The standby list cannot be rolled to the next day. Pass riders who are not accommodated on the last flight of the day must cancel their reservation and make a new booking/listing for the following day.”

Rumor: Pass riders at the top of the standby list get seats in economy while those farther down on the list are getting Economy Plus.

Answer: *“Because Economy Plus is new to SHARES, currently, SHARES clears pass riders from behind the Economy Plus section to the back of the aircraft and then moves to any available Economy Plus seats when seats from the middle to the back have been exhausted.*

We agree that this is an issue and the Airport Operations IT team has advised us that there is a SWAT team assigned to deal with all seat related issues and this one is on the list. As gate agents become more familiar with SHARES, they are doing what they can when time permits.”

Rumor: Some people are manipulating the system

Answer: *People are not manipulating the system: Example: Some pass riders can have two bookings/listings on the same flight. Qualified employees are permitted to book/list with a jump seat boarding priority (SJ2U) **and** a personal boarding priority (SAIP) **or** a vacation boarding priority (SA0V) on the same flight.*

*However, it's **not** OK to list with a personal pass **and** a vacation pass on the same flight. It's also **not** OK to list in FC **and** Y on the same flight. If you see that happening, document and report it to etc@united.com.*

Unusual boarding priority codes (for example: PS0U, PS5B) are for deadheading crew or employees on business. Common codes are listed on pages 3 and 4 in the pdf here:

FlyingTogether>Travel>BoardingPriorities (under Travel Policies). If you see a code on the pass rider list you don't know, write to the ETC for an explanation.

Rumor: What happened with the retiree who couldn't change from Y to FC at the gate and missed the flight? She had listed in Y, but the Y cabin had filled up. The agent said he couldn't move the retiree to FC. Does SHARES allow an agent to move a retiree up to FC?

Answer: YES! Retirees can be upgraded and then sent an invoice, if there's an applicable service charge for that flight. This time the gate agent was incorrect. Next time, politely ask the agent "Is there another agent or a supervisor that could help? I would really like to sit in First class and make the flight!"

"SHARES is programmed with the pass travel business rules as outlined in the policy and program documents and the booking/listing and clearing process is operating in sync with these rules. Ask retirees to be patient with agents who are still learning SHARES and to trust that the process is sound and the agents will eventually become more comfortable with the system and the process."

SHARES is a completely different language than Apollo/Fastair; it's all different keystrokes. Imagine speaking fluent English and suddenly having to switch to Latin. It's very frustrating for agents who want to help pass riders, but are unable to do so.

The Bottom Line: The issues discussed are being addressed by the ETC and the IT department and as agents become more familiar with SHARES, the process of clearing pass riders will be much smoother. We must have patience and understanding, keep notes for possible refunds, and have a back-up plan for pass travels.

United and ALPA reach agreement in principle for JCBA



United announced August 3rd, an agreement in principle was reached on a joint collective bargaining agreement with the Air Line Pilots Association (ALPA) representing pilots at both subsidiaries. The agreement is subject to definitive documentation, approvals by the ALPA master executive councils of each subsidiary and ratification by pilots.

"This agreement follows intense negotiations with our pilot group and is an important step forward for our company," said Flight Operations SVP Fred Abbott. "I want to thank both negotiating teams for their efforts in reaching this agreement."

"The National Mediation Board played a crucial role in our negotiations," said Human Resources and Labor Relations EVP Mike Bonds, "and I want to recognize NMB member Linda Puchala for her personal involvement and thank Senior Mediator Patricia Sims for her professional and effective mediation support."

CO flight attendants ratify agreement

Flight attendants from the CO subsidiary, represented by the Association of Flight Attendants (AFA), ratified a new labor agreement.

The new agreement covers approximately 9,000 CO subsidiary flight attendants. United and the AFA will soon commence negotiations for a joint collective bargaining agreement for flight attendants at UA, CO and Continental Micronesia. Flight attendants from our UA subsidiary ratified a new four-year contract in

United is ordering new planes!



United announced that it has ordered 150 new Boeing aircraft — 100 Boeing 737 MAX 9 aircraft and 50 additional Boeing 737-900ER aircraft — for delivery between 2013 and 2022.

The 50 additional 737-900ER aircraft will allow United to replace many of its UA subsidiary's 757-200s, which the company flies domestically and which are much less fuel efficient and less operationally reliable than the new aircraft replacing them. The new planes will also enhance United's customers' experience and maximize network opportunities.

“I think the 737 MAX 9 is going to be a great airplane. It’s a huge technological advance,” said First Officer Nancy Barteczko.

EWR Flight Attendant Angelique Reddick said, *“These planes are what I call ‘people-friendly.’ They’re the planes you want to fly on. They’re brighter, more comfortable and prettier, too! I know I prefer working on these aircraft; the panels are easier to use and everything is streamlined.”*

“This order got me excited for our customers,” said ORD Customer Service Representative Warren S. Moore. *“Investing in our fleet means we’re going to have a more reliable product and fewer mechanical issues and can better perform as an airline. It’s a big win for United and our customers.”*

United committed resources to support ops



Weather wreaked havoc with United’s operations this summer. Thunderstorms through the Midwest and East Coast resulted in numerous diversions, cancels and delays throughout the system, including international flights.

Beyond the weather, it’s been a challenging summer for reliability. There are a lot of changes as co-workers in virtually every area of operations are learning new processes and using new tools. Along with summer flight volumes and load factors, this has affected United’s performance. As mentioned in an [employee bulletin](#) from Chief Operations Officer and EVP Pete McDonald on July 6, United is taking several steps to improve reliability to

support co-workers.

United is restoring its spare aircraft – including two Boeing 757s and one Boeing 747 this month and additional Airbus A320s and a Boeing 767 in coming weeks. In addition, the company will continue to invest time in the schedule for maintenance access to the fleet. United has added resources in Tech Ops and Airport Ops as well as block and ground time to give its front-line co-workers more time to get the departures out. These measures will help United with reliability as it continues to put the right aircraft in the right market.

“Our goal is to get back to the level of performance our customers and co-workers expect, and these actions are significant steps in the right direction,” said EVP and Chief Operations Officer Pete McDonald. *“More than anything, I want to thank you for your hard work and all you are doing to take care of our customers.”*

ps® Fleet renovation to begin this fall



United will install flat-bed BusinessFirst seating and make numerous other cabin upgrades on its p.s.® (premium service) Boeing 757-200 fleet starting this November. When the project is complete next summer, United’s cabins between JFK (New York-Kennedy) and LAX and SFO will be comparable to those in its trans-Atlantic narrowbodies, except that each p.s. aircraft will boast 75 percent more flat-bed seats, 28 compared to 16.

“The p.s. markets are very important,” said Marketing SVP Mark Bergsrud. “Many of our most valuable customers heavily use these routes, and they demand the level of service and product we proudly provide with p.s.”

The new p.s. planes will each have 28 flat-bed BusinessFirst seats, 48 in Economy Plus and 66 Economy seats for a total of 142 seats. Each seat will have personal on-demand entertainment, and United will continue to offer in-flight Gogo wireless service and power ports in every row.

Since United launched p.s. in 2004, its p.s. planes have had 12 angled lie-flat United First seats, 26 recliner United Business seats and 72 Economy Plus seats for a total of 110 seats. The updated configuration provides United with 32 additional seats.

American Airlines (AA) recently announced it will offer three-class transcontinental service on Airbus A321s with a total of 30 flat-bed seats in the premium cabins. AA does not expect the first of those aircraft to enter service until November 2013.

Neckwear swap helps tie us together

Easy Does It - “Early Holiday Chicken For Two”



This is soooo easy ... you’ll love it for a quick end-of-summer dinner. This is enough for two hearty eaters. It’s tender yet slightly crunchy!

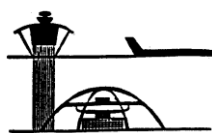

Most of us are old enough to remember WWII. Our chapter now treasures a photo and newspaper article from that era where women stepped in to help out in factories etc. as our servicemen were deployed and fighting in foreign lands. This newspaper article shows that in just one day, 29 civilian Pennsylvania-Central employees in Washington DC donated their life's blood to save lives overseas. With 300 PCA'ers in the Armed Forces, civilian PCA employees regularly gave blood to the mobile Red Cross Blood Donor Unit set up at the National Airport. 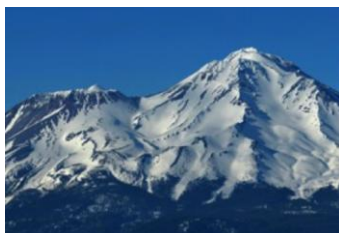

I keep looking for someone that I remember, maybe while I was sleeping on a desk during DC-3 Cargo operations during the early 1940's. They always left the cargo operations when a passenger flight came in. So I and my co-pilot would take a nap. We would leave eg, at 8 o'clock in the evening, land at South Bend, Toledo, Cleveland, Akron, Youngstown, Allentown, Philadelphia, LaGuardia, by 0900 in the am; it was a long night. But we were young and flying, and couldn't ask for more.

In the June issue of the 2012 Newsletter, they mention the arrival of the Mainliner 230. So, as Paul Harvey would say; *"This is the rest of the story"*. During the Pacific Operations, we transitioned in the C-54 in September 1943, and were dual qualified in the Consolidated C-87 (B24 converted to cargo) and the C-54. Captain George Douglas was the transition instructor and for this story, I was his co-pilot. If you remember Edward R. Murrow, news anchor, who typically was shown with his legs crossed and a cigarette in his hand. George Douglas was his equal. He was demonstrating the capability of the DC4, to cross over a range station located adjacent to the airport, and to be able to descend in such a manner to a VFR condition immediately after crossing the station, and then be able to land on the runway. In this instance, George was sitting in the left seat, with his legs crossed, holding a cigarette in his hand, Circa E. R. Murrow, when the end of the runway at SFO Runway 10, disappeared from view over the nose of the aircraft. George put his cigarette down, (there were ashtrays interesting enough). He said, *"Cliff, gear down, full flaps, airspeed 85 MPH"* and he pointed the nose directly towards the end of the runway. The descent turned out to be interesting. I was just a little apprehensive, (I had never done this type of maneuver myself before) but, with a little bit of power to make the round out, we touched down just past the numbers on the runway. It was most impressive. With the transitioning pilots taking note, that the C54 had marvelous slow speed characteristics.

So, for the 33 years that I flew as Captain on the DC3-4-6-7-8, the B720-747, I used that technique whenever it was necessary to descend for that type of landing approach. After I retired from UAL, I flew for an air ambulance company Mercy Flights in Medford, Oregon for 17 years, and then they found out that I was 77 years old, too old they said. So I activated my Instructor's Certificate, and have been instructing ever since. Still using George's technique, instead of slipping the aircraft, it is much safer, especially for a low experienced pilot.

My dear wife Phyllis is busy knitting. She has 25 body forms with beautiful sweaters displayed in her home boutique.

I have 3 brand new students, and when I see the grin on their faces, from ear to ear as they are progressing to learn to fly, it is well worth all the effort. Happy Landings for now.

Rest In Peace, United Airlines ~ It is now several months since the new Continental Airlines came into existence on PSS Day, March 3, 2012. Even though United Airlines purchased Continental Airlines (remember?), United Airlines is no more.

With each passing day, it becomes more and more apparent that the United Airlines we and all of our revenue passengers knew before has ceased to exist like Pam Am, Eastern, TWA, Northwest and others before her.

You don't think so? Have you been to an airport recently, watched a United airplane pass by or tried to use any of the new Continental Airlines policies or systems that have replaced United's? Continental executives are running the airline, major computer systems are Continental's, websites are Continental's with the United name slapped on them but the Continental business mindset prevails.

CSR's with whom I have spoken have said that **old, cryptic** APOLLO, before FASTAIR and FASTRES were implemented, was more user-friendly than Continental's PSS system. Items that have circulated since PSS Day (newspaper articles, TV reports, and various letters) indicate that revenue passengers, even the high-end, premium, frequent flyer revenue passengers, are getting fed up with how the new Continental is treating them.

Remembering that United purchased Continental, I make the following observations, both large and small, from my experiences so far:

- 1) Airport Environment
 - -Eliminate the 6 letter name and is there anything in the signage or the environment that reminds you of United or does it scream Continental at you? Me too!
 - -Premium customers no longer walk on a United red carpet. Now it is a Continental blue.
 - -There are no more Red Carpet Clubs.
- 2) Aircraft
 - -Same as the airport. Eliminate the 6 letter name and is there anything in the livery that reminds you of United or does it also scream Continental at you? Me too!
 - -Open up a Hemispheres magazine to the airport diagrams. Which hub airports are prominently displayed first? ORD, DEN, IAD, SFO? No, it's IAH and EWR.
- 3) Pass Travel
 - -We are all aware and becoming more aware of how poorly retired United personnel are now treated.

Why was United's fair, easy-to-understand, promised policy trashed for Continental's convoluted, multi-level, multi-type policy?

Why all the "CYA" disclaimer statements on the new Continental's travel policies that never existed on United's policies?

For those of us who are still working in another career, with our downgraded pass travel privileges and lost years of seniority, the days of being reasonably certain that we can travel to visit children and grandchildren over a weekend are pretty much a thing of the past.

Procedures for assigning seats to NRSA travelers appear to be different. So far, my wife and I have been on 4 domestic flights through 4 domestic airports (ORD, CLE, ATL, GSO). At each of these airports, the names of NRSA travelers were never called over the PA system. The gate agents at these airports simply said in a normal

voice that standby passengers should come to the podium. If we had not been sitting near the podium, we would not have heard the agent. If the agent had a boarding card with our name on it, we got on. If not, that was how we found out that we were not going to get on the flight. It felt like being a part of a “cattle call”.

Calling 800-UAL-LIST worked very well for checking flights and listing yourself and your family for flights. Have you ever tried to use 866-FLY-EPASS? I have tried 6 or 8 times so far and have yet to successfully get listed for any flights. Each time, I have been told that I will be transferred to an agent. I was connected to an agent only once and that was after being on “hold” for 30 minutes and she was not able to help me. The other times, I gave up after 15-20 minutes being on “hold”. Also, there is no information available for United Express flights like there was at 800-UAL-LIST.

Do you think that you will receive answers from ETC@united.com to questions that you may have about pass travel? Think again. So far submitting questions is pretty much a waste of time. It takes weeks or months to receive a response, not necessarily an answer. Questions that I submitted in early March were not responded to until early June after I re-submitted them for a 2nd time. The response did not completely answer several questions and at least 1 was not answered at all.

As more of us share our experiences and the information that we acquire about the new Continental and how it operates, it becomes more and more apparent that the United that we knew has faded into history.

When you have a chance, raise a glass to toast the memory of the airline that each of us, in own way, helped to build, improve and maintain.

Also, say a prayer that W. A. Patterson is resting peacefully and not rolling over in his grave because of the passing of his airline.

In 1948, the DC-6 "300 on Wheels" (below) was updated from the DC-4 "230" mobile training unit of the previous year. The "230" training unit had toured the United system and provided over 6,500 hours of training to United Maintenance personnel.



4,500 pounds of mockups and other training aids were transported in this Fruehauf-built 28-foot "moving van". Four roll-around units contained working mockups of nine "Mainliner 300" Operating Systems. One unit dealt with Heating & Ventilation systems, a second with the two Automatic Pilot systems (both the "230"

and "300" for comparison). A third unit dealt with Fuel Quantity, Cowl Flap & Oil Cooler Door mechanisms and the Takeoff Warning system. The fourth unit dealt with Cabin Pressurization, Airfoil Anti-Icing and Generator Control systems.

The Mobile Unit also included large Charts, a Blackboard and cut-away Models of various plane parts.

In 1945, United installed Sperry Electronic Automatic Pilots in the "230" (DC-4) planes replacing Hydraulic Automatic Pilots used in the past.

When combined with Automatic Landing Controls, landings were possible under substantially lower weather minimums, increasing schedule reliability and safety.

"Entering this new era of air transportation and automatic flight, does not mean we are going to dispense with human pilots", said "Pat" Patterson.
