- ❖ Super Shuttle provides ground transportation from the airport to the hotel at a discount price. To obtain the discount you must book online on Flying Together. Go to travel and scroll down to discounts. There is a code you need to use to access the discount.
- ❖ Wheelchairs and motorized scooters are available for rental by calling Ashley MED at (619) 297-1983. The shower at the hotel is in the tub and there are no hand grips or rails. At home, I use a suction hand grip for the tub. It attaches easily to any surface and is light weight for travel. They can be purchased at Lowes, Home Depot or Amazon for about \$20.00. They are easy to carry, safety items.
- ❖ The Town & Country is a large venue. If you feel you need assistance to your room, ask for a Golf Cart at check in.
- ❖ If you have not yet registered, you can get the form in the June issue or online. We don't want you to miss out.
- ❖ All convention activities are casual attire. There are three pools at the hotel that you might want to enjoy. The Banquet on Saturday night has a Polynesian theme, but Island attire is at your discretion.
- ❖ There will be no Convention article in October as we will all be on site at the Town & Country.

United “carry on” educating customers about “Over, Under, Checked”

More than half a million customers received United’s latest email aimed at educating them on United’s “Over, Under, Checked” carry-on policy.



In addition to reinforcing the policy, United reinforces in the email that customers can “help everyone experience a more comfortable flight by bringing bags that are cabin-ready.”

Cabin-ready bags refers to both size and quantity limitations in our carry-on policy. Addressing where and how to stow bags once on board the aircraft ensures adequate bin space, smoother boarding and a more flyer-friendly travel experience for everyone.

The outreach accompanied an update to the united.com/carry-on page explaining what it means to be cabin-ready. These measures extend United’s campaign to educate customers, which began in March and includes check-in screens, GID screens, airport signage and pre-travel emails.

The carry-on policy also applies to employees traveling for business or leisure. Excluding working crew exemptions, employees are required to follow the cabin-ready guidelines below:

- ✓ One personal item that fits under the seat, such as a laptop case or other small item (no larger than 9” x 10” x 17”).
- ✓ One carry-on bag that fits in the overhead bin (no larger than 9” x 14” x 22” including handles and wheels).

All Airbus planes now have expanded bin capacity, Wi-Fi



United has completed modifications to increase the overhead bin capacity on all 152 of its Airbus planes, offering customers more useable space to speed boarding and reduce the number of gate-checked bags. United completed the work on the last aircraft last month.

Tech Ops employees in DEN and SFO performed 89 of the modifications, and United’s maintenance business partners completed the remaining 63. In all cases, the existing bins on the A319s and A320s got new latches, hinges and doors, nearly doubling each plane’s carry-on capacity.

United also has installed Wi-Fi in all the Airbus planes and completed two-thirds of the Airbus economy class seating renovations, with 104 aircraft back in service as of July 10. The company expects to complete the remainder this year. Installing the lighter, slimmer seats saves fuel and increases capacity by 6-12 seats per aircraft without compromising legroom.

TSA increases Aviation Security Fee

The TSA Aviation Security Fee, also known as the September 11 security fee, has increased from \$2.50 per enplanement to a flat \$5.60 each way for all travel originating at an airport in the United States. Stopovers of more than four hours on domestic connections or more than 12 hours on international connections will result in additional fee charges.

United, along with Airlines for America and other industry stakeholders, opposed the increase and have opposed certain aspects of this new security fee, such as TSA's plan to remove the existing fee caps for round-trip travel and to apply the fee to the domestic portion of travel that originates outside the United States.

The fee applies to all revenue and certain non-revenue travel and is collected in the price of the ticket. Information regarding the fee on non-revenue tickets can be found on the employeeRES login page and in the employeeRES pass tax calculator, where it is designated as the "AY" fee.

Reminder - Retiree Badge Available



As mentioned in a previous newsletter, a new United retiree badge is available via electronic/online ordering to any former co-worker on "retired" status. The badge was intended to provide retirees with a tangible link to their former employer and supplement the Verification of Eligibility Letter when attempting to apply for any applicable discounts offered to United retirees. This badge is in no way mandatory nor is it required for pass travel.

There is a \$35 fee for the initial badge.

Torgy's Travel Tips

With summer travel not quite behind us yet, load factors are still high across much of the system. With that in mind, many of us who must or wish to travel during this busy time elect to purchase confirmed space tickets. This article will assist you with some tips on buying tickets.

When flying on **United** you and your eligibles qualify for a 20% discount off any fare offered to the general public. Along with the discount come 2 free checked bags - an additional savings of at least \$50 (more savings if your destination is international). You accrue miles if you are a Mileage Plus member and you may select your desired seat number at the time you make your reservation. If your flight is delayed or canceled, you receive the same compensation as all other revenue passengers. You can even volunteer for denied boarding compensation if you choose to, which gives you travel credits towards purchasing a new ticket in the future and guarantees you a confirmed seat on a later flight. A word of caution, however: you must adhere to the rules of the fare you purchase. If you buy a non-refundable ticket, it means just that - non-refundable. Most every fare except full fare comes with change fees, usually in the neighborhood of \$200, which may be more than the price you paid for the ticket itself. There is no mercy given to employees or retirees who attempt to plead their case. It's "fly it or flush it".

This discount program is called: My UA Discount and can ONLY be accessed on the employee website: Flyingtogether.ual.com >Travel >MyUADiscount >BookFlights.

If you choose to fly on an airline other than United, shop around for the best fares. Travel websites such as

Cheepoair, Expedia, Hotwire, Orbitz and Travelocity can point you in the right direction for choosing an airline and Kavak.com will compare some of these same websites on one screen for you. But frequently, accessing the airline's own website will reveal fares that are better than those offered through the 3rd party websites. In addition, if you book directly through a carrier's website at least 7 days in advance for flights within the US, you are entitled to "hold your reservation and the fare and change or cancel within 24 hours of the booking, without paying a change or cancel fee", according to the US Department of Transportation. With the exception of **American Airlines**, you pay for your ticket at the time of booking and then receive a refund if you cancel within 24 hours. On American, you are given an option at the time of booking to "hold" or "purchase". If you think you might change your mind, choose "hold". The booking will expire after 24 hours.

Southwest Airlines goes one better by not only offering the 24 hour rule, but allowing you to change or cancel a reservation up to 10 minutes before flight time and receive full credit for your fare to be used on future travel on Southwest within one year of the original reservation. And Southwest gives you 2 free checked bags (even golf clubs and skis). For international travel, consider some of the lesser known carriers that are now flying into the US. **Turkish Airlines** uses their hub city of Istanbul as a connection to almost all of the major European capitals. Now it may sound convoluted to fly from say Houston to Budapest via Istanbul, but believe me they offer great airfares, free stopovers in Istanbul (some even include free sightseeing) and onboard service like we used to get in "the old good old days" of flying. **Icelandair** is another wonderful example. Free stopovers in Reykjavik, Iceland are included on all of their flights into/out of the US.

A couple of more items you should be aware of concern carry-on bag sizes and higher ticket tax fees. The TSA's September 11th security fee has risen from \$2.50 per segment to \$5.60 per segment. If you use a vacation pass you do not pay this fee. But if you have less than 25 years seniority and choose to use a personal pass in First or Business, you will be assessed the fee. Also, if you purchase a positive space ticket using the "My UA Discount", you must pay these fees.

Carry-on bag sizes are apparently undergoing some "tweaking" by many airlines. UA states a 9 × 14 × 22 inch rule. Some carriers use 10 × 14 × 21 and still others allow 9 × 15 × 21. This has traditionally not been a major issue but customer service agents have been enforcing the limits lately, charging customers a checked bag fee if their bag does not fit in the portable "sizers" on display at the counter and gates. Be sure to read the baggage information on the website of the airline you choose in order to avoid a sudden surprise at the airport.

When traveling on UA using a pass or the MyUADiscount, you are allowed 2 free checked bags.

So wherever your travels take you, have fun!

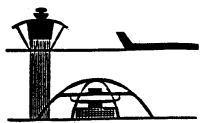

There was a discussion on the recent United incident of an airplane that diverted into Midway Island from HNL to GUM. The B777 had smoke in the cabin and flight deck.


Vincent Neidlinger spoke about the Redding Air Show September 27th and 28th and invited all to attend.

The CAUSE Foundation which is an acronym for Concerned Attendants for a United Support Effort is celebrating 20 years of helping United flight attendants and their families who are in financial distress due to illness, injury, disability or death.

In the 20 years CAUSE has granted financial aid totaling over \$5,000,000. They have granted over \$45,000 in scholarships to children of deceased flight attendants.

More than \$40,000 has been donated to other 501 (c)(3)s as Research Grants to such organizations as ALS, Friedrichs Ataxia, Breast Cancer Research and several more. A Founders Grant given yearly has been awarded to organizations such as the Alzheimer Association, the Multiple Sclerosis Society, and has also contributed to organizations that would directly impact flight attendants in need due to a natural disaster.

This organization is global and with its army of volunteers operates with an amazingly low 7% administration cost!

The CAUSE Foundation is primarily funded through voluntary payroll deductions. Since the payroll systems for the United and the Continental flight attendants have not as yet been totally integrated, a Fund has been established to begin helping flight attendants from the Continental group. This Fund has already been seeded with \$5,000.00 and needs matching donations to make this effort feasible until the payroll systems are merged.

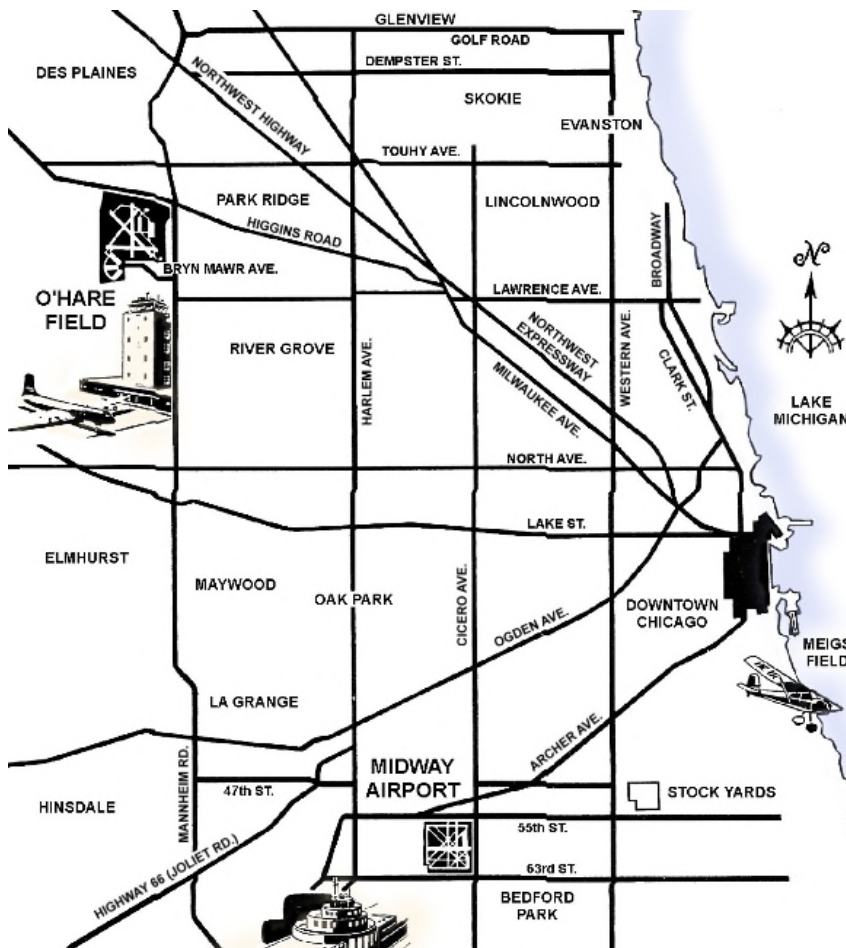

United Airlines Historical Foundation



"Preserving the Past, Inspiring the Future"



This 1955 map of the Chicago area showing the location of the two airports - Midway Airport (lower center.) and O'Hare Field (upper left) were used by United and other scheduled airlines.

Beginning on October 30, 1955, United shifted 10 incoming & 10 departing flights from Midway Airport to O'Hare. At the time this was the largest number of flights operated by any airline at O'Hare. United offered non-stop service to New York, Washington DC, Detroit, Denver, Des Moines, Cleveland & Toledo and through-service to other major cities. O'Hare covered

6,400 acres (10 times the size of Midway) with the Terminal area covering a square mile. In November 1955, the four runways in operation ranged in length from 5,500 to 7,350 feet. The master plan included six 8,100 ft. runways. In 1955, four Ramp Positions were assigned to United.

Approximately 70 United Employees were assigned to O'Hare including: R.D. Hoen, Station Ground Services Manager and John Kersey, Passenger Services Manager. United leased Ticket Counter & Office space on the second floor of the Terminal building. United's ground-level northwing space included Crew Quarters, Communications, Cargo, Load Planning and Dispatch offices.
