Writers' Column ~ Flying Tiger Heritage Park by Larry Jobe

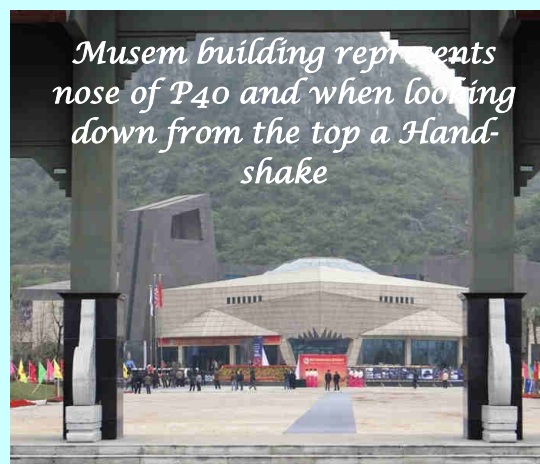
Retired United pilot Larry Jobe along with retired Brigadier General James T. Whitehead Jr. just participated in the opening of the Flying Tiger museum located at Flying Tiger Heritage Park in Guilin, China.

This project was begun in 2006 by General Whitehead and Captain Jobe as a joint effort by the Americans and Chinese to honor and remember the brave men who sacrificed to preserve the freedoms we enjoy today. They formed the Flying Tiger Historical Organization a 501 (c) 3 corporation. Located on a 23 acre site where General Claire Chennault's command and operation cave is located, the park will eventually see the cave restored to its WWII livery along with replica buildings, memorial walls and statues honoring all who fought.

The museum dedication ceremonies were attended by high ranking Chinese government officials including the Vice Premier Liu Yandong.

The United Pass Line

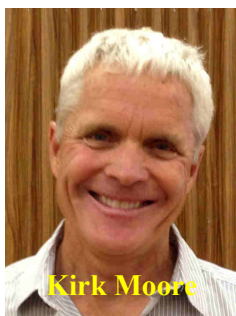

The United Pass Line (UPL) allows employees and retirees to create bookings, check Passenger Boarding Totals (PBT) and check ePass balances through a voice response phone system. When an employee or retiree calls the UPL they will now be asked for their six-digit uID number and password of the last four-digits of their social security number, which has changed from a five-digit subsidiary Continental ID number (if applicable) and the birth date as the password.

Please note: All employee applications now accept a six-digit uID number. We understand while some applications still accept a five-digit subsidiary Continental ID number, it is strongly recommended to begin using your uID. In the near future (date still to be determined) the sunset of subsidiary Continental ID numbers will occur.

"Order of Accommodation" boarding? There has been a rumor going around about a new boarding policy wherein pass riders are denied boarding because a more senior pass rider was denied boarding due to an inability to check their bag (weight/balance or cargo is full). The ETC has responded to query about the policy:

"It appears since the recent implementation of positive bag match procedures to the island-hopper markets,

the local teams received some conflicting information about the interpretation, specifically related to handling of pass rider bags on below-wing bulked-out flights. Based on this conflicting information they were temporarily not accommodating pass riders with bags or those boarding after the pass rider with the bag.

We have communicated immediate implementation of the correct bag procedures, which is to accommodate pass riders in seniority order without penalization for checked bags. Of course, this means the bags may not board that flight with the employee and be sent in a later flight. We will continue to work with our airport teams to improve the pass rider experience.”

Registering your Pass Riders ~ A list of retirees' eligible pass riders is on the [Pass Travel Summary](#) page.

Retirees and employees will now use the new “My Info” system on “Flying Together > Employee Services” to register pass riders. So many people are calling the Employee Travel Center about using the new system the ETC notified us their phone lines are jammed! So, please note:

- 1) Retirees usually do not need to register pass riders unless we get married, get new kids, get a new domestic partner, or some other life event transpires.
- 2) Retirees who have already registered their two annual Enrolled Friends should wait until the December “open enrollment period” to make changes.
- 3) Yes, we can “deactivate” our current Enrolled Friend(s) at any time, but a new Enrolled Friend will not be eligible to fly until January 1st.
- 4) If you have *never registered Enrolled Friends*, you may add one or two EFs for 2015 now, but it may take up to 72 hours before you can list them on a flight.

IF you still need to register a pass rider now, please refer to the [Q&A](#), which covers the most frequently asked questions and the [Reference Guide](#), first to see if your question is answered before calling or emailing so that our representatives can best assist everyone.

To register your pass riders go to either: Flying Together>Travel and click on the “Update pass riders and buddies” icon in the middle of the page -OR- go to Flying Together>Employee Services>My Info>Pass Riders (under the Travel subheading). You will have to sign in again (use same file number and password that you use for Flying Together)

UAL responds to reports that hackers targeted United (Posted July 29,2015)

U.S. media published reports that hackers backed by the Chinese government recently targeted United and that these individuals may have removed data from



United's systems. These reports are based on pure speculation and United can assure its customers and employees that their personal information is secure. United announced highest-ever quarterly profit



United reported second-quarter 2015 net income of \$1.3 billion, or \$3.31 per diluted share, excluding \$67 million of special items. Including special items, United reported second-quarter net income of \$1.2 billion, or \$3.14 per diluted share. These results are a record quarterly profit for the company.

Open and Fair Skies: What's at stake



Labor groups, management and economic experts spoke out against the \$42 billion in government subsidies and other benefits that Qatar Airways (QR), Etihad Airways (EY) and Emirates Airline (EK) have received in violation of Open Skies agreements.

Several unions have joined American Airlines (AA), Delta Air Lines (DL) and United Airlines in The Partnership for Open and Fair Skies and, a group of pilots, flight attendants and others recently gathered at ORD to call on the Obama Administration to level the playing field for U.S. airlines and U.S. workers.

"Chicago is a prime example of what is at risk if nothing is done to address the subsidies that the Gulf carriers receive," said United Flight Attendant Erica Levy. "If these airlines from the Gulf continue to expand with unfair advantages, domestic carriers may be forced to reduce routes just to stay competitive in the industry."

Recently, Jeff spoke at a meeting of the Wings Club, a global society of aviation professionals. He called the rise of the Gulf carriers the single biggest threat facing U.S. commercial aviation today and described the devastating consequences if Qatar and the United Arab Emirates are allowed to continue abusing the Open Skies agreements.

Also this week, the Partnership for Open and Fair Skies released a research report by Aaron Klein, director of the Financial Regulatory Reform Initiative at the Bipartisan Policy Center and a former deputy assistant secretary for economic policy at the U.S. Treasury Department, that draws parallels from the decline of the domestic shipbuilding industry to the present-day trade dispute with the subsidized carriers.

The report estimates that the effects of continued inaction on the Open Skies agreements could put 200,000 U.S. jobs at risk - a significantly higher number than previous estimates provided by the Partnership to the U.S. government agencies currently reviewing the issue.

This followed a new report by one of America's foremost aviation economists that finds that the government-subsidized expansion of the Gulf carriers into the U.S. is threatening service and access for communities

across the nation. The report, by William Swelbar, executive vice president at InterVISTAS Consulting, Inc., and a research engineer at MIT's International Center for Air Transportation, concludes that heavily subsidized Gulf carriers are shifting passenger traffic away from U.S. air carriers without generating new demand, thereby threatening the viability of nonstop flights and service to local communities in America.

Tablets for rent on select flights to and from HNL



United began a test program the week of July 29th, that allows customers on Boeing 777 flights between HNL (Honolulu) and GUM and HNL and the U.S. mainland to rent Samsung tablets during their flights. The Samsung tablets are intended to complement existing Wi-Fi and Personal Device Entertainment (PDE) options on longer flights.

Because some of these flights are close to nine hours long, United wanted to provide customers with an entertainment option if they don't have a device or forget their device.

Rentals will cost \$9.99 for flights six hours or less and \$14.99 for flights longer than six hours and will include complimentary ear buds. Tablets will be complimentary to all first class passengers.

Customers will also have access to new-release movies and TV shows plus magazines and books, as well as custom-curated content from Tribeca Film Festival and Vevo music videos, all adding up to more than 100 hours of content. The tablets have a 20-hour battery life so customers won't have to plug into a power source during the flight.

Torgy's Travel Tips – September 2015

"Should I stay or should I go?" That's the theme of a current TV commercial for a hotel chain. Well, I think you definitely should go! Get out and explore this wonderful world, especially during fall or spring when flights are less full, temperatures are more moderate and roads less crowded. Here's some food for thought: **Drive Historic**

Route 66!

Originally called "America's Main Street" and "The Mother Road", Route 66 connected Chicago and Santa Monica, CA before the construction of the Interstate

Highway System. There was a TV show titled Route 66 in the 1960's starring Martin Milner and George Maharis and before that, "Get Your Kicks on Route 66" were the lyrics of a popular song.

Well, the longest continuous stretch of old Route 66 in the US is the 159 miles from Flagstaff, AZ west to Needles, CA. And what a kick it is to drive! The two-lane road is peppered with Burma Shave signs along the farmers' fences. The motor-court motels, complete with colorful metal chairs in front of each unit, are very much in evidence. And roadside attractions show up everywhere. If you hop on 66 at Flagstaff, don't miss the Museum Club, an iconic Route 66 watering hole. It is said that proprietors Don & Thorna Scott are frequently seen behind the bar or in a corner booth, although both have long since passed away. The town of Seligman, located just west of Flagstaff, is the epitome of a Route 66 town. It retains all the flavor of time gone by and is having a ball keeping it up. Don't miss The Roadkill Café or the Sno-cap Drive In, complete with a gravity-feed gas pumps and a back lot of long abandoned manual tools and old classic cars. The star of the town is Angel's Barber Shop. Angel was instrumental in keeping Seligman alive after Interstate 40 diverted car traffic around the town in 1978. The Pixar movie "Cars" was based on the area around Seligman and you can catch an interview with Angel on the "Cars" DVD in the bonus section. Angel is 88 years old and he still opens his shop every day. The shop has expanded to include quite an extensive and fun gift shop. And lastly, you might even leave Seligman with a complimentary Route 66 DMV License if you stop at the Rusty Bolt down the street.

Now my favorite stopping point along the Route is the tiny, dirt street town of Oatman, located between Kingman and Needles. You go to Oatman to see the donkeys – yes donkeys! A century ago this was a thriving gold mining region. Between 1915-1917, the equivalent of \$870 million in today's dollars was extracted in the nearby hills. Prospectors used donkeys to transport the gold and these laid-back yet wild burros are the descendants of the pack animals turned loose by the early prospectors when the mines closed down in 1921. The animals are protected by the US Dept of Interior but can and do roam anywhere they want in Oatman. You can buy burro chow at nearly every store in town to feed the donkeys. Remember though, they are wild animals. One further note: Route 66 from Oatman eastbound to Cool Springs is **not** accessible to motorhomes or vehicles over 20 ft long due to the twisty and narrow road. The landscape is steep, dry and wild. We witnessed bighorn sheep and donkeys darting across the road, so take it slow.

The remainder of Route 66 into California is all but hidden by I-40. There are remnants of the Mother Road

near Barstow at the Calico Ghost Town and of course Santa Monica Pier is the "end of the road", both figuratively and literally. There is a booth on the pier operated by the National Route 66 Association and the volunteers have a wealth of information to share. Unlike other merchants on the pier, all proceeds at this booth from T-shirts, postcards, maps, etc, benefit the upkeep and promotion of the Mother Road.

So get on out there and get your kicks!

United implemented innovative, industry-leading contingency fuel program

United reached a significant milestone this year when it began fully operating all international flights using an innovative new statistical contingency fuel program known as Analyzed Regulatory Fuel (ARF). United is the only U.S. airline flying according to this program, which enables the company to plan the right amount of fuel to cover for unexpected contingencies.

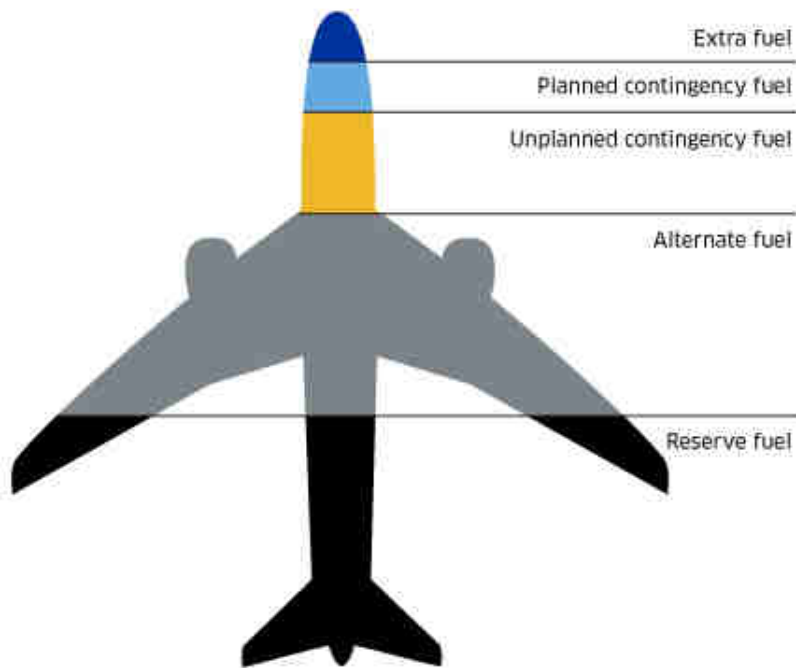
As you know, fuel is an enormous expense, and, while nothing comes before safety, there are many ways that United can save even more fuel. ARF is another way United can do that.

Every flight has certain fuel requirements in addition to the basic amount needed to get from point A to point B. On top of that, each international flight is required to have at least 30 minutes of reserve fuel, fuel to get to a nearby alternate airport, and a certain amount of planned and unplanned contingency fuel.

On United's domestic flights and certain short-haul international flights, United currently use a program called Analyzed Contingency Fuel (ACF), which analyzes two years of actual fuel burn data for individual flight segments to determine statistically how much additional fuel above the regulatory fuel requirement United should add. ACF gives United the ability to save millions of dollars a year in fuel, but until now United has not been authorized to use it on most international flights.

Historically, international flights had a blanket 10 percent unplanned contingency fuel requirement, even though in many cases United's data showed that a safe and reliable flight really needed less - in most cases only around 3 percent.

In early 2015, United conducted validation flights. After each flight, United collected data and feedback from pilots and dispatchers and improved the company's procedures. The FAA assessed United's system and allowed United to continue ARF flights after it demonstrated that ARF performed as expected in all situations. That assessment led to authorization to replace the traditional 10 percent contingency fuel re-



Extra fuel: Fuel which allows the aircraft to deviate from the planned route to avoid weather.

Planned contingency fuel: Fuel needed to account for known contingencies at the destination, such as known ATC delays.

Unplanned contingency fuel: Fuel needed in addition to "planned contingency." ARF is now used to calculate unplanned contingency fuel.

Alternate fuel: Alternate fuel enables the aircraft to reach a nearby alternate airport if landing at the planned destination becomes unachievable.

Reserve fuel: On international flights, reserve fuel is required so the aircraft could hold for 30 minutes in case of any unplanned events upon arrival at the destination station.

quirement with the data-driven system for all United flights.

"We built this program from scratch," explained Operational Efficiency Senior Program Manager Marc Brodbeck.

"It took two years and several phases of validation and supporting data to demonstrate to the FAA that our ARF process was safe, accurate and reliable."

"We are now using data to provide the "right" amount of extra fuel to cover unexpected contingencies without adding unnecessary fuel and weight," explained Network Operations Director Laura Farnsworth Allen. "It's a very innovative approach."

The FAA is currently working to finalize the new rule. United expects it to be fully approved later this year.

"We accomplished these changes through a great cross-divisional effort, including working very closely with the United FAA Certificate Management Office," said Corporate Safety VP Mike Quiello.

"It takes a lot of diligence to develop a program such as this. Thanks to Flight Ops, the dispatchers who worked during the validation period and Government Affairs, who worked with the FAA to develop this cutting-edge rule."

During validating flights, United saved 1 million gallons of fuel. The company anticipates being able to save 3 million gallons each year.

Reducing the amount of unplanned contingency fuel helps remove excess fuel weight on its aircraft, which enables United to carry more passengers and cargo. Carrying the right amount of fuel on board will also help United increase fuel efficiency and reduce its carbon emissions.

We wished Happy Birthday to our July celebrants **John Eisinger** and **Judy Hebl**.

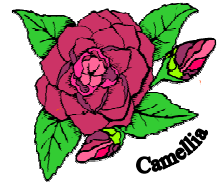

Greetings from Idaho! Boise has cooled down considerably since my last report, with just a few hot days. We do enjoy the articles you share. David and I were so surprised and pleased to receive a letter from past members, **Ted & Ann Pumphrey**, who live in Slanesville, WV. Ann said, *"Even though Ted and I have been back east nearly nine years, we miss the monthly meetings in Boise and look forward to your columns in RUAEA newsletter, Carol."*

We were a "small but mighty" group at our July 8th meeting. Gathering in the restaurant's back room has worked out very well. It is quiet, as we are usually the only ones there, and the food choices are very tasty. Attending were **Shirley & Rick Dempsey**, who pick up **Marlene Croghan**, **Charles & Shirley Perkins**, and **Louise Duvall**. I was a little late and a little lost, as my approach was from a different direction than usual.

Sitting next to Louise, I was able to hear about (and now share) her latest adventure. And I do mean adventure, as she did all her own driving, from here to Texada Island, BC, Canada and back! She took three ferries from Vancouver before arriving to visit with her daughter, north of the San Juan Islands. Only half of Texada Island is occupied, and folks there get to their local stores, restaurants, etc. by walking. Louise's week there, visiting on the island, must have been wonderful (and hard to say good-bye!). Added to her blessings are many grandchildren and great-grandchildren. No other news was shared (on paper), so I am thankful for news of this wonderful family time.

I would like to share news of a very, very special event (one you've most likely never heard of) hosted by our city, lasting from July 28 to August 2. Jaialdi (pronounced Hi-All-Dee) is a Basque celebration/festival including many, many activities. The unique cultural institutions and social events in Idaho are a blending of old and new ways. Jaialdi is a one-of-a-kind expression of that phenomenon. Idaho has 7,900 residents who claim Basque heritage, 2,000 of them in Boise. Contrary to myth, though, Idaho is not the most populous Basque state in the U.S. California holds that honor. But what Idaho Basques lack in raw numbers,

they more than make up for in concentration, visibility, and distinctiveness. Basques began arriving here more than a century ago, flourishing as they integrated themselves into civic and social life while preserving their unique heritage and cultural identity. Their strong and unique presence made Boise a natural pick for the first Jaialdi festival in 1987, and for those that have followed every five years since 1990. Beginning in the early 1800's, Basques left their homeland in northern Spain to escape civil war, economic hardship and political oppression. Leaving Spain they sought opportunity, a measure of acceptance and peace. Essentially stateless in their homeland, but with a culture and identity that predates even the Roman conquest of Europe, Basques readily assimilated here while still maintaining their strong cultural identity. *"That value of we, us, our, is different from I, me, mine. Basque values are plural, and so that affects their integration into their community."* When the Basque president was asked what he would take home with him, he replied, *"I'll take the pride that Basques feel here in Boise, Idaho and all of the United States. The pride of feeling like a working people who love liberty, people who want the best for themselves and the rest of society. And that pride is what fills me personally. And I'll take with me the commitment to continue passing history down, generation to generation. It's important to know what world we're a part of. To know that each one of us has our personality, our identity, and that communication between the identities enriches society. Here, the Basques are doing that for the enrichment of the United States."*

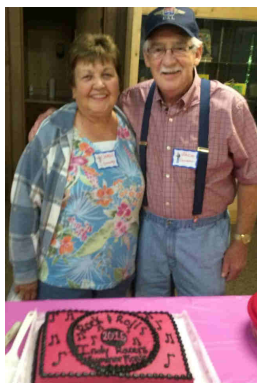

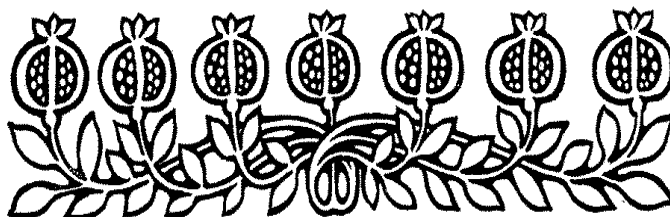

The news is that CON-UAL is retreating from JFK at a time when smaller airlines are expanding. What baffles me is that the old UAL knew they had lost money serving JFK for the past seven years; why did they not try to rectify that problem in 2008? Maybe they did and failed.

JFK was where I was hired in 1956 but then it was called Idlewild. Nothing against the Kennedy's but there are thousands of schools, roads, bridges, highways and centers named Kennedy, but there was only one Idlewild.

In transferring JFK flights to EWR in New Jersey, I wonder if the Rajahs of Revelation in Houston considered the fact that people don't like driving from the NYC area or by taxi because of the bridge and highways tolls. When he was on his feet again, he packed his suitcase, and explained to his wife that he hated being looked after and said "Goodbye" and left.

His wife put the 3 level house plus cellar up for sale. She explained to the buyer that the house was too large for one person; then moved into a 3,000 sq. ft. condo.

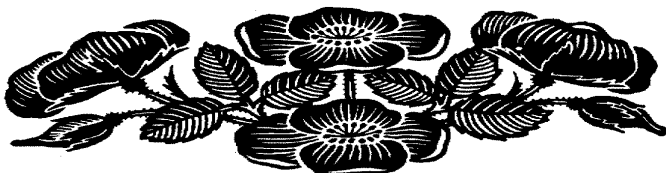

Gail Gorski, United Airlines 747 Captain at SFO, passed away on July 20, 2015. Gail was the first female pilot hired by United Airlines in 1978. She enjoyed a long career flying which began at 16 when a friend took her on a pleasure flight. She fell in love and decided she wanted to be a pilot. She pursued her dream at South-eastern State College, earning a degree in aviation, where she was later recognized as a Distinguished Alumni in 2012. She spent her junior year of college at University of Louisville after being named Kentucky Derby Queen. When entering the working world, this "beauty queen" title provided ammunition for naysayers to argue she was hired for jobs due her good looks. She



didn't listen and went on to be the first female VIP for the Federal Aviation Administration (FAA) and the first female FAA Flight Inspection Pilot, proving she had the brains to back up her beauty.

In 1978, Gail was hired as the first female pilot for United Airlines - which at that time was the largest airline in the free world. She spent her 37 year career with United, most recently as a Captain on Boeing 747's flying international routes, mostly to Asia.

Throughout her career, Gail was very active in the Aviation community. She was one of the 21 original members of the International Society of Woman Airline Pilots. She also led "Fear of Flying" classes, helping to explain the science of flying to those who were scared to travel by plane.

When Gail wasn't flying, she was a well-loved friend, amazing mother and caring daughter and sister. She touched everyone who knew her with her carefree spirit and warm smile. She loved good red wine, boating in the Bay Area, cheering on the San Francisco Giants and 49ers, throwing dinner parties and being with her friends and family. She will truly be missed.

Robert England mentioned in this letters section that we should talk more about United and what we did that may not have been recorded. When Veronica and I visited the Boeing factory/museum, I started thinking and writing down what I remembered that I saw in my 37 years at United Airlines. I was hired as an aircraft painter. But, for the first three months I was a sheet metal worker in the sheet metal shop. I then took a UAL home study course on sheet-metal, one of the many courses offered to UAL employees. Three months later, I went to SFOOV as an aircraft painter. That's where I heard of **Butch Raymond**, a former Capital employee. I learned how he was instrumental in getting an airplane overhaul, now called Heavy Maintenance Visit (HMV), of the DC-8 and the B720 accomplished in one week.

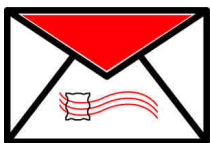
Then, I got my greetings from my Uncle Sam. Fortunately, I asked the retired military employees that were working in OV for advice. I followed their advice and wisdom. After four years in the Air Force, I went back to work for UAL as an aircraft painter. On my return to UAL, SFOOV was using acrylic paint on the interior and exterior. When an aircraft was down, SFO

would team up a crew that would go on a field trip no matter where the aircraft was and get it back into the air again. One of those field trips was a DC-8 that UAL personnel retrieved from a very difficult place. The crew had to make a temp repair so it could T/O out of where it had to make that unplanned landing. Then they had to land it where a better repair could be made so that it could fly to SFO for a HMV. During the HMV, OV re-skinned the left hand top of the wing. UAL did a lot of HMV contract work for other airlines such as TIA, Federal Express, People Express, Air Florida, Alaska and other airlines.

When I was a temp MPA, I heard that about 20% of the workers were employed at UAL because of all the contract work performed. When I was at SFOMM, I was on a Braniff A/C going to the gate when a Pan Am 747 on too short of a runway hit lights on takeoff and then came back to SFO. When I was in the radio shop of component maintenance, I saw where UAL's engineering created UAL's own test stations for the removed components so they could make them serviceable again. Because of the unique back shops, UAL could produce a now needed part, sometimes per sample, by paying Douglas or Boeing for the right to manufacture that part at SFO. This capability is not available today in SFO. Just about anything needed could be reproduced by using new methods like Flame Spray at UAL. The impossible just took a little longer. Creativity was alive and well at UAL. I think the loss of that ability is a terrible loss to the United Airlines of today.

When I was a radio and electric lead working on the Pan Am 747SP reconfiguration at SFOUM, UAL had acquired five 747s to reconfigure to UAL interior/exterior. They were nick named the "Lemon Sisters". I heard a lot of thoughts about what a crazy idea it was to buy those five 747s. Those five A/C hummed while they were making money for UAL.

I saw where having the component maintenance all at one station was a great benefit. When Line Stores had an expedite for a serviceable part that was needed now for an out of service A/C, the MOC would more than meet the challenge. I would think that there are many unusual stories and experiences from the different departments and internals of UAL's torso. SFO was a marvelous place to work and I worked with many talented employees. I hope to hear from more of you in this Letters Section.

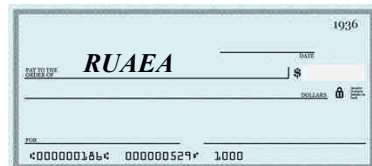
