# <u>United Launches Largest Winter Schedule Ever with a Focus on Africa, Southern Europe, & Latin America Plus Ski and Sun Destinations Across the U.S.</u> October 24, 2024



After a record-setting summer season with nearly 48 million customers traveling with United, today the airline makes it even easier for customers to keep adventuring as temperatures cool down.

United is flying its largest winter schedule in company history\* with an average of nearly 4,600 flights every day during peak season. The airline will add flights at more than 140 U.S. airports including new flights to some of the

most popular ski and sun destinations.

The airline is forecasting its busiest winter season ever and is seeing growing demand for international travel to Latin America and across the Atlantic.

The winter schedule kicks off with United's inaugural flight between Newark/New York and Marrakesh, launching October 24. Beginning October 27, the airline will be the only U.S. carrier to fly to Cebu, Philippines, with service from Tokyo/Narita. Later this winter, United will also add nonstop service to Medellin, Colombia from Houston and to Dominica from Newark/New York.

"This winter, we're offering more flights to more destinations to give customers the widest range of places to explore," said Patrick Quayle, United's Senior Vice President of Global Network Planning and Alliances. "Whether that's adventuring somewhere new overseas, unwinding with some sun or enjoying the best ski towns in the country, we're pleased to offer easy access to the top destinations for winter getaways."

Tickets are now available for purchase on the United app and on United.com.

<u>History-making expansion in Africa</u> ~ United will have the largest network in Africa in its history this winter and will be the only airline to directly connect the U.S. and Marrakesh with new three times weekly service from Newark/New York, launching October 24 on a Boeing 767-300ER. Combined with United's recently announced service from Washington Dulles to Dakar, Senegal\*\* launching in May 2025, United will serve more destinations in Africa than any other U.S. carrier. The new service complements expanded weekly flights from Washington D.C. to Accra, Ghana beginning in October and Lagos, Nigeria beginning in December.

More time to explore southern Europe ~ After seeing a record increase in summer travel to Europe, United will extend service to iconic European destinations including Greece, Spain, Italy, and Portugal this winter with the most seats offered during the winter peak compared to the same periods in 2023 and 2024. United will also extend several seasonal routes into the fall and winter months, including nonstop service to Milan and Rome from Chicago O'Hare and Madrid from Washington Dulles now flying until December 2024 and daily flights between Washington/Dulles and Lisbon, now extended to January 2025.

Game-changing connections within the Pacific ~ Starting October 27, United will be the only U.S. carrier to fly to Cebu, Philippines with daily flights on 737-800 aircraft from Tokyo/Narita, enabling easy, one-stop connections for U.S. customers from five hubs in the Continental U.S. This winter, United will make its second daily service between San Francisco and Seoul-Incheon year-round. United will also add a second daily flight between Los Angeles and Hong Kong, providing flights and connections in both the morning and evening. The airline is also increasing flying between Los Angeles and Shanghai with daily flights starting October 26 on a Boeing 787-9.

<u>Double-digit growth in Latin America</u> ~ United continues its growth in Latin America as the airline expects to be nearly 10% larger this winter compared to last year. On November 13, United will grow its presence in Colombia with new year-round service to Medellin from Houston\*\*, complementing the airline's existing routes to Bogota from Newark/ New York and Houston. Starting February 15, United will be the only carrier connecting the Northeast U.S. to Dominica\*\* with its weekly nonstop service on a Boeing 737-700 aircraft.

United is expanding its Latin America offerings from San Francisco with new, year-round flights to Monterrey, Mexico, operated by United Express partner SkyWest up to twice daily, and with new seasonal, weekly service to Belize City, Belize.

In the Caribbean, United begins service from Newark/New York to St. Kitts early, with weekly nonstop flights starting in November operating on a Boeing 737-900ER. The airline will extend service between Newark/New York and Bermuda into the winter season, making the route year-round, and will add daily service between Newark/New York and Port of Spain, Trinidad and Tobago for the peak holiday and Carnival periods.

United plans additional expansions from Chicago, Houston, Washington, D.C., and Los Angeles to cities like Buenos Aires, Argentina; Guatemala City, Guatemala; Morelia, Mexico; San Juan, Puerto Rico; and San Salvador, El Salvador.

<u>Coast to coast domestic growth</u> ~ United's domestic schedule from January to March will be its largest ever with nearly 140 airports offering more flights than the same time last year.

During the winter season, U.S. travelers will have more opportunities to head west with an average of nearly 13% more seats to warm-weather destinations including Phoenix, AZ; Palm Springs and San Diego, CA.

The airline will launch new non-stop service between Washington/Dulles and Salt Lake City and Palm Springs on December 19.

United continues its growth in Florida this year with 20 additional departures from its hub airports to cities like Fort Lauderdale, Orlando, and Palm Beach. The airline will also bring back its popular nonstop service from Cleveland to Cancun and several Florida destinations including Orlando, Fort Lauderdale, Tampa and Fort Myers.

<u>United leads in ski destinations this winter</u> ~ United continues to offer more service to top ski markets than any other U.S. carrier with nearly triple the average daily flights of other airlines and nonstop service to 11 ski markets in 2024.

This winter, the airline will introduce larger, Embraer E-175 aircraft operated by SkyWest\*\* to Aspen, CO and Bishop/Mammoth, CA, offering more premium seats on these select ski routes, as well as increase the number of flights between United hub airports and destinations including:

- ▲ New winter seasonal weekend service between Washington/Dulles and Bozeman, MT and an additional flight between Newark/New York and Bozeman, MT.
- ▲ New seasonal weekend service between Chicago and Gunnison/Crested Butte, CO in February and March.
- ▲ New winter seasonal service between Los Angeles and Kalispell, MT starting in February.
- A second daily flight between Newark/New York and Jackson Hole, WY from December to March.
- ▲ During peak holiday season from December to January, a daily flight between Los Angeles and Montrose/Telluride, CO.
- Twice daily service to Sun Valley, ID from both Los Angeles and San Francisco during peak holiday season.
- A seasonal extension of Denver-Bishop/Mammoth service with twice weekly flights through the end of April.

#### <u>United Helps 20,000+ Customers Find Right Aircraft for</u> <u>their Wheelchair with Industry-First Digital Sizing Tool</u> October 17, 2024

More than 20,000 customers who travel with wheelchairs have already used United's industry-first digital sizing tool since it launched in March 2024, with feedback from those customers helping contribute to a nearly four-point improvement in customer satisfaction scores compared to a year earlier.

As part of today's announcement and as another way to further improve the travel experience for customers with disabilities, United also began a new collaboration with United Spinal Association to help advise and support the carrier.

"The early success of our digital sizing tool is an encouraging development in our ongoing efforts to find more ways to improve the travel experience for customers of all abilities," said David Kinzelman, Chief Customer Officer for United. "We look forward to working together with United Spinal to explore even more impactful solutions in the future; collaborating with their community of experts and harnessing their valuable feedback will help us better meet the specific needs of our customers who use wheelchairs."

Earlier this year, United launched the new digital tool on its app and <u>united.com</u>, making it easier for customers who use wheelchairs to find flights that can best accommodate the specific dimensions of their personal mobility device. The airline also announced that customers may seek a refund of the fare difference if a customer needs to pay more for a flight that can accommodate their wheelchair. Customers seeking a refund of the fare difference will need to follow United's process; United will promptly ensure they receive the difference in fare after review.

"I am thrilled about this collaboration with United Airlines," said Vincenzo Piscopo, Chief Executive Officer and President of United Spinal Association. "I commend their commitment to making the travel experience more accessible for people with disabilities and their decision to choose United Spinal Association as a partner in this journey. This partnership demonstrates that accessible travel is a reality, and every step forward brings us closer to a more inclusive travel experience for the disability community. I hope to see continued improvements not only from United Airlines but also throughout the entire travel industry."

In addition to the digital sizing tool, United has made several product and policy changes recently to improve the experience for people with disabilities:

- ▲ Providing ramp agents mobile technology that indicates when a wheelchair is on a flight to help ensure they are better prepared to receive and load it. The technology also inhibits ramp agents from closing out a flight until they acknowledge that they've loaded all wheelchairs.
- ▲ In 2023, United was the first U.S. airline to add Braille to aircraft interiors, helping millions of travelers with visual disabilities more easily navigate the cabin independently. United expects to outfit its entire mainline fleet with Braille by the end of 2026.
- ↑ The United mobile app makes it easier to use for people with visual disabilities with increased color contrast, more space between graphics and reordering how information is displayed and announced to better integrate with the screen reader technologies like VoiceOver and TalkBack.
- ▲ United's Inflight Seatback Entertainment screens offer a wide range of accessible features such as closed captioning, text-to-speech controls, magnification, explore-by-touch capabilities, audio described movies, and adjustable and high-contrast text and color correction. As part of United Next, the airline's historic growth plan, the carrier expects to take delivery of about 700 new narrow and widebody aircraft by the end of 2032, all of which will include the latest in seatback screen entertainment options.

# <u>United Airlines Announces Third-Quarter 2024 Financial Results:</u> <u>Exceeds Earnings Per Share Expectations</u> October 15, 2024

United Airlines (UAL) today reported third-quarter 2024 financial results. The company had pre-tax earnings of \$1.3 billion, with a pre-tax margin of 8.7%; adjusted pre-tax earnings of \$1.4 billion, with an adjusted pre-tax margin of 9.7%. The company also achieved diluted earnings per share of \$2.90; adjusted diluted earnings per share of \$3.33, ahead of the third-quarter 2024 guidance provided at the start of the quarter of \$2.75 to \$3.25.

The company produced strong financial and operational results in the quarter. As the company expected, revenue trends improved as the industry reached an inflection point in the quarter with unprofitable capacity exiting the market. Domestic unit revenue was positive year-over-year in August and September. Demand continues to be strong for the United product: Corporate revenues were up 13% year over year in September, and in the quarter premium revenues continued to remain resilient and were up 5% year over year and revenue from Basic Economy was up 20% year over year.

"I appreciate the entire United team coming together to take care of our customers by operating a safe and on-time airline this summer," said United Airlines CEO Scott Kirby. "As predicted, unproductive capacity left the market in mid-August, and we saw a clear inflection point in our revenue trends that propelled United to

exceed Q3 expectations. A prosperous summer 2024 is just the beginning as our improved customer experience combined with United Next positions the airline at the top of the industry for the foreseeable future."

<u>Capital Allocation</u> ~ The company's Board of Directors authorized a new share repurchase program for up to \$1.5 billion of outstanding shares of common stock and warrants originally issued to the U.S. Treasury under the CARES Act and Payroll Support Program, subject to a limit of \$500 million in aggregate through year-end 2024. This amount represents approximately 7% percent of the company's market capitalization based on the closing stock price on October 14, 2024. This is the first share repurchase program since the suspension of the previous program in 2020 due to the COVID-19 pandemic. Unless suspended or terminated earlier by our Board of Directors, this program has no set expiration date and will therefore terminate when the company has completed all purchases authorized under the program.

"In the last four years, we've invested \$22 billion in our product and nearly \$10 billion in our people. Those investments have enabled higher profits and are now contributing to growing free cash flow," said United Airlines CFO Michael Leskinen. "We're now in a position to add a share repurchase program as we continue to invest in and de-leverage our business. We are simultaneously targeting net leverage below 2x in the next few years. We intend this buyback to be the beginning of a consistent and disciplined return of capital that is paced by our ability to generate increasing levels of free cash."

In the quarter, the company repurchased in the open market just over 2 million shares of UAL common stock in connection with the exercise of roughly 6.4 million warrants issued to the U.S. Treasury under the CARES Act and Payroll Support Program. The repurchase of these shares eliminated the dilution associated with the warrants exercised and are separate from the \$1.5 billion share repurchase program above. The shares were purchased at an average price of \$39.99.

Under today's \$1.5 billion share repurchase program shares may be repurchased in the open market and in privately negotiated transactions, as well as accelerated repurchase agreements, depending on the capital needs of the business, the market price of UAL common stock, general market conditions, securities law limitations and other factors.

Preheat oven to 450.

It's Christmas morning and all through the house everyone is busy unwrapping gifts, cleaning up Christmas wrap, playing with toys and the cook is in the kitchen preparing breakfast for everyone. Let's give her/him a break and have them prepare something simple. How about fluffy biscuits to go with a casserole, eggs, or with honey or jam?

7 Up Biscuits: 2 cups Bisquick ½ cup sour cream ½ cup 7 Up ¼ cup melted butter

While you are making the biscuit dough, take ¼ cup butter, put in a 9-inch pan and melt in the oven. Once it is melted remove from oven. Cut sour cream into Biscuit mix with a fork until blended. Add 7 Up. This makes a very soft dough.

Sprinkle about ¼ cup additional Biscuit mix on countertop (unless you have a cutting board) and pat dough out.

Take your dough you have patted out to about 9 inches and carefully pick it up and put in pan with melted butter.

Cut the dough into 9 pieces. I find this is the easiest way, but if you have a biscuit cutter, you can cut them out and put in the pan.

Bake for 12-15 minutes or until golden brown.

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. On November 2, I turned in 1177 coupons worth \$4,854.50. Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons.
