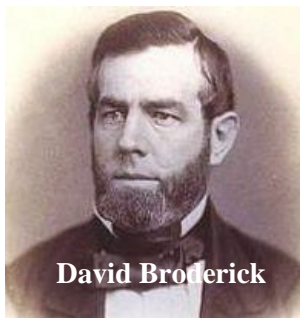

## The Writers' Column The Last Duel in the United States By George Midwin

Of the 568 of the California State Historical Landmarks I have visited, one in particular, I found very interesting. Following a sign on the freeway for a historical site ahead, it led me through a heavily populated area. I came upon a tiny park, with walkers, runners and babies in strollers, all oblivious as the significance of this park and the event that took place there over 160 years ago. This was the site of the last duel to have taken place in the United States and one that reverberated across the land.

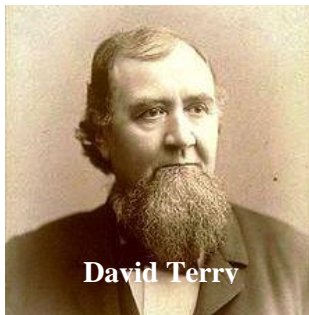
The duel between David Broderick and David Terry on September 13, 1859 as stated on the historical plaque is similar to many, many others. However, having researched this further, I discovered much more and why it garnered so much attention in America.



David Broderick

David Broderick was born in Washington, D.C., to parents who immigrated from Ireland, to build the Capitol building. After the passing of his father, David worked as a stone mason and volunteer fireman in New York. He became involved in the Democratic Party and made an unsuccessful bid for congress. Years later he moved to San Francisco and with some partners, produced gold coins and helped organize the San Francisco fire department. Today the Broderick Engine Company No 1 is named in his honor. In 1850 he was elected to the State Senate and then in 1857 to the US Senate. David was a man of the working class and fought for the rights of those who were neglected. Often he would be at odds with other members in his own party, as an advocate to abolish slavery.

David Broderick rose to the position of President of the Senate and for a short time, became the Governor of the State of California upon the resignation of Governor Mc Dougall. He exhibited an energy that was seldom seen and was a crowning success as a senator.



David Terry

David Terry was born in Kentucky and raised in Texas, becoming a Texas Ranger. He studied law and as a lawyer, moved to California to work the gold fields in 1849. However, he found his fortune working as a lawyer in Stockton, California and became involved in the Democratic Party. He rose to prominence after taking a case of a wealthy widow who was being cheated by local authorities. The sheriff had hidden her gold for "safe keeping" somewhere near Monterey, California, but the person who hid the gold died and its whereabouts never revealed.

In 1855, Terry was nominated to the California Supreme Court and in 1857 served as Chief Justice. He continued in this position until September 12, 1859, when he resigned from the court.

David Broderick and David Terry were once friends; they became bitterly separated by their differences with regards to slavery. Broderick being opposed and Terry in favor of slavery. This led Terry accusing Broderick of being the reason to which Terry was denied to be re-nominated to the Supreme Court. Terry delivered a scathing speech denouncing Broderick, who in turn had negative comments for Terry.

A few months later, Broderick himself failed to win reelection as senator. Shortly after, Terry sent a letter to Broderick regarding the remarks he made against him, calling them "offensive in nature". Terry then challenged Broderick to a duel.

Upon staging the duel, a large group of spectators and media turned out. The sheriff discovered the duel and because dueling was illegal, arrested both men. However, they both were released a short time later. Soon after, Broderick and Terry agreed to move the duel to a more secluded location, just outside the city of San Francisco. Only a small group of witnesses and media present.

Before the event ever took place, Terry had a few months to 'practice' using a set of European dueling pistols. Terry became quite adept at using the pistols. Broderick was unaware of this, but was a good shot himself. The dueling pistols have adjustable trigger pull, from a strong force to very light or 'hair trigger'.

Each man had chosen a 'second', someone who would ensure that neither dueler had an advantage over the other. This included a search to ensure no objects were present that would deflect a bullet. Each second brought their own dueling pistols. A coin toss decided choice of position, won by Broderick and choice of pistols, won

by Terry. After the seconds inspected the pistols, they were provided to the duelers. It was later reported that Broderick received a pistol with a lighter trigger.

The two men assumed their positions and call for ready was made. Terry responded immediately, while Broderick fidgeted with his pistol. As the call to fire came, Broderick fired on the count of 'one'. However, as he raised his arm the pistol discharged, with the bullet hitting the ground a few feet in front of Terry. On the count of two, Terry fired, striking Broderick in the chest and he fell to the ground. His wound was not fatal and he was transported to a friend's house in San Francisco.

David Broderick died three days later. The largest funeral ever held in San Francisco was attended by over 35,000 people. Several speakers spoke and a friend, Edward Baker, delivered a wonderful eulogy. He was laid to rest at Laurel Hill cemetery in San Francisco, with a very large obelisk marker on his grave.

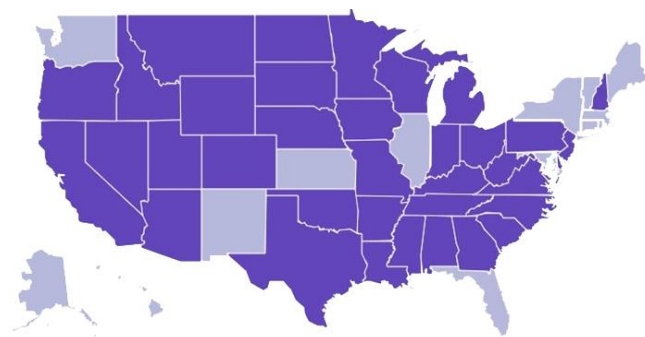
The story doesn't end here. In 1937, the ever growing city of San Francisco needed more room to build. The Laurel Hill cemetery property was to become future homes and businesses. Those interred were to be moved to a new cemetery South of the city. Remains, numbering in the thousands, were dug up and placed in shoe box sized containers and buried in one large mound, with just a small plaque recognizing the move. The large obelisk on Broderick's grave may have befallen the same fate as the headstones of the others, used for erosion control at Ocean Beach in San Francisco.

Several years later, Terry was representing his new wife in a controversial legal case. The case was heard by a former friend of Broderick, Stephen Field, having served together on the Supreme Court. Terry and his wife were convicted of contempt of court and jailed. A year later, Terry, when at a train stop, ran into Field and slapped his face. Field's body guard shot and killed Terry. He is buried in an elaborate plot in Stockton, California. His wife became insane and spent the rest of her life in the Stockton Sate Hospital for the insane.

The pistols used in the duel, were discovered 110 years later in a museum in London. Later they became the property of a private individual and ended up in auction in 1992. In the Bank of California in San Francisco, two dueling pistols are on display, purportedly used by Broderick and Terry. Many believe these are copies.

Two granite markers, erected in 1932, now eroded, mark the spot where the last duel took place in the United States . More than just a landmark.

### **Travel planning made easier with new feature** **September 3, 2020**



Some exciting news for travelers trying to navigate travel restrictions due to COVID-19: today, we launched a new interactive map tool on [united.com](https://united.com) and the United mobile app that allows customers to filter and view travel restrictions for a desired destination.

The Destination Travel Guide, a first among U.S. airlines, provides an interactive, color-coded map to highlight if a destination is closed, partially open or fully open for travel, and will also note if any tests or self-quarantining are required for travel. Customers can easily filter destinations to view local regulations,

such as social distancing and mask enforcement, as well as to see if hotels, restaurants and other leisure outlets are open to the public.

*"We know it's a challenge to keep up with the ever-changing list of travel restrictions, policies and regulations so we are offering a simple, easy tool that helps customers decide where to travel next,"* said Chief Digital Officer and Technology EVP Linda Jojo. *"By providing the most up-to-date information on the destinations we serve, customers can compare and shop for travel with greater confidence and help them find the destinations that best fit their preferences."*

The tool currently highlights travel restrictions and leisure offerings in the U.S. by state and will expand to include all international destinations we serve in the coming weeks. Customers viewing the color-coded map can click on each state to view local regulations and travel guidances. There is also the option to filter the map by state to view specific information on each destination, including:

- ➔ Medical certificate needed (such as negative COVID test)
- ➔ Non-essential shops open
- ➔ Tourism accommodation open
- ➔ Restaurants open

- ➔ Bars and cafes open
- ➔ Museum and heritage sites open
- ➔ Mask in public required
- ➔ Physical distancing required

The new map feature follows several of our recent innovations that were designed to enhance the travel experience. As part of the United CleanPlus program, we recently introduced touchless check-in, text alerts for passengers on standby and upgrade lists and a new chatbot to give customers a contactless option to receive immediate access to information about cleaning and safety procedures.

United-branded masks are now available for purchase on the United Shop! The first design (pictured in the bottom left-hand corner of the photo above) is available now as a retail option for customers and employees to purchase for personal use. Many front-line employees have already received their company-issued reusable mask and are not required to purchase additional masks.

### **We're flying 40% of our full schedule in October** **September 4, 2020**



As part of our thoughtful approach to rebuild our network, we announced today that we plan to fly 46% of our full domestic schedule next month compared to October of last year. That's eight points higher than our September 2020 schedule. We also plan to resume eight routes to Hawaii, pending approval of the state's pre-arrival COVID testing program. Additionally, we will fly 33% of our international schedule, which is four points higher than last month.

We continue to respond to the growth in leisure travel demand by adding flights to cities in Mexico, Central America and South America.

*"We continue to be data-driven and realistic in our approach to rebuilding our network," said Domestic Network Planning VP Ankit Gupta. "Because October is typically a slower month for leisure travel, we're adjusting our schedules to reflect these seasonal changes in customer demand while resuming service or increasing capacity on routes where we're seeing customer demand for travel."*

Furthermore, we're also realigning the times of our flights to match the current demand for leisure travel. Next month we plan to add more flights on popular days, and schedule fewer flights on Tuesdays and Wednesdays when demand is lower. These are some of the details of our schedule plan for next month:

#### Domestic schedule changes

- ➔ Resuming or starting new service on nearly 50 routes, including 37 routes from ORD, DEN and IAH.
- ➔ Resuming additional service to Florida and adding IAD to SRQ (Sarasota, Florida) and MIA as well as DEN to RSW (Fort Myers, Florida).
- ➔ Resuming service between LAX and EUG (Eugene, Oregon), MFR (Medford, Oregon) and RDM (Redford/Bend, Oregon).

#### International schedule changes

- ➔ Resuming service to 14 international destinations including BOG (Bogotá, Colombia); EZE (Buenos Aires, Argentina); LIM (Lima, Peru) and PTY (Panama City, Panama).
- ➔ Increasing to twice-daily service between EWR and TLV (Tel Aviv, Israel) and resuming three-time weekly service between IAD and TLV on October 25.



- ➔ Resuming or increasing service to CUN (Cancun), MEX (Mexico City) and PVR (Puerto Vallarta) in Mexico.

### **New nonstop service to Florida starts November 6** **August 12, 2020**

Why point-to-point flying? Why Florida?

We plan to add up to 28 daily nonstop flights this winter connecting customers in BOS (Boston), CLE (Cleveland), IND (Indianapolis), MKE (Milwaukee), LGA (New York-LaGuardia), PIT (Pittsburgh) and CMH (Columbus, Ohio) to four popular Florida destinations. The new, nonstop flights reflect our continuing strategy to aggressively manage the impact of COVID-19 by increasing service to destinations where customers most want to fly.

We will add these flights starting November 6 with new roundtrip service from BOS, CLE and LGA to FLL (Fort Lauderdale), RSW (Fort Myers), MCO (Orlando) and TPA (Tampa). In December, we will increase service to Florida with additional flights from CMH, IND, MKE and PIT to RSW and TPA. Tickets are now available for purchase on [united.com](http://united.com) and the United mobile app.

From November 6, 2020, through January 10, 2021, we will operate nonstop service from BOS, CLE and LGA to FLL, RSW, MCO and TPA on peak days.

Beginning December 17, we plan to increase service to up to 28 daily nonstop flights with the addition of service from IND, MKE, PIT and CMH to RSW and TPA.

**RUAEA Website History:** Back in 2003, our RUAEA President **Jim Fauber** and Vice President **Marlin Lade** had a vision that RUAEA should have a website to provide members with timely informative information specifically tailored for United Airlines Retirees.

**Mort Wax** who later would be a President of RUAEA recruited **Bob Kalicki** and I (**Jim Sommerfield**) to look into making that dream a reality. A meeting was set up in Denver, Colorado that summer between Knut & Susan Moe who were to become RUAEA's website hosts, and **Marlin Lade, Dean Moberg, Bob Kalicki, and Jim Sommerfield**. We discussed what would be required for hosting the website and reviewed what some of the requirements for the website might be. We also discussed getting the Newsletter on the website as one of its main features. This required us to work closely with the RUAEA Denver Office and the Newsletter Editor **Jo Madden** at that time. **Jim Sommerfield** worked very closely with Knut and Susan, (Spectrum Corp) regarding what functions, data, and levels of security would be required for the initial website. The initial website was successfully implemented in August, 2003.

**Website Modernization took place in 2011:** Jim redesigned and modernized the RUAEA website for a more modern look. This current design was successfully implemented on Monday April 11<sup>th</sup>, 2011.

The current design makes things simpler in providing all content except the online newsletter available to all RUAEA members, and visitors. The only choice you have to make when you start or renew your membership is whether you want the newsletter in the mail, online only, or both online and paper, which is done at that time.

When accessing the online newsletter you can use your e-mail address and a password.

**Website Managers:** It became necessary to have additional Website Managers to support the website. Jim asked **Ed Majewski** to assist him which Ed did for several years until his passing. Jim then asked **Toni Van Kampen** to assist him with the website. Jim and Toni are your current website managers. Both Toni and Ed performed in an excellent manner.

**Current Website:** Currently, our website is being viewed across all 50 states, and is being accessed across the entire Globe. We have a huge following in many foreign countries. Especially in China, Russia, France, Germany, Canada, United Kingdom, and Poland just to mention a few.

**Website Features:** The Home page of the website is a virtually a **one stop shop** for most if not all of your retiree needs. The navigation items on that page will take you wherever you want to go by a single click of your mouse.

There are currently **23 main functions** available to you from that page. Be sure to check it out if you haven't already done so.

In addition the **Home Page** currently contains all current important information concerning Retirees.

The website Home page has **four** very important features that retirees will find extremely beneficial and informative.

1. **Important Retiree Resource Links**: Currently there are **41 Retiree Resource Links** available for your use. Featured links are for Retiree Airline Employee Associations, Financial and Business Links, Home Mortgage Rates, Loan Information, Government Agencies, Latest US and World News, Medical and Insurance Links, AARP, PBGC, United Airlines Corporation, United Benefits Links, Star Alliance, United Mainliner Clubs.
2. **Travel**: There are **19 Travel Links** available for your use. In addition there is Travel Information regarding, Travel Assistance, United Pass Line (UPL), Creating a Pass Travel Plan, Retiree Travel Awareness, United Airlines Pleasure Travel Regulations may be found as well. The 19 links available cover travel features such as Flight Schedules, by airline, city pairs, date & time, Flight Tracking, Employee Leisure Travel, Discounted Airport Hotel Rooms, Travel and Cruise Packages, Vacation Rentals, Travel Guide Information, Great Vacation Deals etc.
3. **Special Interest Links**: There are **10 categories of Special Interest Links with 15 individual links**. Categories include, Rock N Roll Classics, Sports, National and Local Weather, Cooking & Recipes, Arts & Crafts, Home Improvements, Home and Garden, Gardening Designs & Tips, and Hollywood Celebrity News and Entertainment.
4. **Senior Discounts**: There are **4 individual links** set up for you to view various Senior Discounts. They are Senior Discounts by Category, Address and Zip Code, 100 + Stores Offering Senior Discounts. 196 Discounts for Seniors.

**Website Most Notable Features Include:**

1. The ability to sign up and renew membership's online using debit or credit card which was implemented in 2014.
2. In 2017, we added RUAEA Facebook capability for access and usage from the RUAEA Website home page.
3. In 2019, we developed procedures for Apple, and Android Phones for placing Website Icons on the Home Pages for ease of website access. Note: These procedures are found on the websites Home Page and in an article found in the June 2019 Newsletter.
4. In 2019, we created a new function for RUAEA Volunteer signup.
5. In 2019, we added a new feature which allows you to be notified by e-mail when new important items have been added and are available for your viewing.

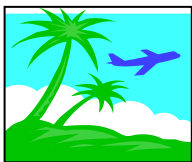

Be sure and read Torgy's Travel Tips about resumption of service in the September issue of the RUAEA Newsletter. She mentions both international and domestic schedules and changing requirements. "On the United App, there is a tab off of the booking page titled Travel Restrictions, which is very informative. There is good news when waiting for seat assignments at the gate! We will now receive a text message, which includes a link to our new boarding pass, instead of being paged to the counter. This makes less work for the gate agents, easier for us straining to hear our name, and a breeze to just scan the electronic boarding pass ourselves at the gate.

"United announced on September 2, "approximately 16,000 United employees will be notified of an involuntary furlough effective as early as October 1. This includes 1,400 Management and Administrative employees who have already been told their jobs will be eliminated at the end of September. They don't expect demand to return to anything resembling normal until there is a widely available treatment or vaccine. Congress is negotiating another stimulus bill to address the economic impact of Covid-19. That legislation may include an extension to the Paycheck Protection Program, and the union partners along with the leadership team are making a strong campaign in support of that. It might prevent involuntary furloughs on October 1, and hopefully delay any potential impact on employees until early 2021." Hopefully it will be delayed, at least!

Is September 2020 a typical time of year for Northern California? Yes it is with the heat, fires, smoke, power outages, and thunderstorms. The Covid-19 of course is affecting everyone in the country. We are still on lockdown in Butte County with Shasta and Tehama County doing a little bit better job. Chico has decided to let the restaurants serve patrons outside on the sidewalks. It really is working out very well. Redding can have restaurants open on a limited basis. We even have three restaurants in the Paradise area that are able to serve patrons outdoors. Some hairdressers, nail salons, gyms and churches are not allowed to be open.

Our group has not met together since March. Everyone seems to be doing OK but certainly we would like to get together and socialize. Thank you to **Sonda Sandstadt**, our Northern Regional

Director, for keeping me informed and I try to pass any info on to the group or at least print it up so they can see it when we get together again.

Many of our members are cooking and baking and I asked for some recipes that anyone would like to share.

I would like to share this one recipe with the RUAEA members. It is called **Gluten-Free Zucchini Bread**. Hope you enjoy it, from **Carl & Grace Franke**.

Ingredients:

4 cups of gluten-free baking flour (Bob's Redmill Baking Flour)  
½ tsp. Xanthin gum (only add this if your flour does not have this ingredient)  
2 tsp of baking powder  
2 tsp of baking soda  
1 tsp of salt  
2 tsp of cinnamon  
2 tsp of allspice  
12 Tablespoons of butter (melted butter in microwave)  
2½ cups of granulated sugar  
4 eggs  
½ cup yogurt (vanilla or I used lemon)  
2 Tablespoons lemon juice (I added only 1 Tablespoon because I used Lemon yogurt)  
3 cups of shredded zucchini. (Do not peel the zucchini and make sure to **remove all seeds** before putting it in a food processor)

Directions:

1. Prepare the zucchini and set aside
2. Spray bottom and sides of 2 loaf pans (approximately 9x5)
3. Preheat oven to 375 degrees
4. In a large bowl add gluten-free flour, xanthin gum, baking powder, baking soda, salt, cinnamon and allspice. Mix all ingredients together and set aside.
5. In another large bowl add melted butter and sugar. Mix to dissolve sugar.
6. Add and mix the following to the butter and sugar bowl: eggs, yogurt, lemon juice
7. Add half of the flour mixture to the other bowl with the butter/sugar/etc. and half of the shredded zucchini. Mix by hand until well blended. Then continue mixing in alternately the flour mixture and shredded zucchini. No need to use an electric mixer, just thoroughly blend.
8. Pour batter equally into the 2 prepared loaf pans.
9. Bake at 375 degrees about 50 minutes or until a toothpick is clear of any wet batter.
10. Cool loaf pan on racks for 10 mins, then remove bread and cool on wire racks.
11. When cool, slice bread and serve. I put parchment paper between the slices and freeze it in containers. You can also wrap a loaf with aluminum foil and put it in a freezer bag. Use it within 6 months if you freeze it.

Wow! Thank you Carl and Grace. This is a great recipe and I even made it! It was delicious!

Here is hoping everyone stays safe, healthy and sane. Hopefully soon everyone will be able to have the normal get-togethers that we all love.

I am going to continue with our early history of United. While we were busy working and raising families, we didn't really have the time to read about and appreciate the long road we have come down.

The year was 1927 and Boeing Air Transport and National Air Transport joined together to create irregularly scheduled first transcontinental passenger service between New York City and San Francisco. The cost was \$404 dollars per person for two passengers wearing flying coveralls, parachutes and goggles. They would cram themselves into an enclosed mail pit and sit on the mailbags or hold them in their laps. This was for the duration of a 32-hours flight of 2,600 miles with 15-stops and the noise of the engines thundering in their ears. When the passengers changed planes in Chicago, they were at risk of losing their seats if additional mail had to be loaded.

Just two years later, in 1929 Boeing and NAT introduced the tri-motor transports that were designed specifically to carry 12 to 18 passengers in an enclosed cabin. The faster planes cut the flying time to only 28 hours and the increased capacity allowed the fare to be reduced to \$259.50. What was once called the U.S. Mail

Route #1 quickly became known across the nation as the Main Line.

The flights were to leave at a specific time but the departure times tended to be flexible; the usual factor of weather, also the availability of the airplane and pilots and the arrival of the passengers at the airport.

Before departure passengers luggage was weighed and tagged, tickets collected, safety regulations explained. All passengers were given comfort packages that contained cotton balls for the ears and chewing gum for dealing with changes in air pressure and the deafening roar of the engines. The passengers were allowed to carry two bags weighing



a total of 25 pounds.

At this time the flights were taking off in bright daylight although the nationwide system of lighted airway beacons had been completed. Passenger air travel had taken off and we were on our way in the vast blue skies

When our monthly breakfast resumes, I will again report on current news from our Resans family! At this time there is no information about our next monthly Breakfast. Worry not, we will be back ...

September 11, 2001 was just another day in my regular routine of getting up in the morning at 8 AM, dressing and getting set to make my breakfast. At the kitchen table was my radio tuned in to WQXR, with my breakfast before me and a hot cup of coffee. As always, the crossword puzzle from The Record was close at hand. As the classical music droned on, there was a sudden interruption, and a bulletin came on saying that an airplane has flown into one of the World Trade centers twin towers in New York City. My thoughts went back to 1945 when a B-25 Air Force bomber crashed in the Empire State building on the 79<sup>th</sup> floor. I can only have guessed that this was the same type of accident with another small plane.

As more reports started to come in I now turned on the TV, something which I never do until I look at the news at night. It was plain to see this disaster unfolding. As a newly elected councilman in Fairlawn, I was urged to join our re-created "civilian emergency response team", as best described, that emergency management went from being a mom-and-pop operation, to a more professional operation run by professionals and staffed by volunteers. Our training in emergency preparation was in all cases to render aid, but not become part of the problem.

I was soon called to help staff Fairlawn's newly established headquarters in the basement of our City Hall. During the afternoon, calls were coming in but the activity seemed to me quite slow. A TV was set up so we could keep abreast of the entire catastrophe that was unfolding. Towards nightfall the frantic calls from relatives started coming in and asking "*have you heard from*", "*can I leave a message*", "*is there any news of*", "*I'm trying to find*". The best that we could do was to assure those folks that if and when we hear of any survivors they would immediately be informed. None of us could realize the chaos that was going on by the Hudson River between Manhattan and New Jersey.

Finally about midnight we were told to go home and get some sleep and return in the morning. I got to my car and decided to drive down to our two commuter parking lots. There I found our police trying to help relatives find their loved ones' cars, so that they can leave messages onto the windshield wipers when they returned. Now I understood the enormity of what had happened, anger raged within me, if only I could retaliate to those who did this, I would do so with a vengeance, in the end four of our residents died at the twin towers.

Along with the other towns in Bergen County, Fairlawn sent two ambulances to assemble at Liberty State Park in Jersey City to be used as necessary. We also sent a command fire truck from company 2 that was used

by the New York City Fire Department. Afterwards on reflection, the only word that I can think of was “proud” the way our first responders worked, and myself being a part of them. This comes from a poem that I have read some time ago: as Americans you can write us down in history with your bitter twisted lies, you might grind us into the very dirt, still like the dust we shall rise.

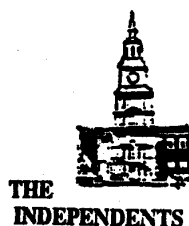

Coming near the end of the alphabetical lineup for Local News and RUAEA chapter reports, we'll refrain from "hunkering down" this month. Most reports in September referred to that as, unfortunately, their main

activity. Congratulations to those few chapters elsewhere in the country that have been able to meet in person. We envy you.

While the Seattle area (King County) has advanced to a higher level of activity after reaching safety levels permitted by the governor's restrictions, only a few restaurants are open for "dine in" experiences. Most still offer pick-up and/or delivery, but many others have been forced to permanently close their doors. Our hearts go out to those who have lost jobs and income during these unprecedented months. Most parks, beaches and other recreational facilities remain closed to the public. Some of this is due to backtracking when said public refused to honor safety guidelines to protect themselves and others from the coronavirus when areas were reopened – apparently too soon.

Co-Presidents **Ken Storey** and **Kathie Torgison** have issued a joint statement, published in the local chapter newsletter for September, noting changes in procedure for the coming months and year, while it is still unsafe to congregate in groups. Meetings will not resume until a vaccine has been developed and made available to all of us, hopefully some time in 2021. The chapter also will hold off on collecting dues while urging members to continue their memberships in RUAEA national. Sad times.

Raise your hand if you know **Carol Lucarelli**, cohort of RUAEA Past President **Hank Gosselin** (SEAMM). Both are members of the Emerald City Slickers, Arizona Sunbirds, and well-known on the RUAEA national scene. Carol often mentions her son, 63-year-old **Frank Lucarelli**, long time trainer at Emerald Downs Racetrack in Auburn, Washington. Frank, who gave up a minor league baseball career in favor of horses, recently was featured in the sports section of *The Seattle Times* with a glowing review of his 23 seasons working with horses there. Locals look forward to hearing more from – and about – Frank before the Emerald Downs meet ends in October.

We recently learned that Captain **Bruce Leach** (SEAFO) passed away April 9, 2019 at the age of 83. He had been fighting cancer for some years. He is survived by his wife **Grace**. Following his retirement, Bruce and Grace moved to Bonita Springs, Florida. They later returned to Auburn, Washington where they lived while Bruce was undergoing treatment.

**Ron Cantrell** (SEARR) died of a heart attack in August at his home in Federal Way, Washington. He is survived by his wife **Helen**, who also retired from SEARR. Condolences to both families.

Last month we began to chronicle the life, times and career(s) of **Dave Jones** (SFOFO), an active member and past president of the Emerald City Slickers. His member profile published in *Contrails* took two issues, and we got him only as far as the ETOPS approval for the 777 in the 1990s in our September column. We continue, mostly in Dave's own words -with some editorial privilege.

Here is the rest of "Dave Jones – A career defined by his love for airplanes, Part 1" and if we finish that, you'll find "Dave Jones – A career defined by his love for airplanes, Part 2".

Dave worked as the United maintenance and engineering coordinator for service readiness for the 777. This involved ensuring the airline had maintenance plans, documentation, training and spare parts to support start of service. As part of the ETOPS approval, Boeing and United jointly conducted 1,000 proof of readiness flight test demonstration flights over a variety of city pairs. United flight crews and mechanics actually operated 90 of these flight segments, usually during night time hours. The most rigorous test was an engine shut down midway from the west coast to Hawaii. The 777 continued on the remaining engine for over 3 hours to complete the flight. This successful work brought about Boeing and United's ETOPS approval for 180 operations at start of service in June 1995. Dave was privileged to be one of the lucky employees on the delivery flight of the first 777 on its flight from Seattle to SFO.

Following the 777 assignment, Dave was named engineering manager for new avionics technology, managing a group of senior avionics engineers responsible for researching, specifying and justifying additions of new avionics technologies to United's fleet. As an aero engineer by education and with a background in flight test operations, avionics electronics was a new challenge. Dave is still in touch with several in the core of engineers he relied on.

This assignment coincided with the emergence of GPS navigation and its first implementation on United planes. The most significant initial impact was on United's 747-400 fleet that was operated on trans-Pacific flights. United, Qantas, Air New Zealand and Cathay Pacific partnered with Boeing to pioneer and certify a capability to operate the 747-400 with a new Future Air Navigation System (FANS). It included GPS and specially-coded digital text messages (Data Link) delivered over the airline communication system ACARS. This new system replaced 1940s based communication and navigation, transforming the accuracy and dependability of over water navigation.

The new technology group's biggest project during Dave's time as manager was leading a fleet-wide upgrade of the weather radar systems on United airplanes. Back in the late 1940s and early 1950s, United

engineers had partnered with an avionics manufacturer to design an advanced weather radar system. For several reasons, United was the only airline to adopt that system, with all other airlines using different technology. This situation prevailed into the 1990s, giving United a superior radar picture of the weather – at least in the eyes of United’s technical pilots and engineers.

A series of fatal accidents related to wind shear in the 1980s changed the equation. Wind shear is a rapid change in wind direction and speed that is most commonly associated with thunderstorms. After these accidents, NASA and the industry developed both a means to detect the presence of wind shear and a means to fly out of it. Detection was based on the addition of new features to the weather radar systems used on all airline planes except United’s. To gain the new safety benefit, United had to give up its own system. Dave’s group developed the technical and business arguments for the change and worked a vendor competition for a system purchase that totaled tens of millions of dollars to change over United’s 500 planes over a 5-year period.

As the weather radar program progressed, Dave’s career was altered once again. Though this article was covered in Parts 1 and 2 in the Seattle chapter’s local newsletter, we’ll save a newly-developed Part 3 for the November RUAEA Newsletter.

October’s special event is some folks’ favorite “holiday,” but Halloween will be quite different this year. Most revelers will already be wearing masks – of a different kind! Here’s to Happy Haunting in abbreviated form.
