



- ➤ Don introduced our new Treasurer, **Chris Johnston**, who will be replacing outgoing Treasurer **Pam Ziebarth**. Pam was presented a certificate of Achievement for her years of incredible service. She was credited with creating our first budget.
- ➤ Don spoke about the Benefit Panel that will follow the Business Meeting. He stressed that without RUAEA, we would not have this impressive representation from United Airlines, Alliant and the Health Organizations.
- ➤ The following positions will need to be filled in 2020; President, Executive V.P. and V.P. of Conventions. Anyone interested in serving should contact **Don Burbank** or **Tom Cunningham**.

<u>Virgil Gooselaw</u>, <u>Past President</u> – Virgil emphasized that we are a social organization staffed by volunteers.

- One of his areas of responsibility is the Denver office. Our Membership Manager, **Cas Spokas** lives about 100 miles away from Denver, therefore Virgil is called upon to take care of issues as needed.
- ❖ We started the year with three secretaries, and all have retired. The office is now managed by Virgil and **Mike Malesardi**, who is a recent retiree.
- ❖ Virgil also heads the Nominating Committee. Please let him know if you have anyone who may want to volunteer. **Ed Meyer** has resigned as our auditor after 14 years of excellent service. **Dolly & John Taucher** will serve as our new auditors.
- ❖ Our Newsletter is made successful due to the monthly efforts of **Francis** & **Veronica Domaratius** and **Martha Gooselaw**, Letter Editor.

<u>Pam Ziebarth</u>, <u>Treasurer</u> – Last year RUAEA had income of about \$112,000 and expenses of nearly \$111,000 for a surplus of only \$1,000.

- ✓ Expenses Our largest expense is the Newsletter, which accounts for about 51% of our expenses. The website accounts for a little over 12%. Board travel is about 22% (that covers two board meetings plus the Regional Directors travel to chapters). The remaining 15% goes to various operating expenses of the organization.
- ✓ Cash Reserves includes current cash reserves (which is savings, checking and three CD's) are \$225,000 compared to last year's \$221,000 at this time; thus \$4,000 more. Three big expenses; Newsletter, Board travel and website will impact negatively in the next three months.
- ✓ Income current income from dues, contributions and interest (\$82,000) is running about \$800 behind last year at this time.
- ✓ Bottom line currently RUAEA is solvent
- ✓ Comments from Pam "I have thoroughly enjoyed serving as the RUAEA Treasurer for the past five years. I thank the organization for giving me this opportunity and Ron Bertacini especially for getting me on the board. I learned much, made life-long friends and was able to experience firsthand the last ten RUAEA conventions, what fun they have been. I hope the new Treasurer Chris Johnston, will experience this same enjoyment working with such a super Board of dedicated individuals. A final thanks to Ed Meyer, previous auditor for the 14 years of dedication to RUAEA, for all that he taught me and for all the laughs we had the past five years".

- > Our enhanced Centers of Excellence (COE) program is provided by a new vendor, with more hospitals and broader access to care.
- ➤ Active&Fit Direct<sup>TM</sup> gives you access to fitness centers nationwide for just \$25 a month through our employee discounts program.

- Are you enrolled in the Healthy Rewards PPO plan? If so, there are a few specific changes that apply to you. We've highlighted them here, and you can learn more by reading your 2020 Benefits Guide on YBR:
- ➤ If you choose to set aside your pre-tax dollars in a Healthcare Flexible Spending Account (HCFSA) in addition to the Health Reimbursement Account (HRA) that comes with your medical plan, during Annual Enrollment you'll need to select which of those accounts your medical and prescription drug reimbursements are pulled from first your HCFSA or your HRA.

#### eRES: You asked, we updated



UAL made some changes in employeeRES that you might want to know about before booking your next trip.

First of all, we want you to know that we're listening to what you're saying – lots of employees told us they didn't like that the booking window had been

reduced to 60 days in the new eRES, so we've changed it to 120 days. Now you can plan more in advance for your next trip, with the ability to list for any space available flight or book your positive space company business travel (when inventory controlled seating doesn't apply), up to 120 days before departure. As a friendly reminder, please book responsibly, and for any bookings you no longer need, please cancel in advance. If you want to brush up on the guidelines around leisure and company business travel, check out our <u>pass travel guidelines</u> and <u>company business policy</u> for tips and more.

The unaccompanied minor (UMNR) booking process for pass travelers has also changed, because of the recently implemented policy that allows a maximum of six UMNR travelers per flight. In addition, UMNR pass riders will be able to travel on connecting itineraries only when they're accompanied by an adult pass rider (age 18 or older) on all segments of the itinerary. This is a more recent change that will be updated in eRES in the coming weeks. When you're booking UMNR travel, eRES now displays an alert message reminding you about the updated policy. The number of booked UMNRs will be available in the flight details on employeeRES, before and after you book, and you'll want to keep an eye on that. Also, we're now asking you to provide an emergency contact person for the UMNR traveler's record, in case customer service agents need to reach out to ensure our young travelers' safety and/or give guardians peace of mind. With these changes, the United mobile app will not initially support UMNR pass travel bookings, and it will point you to eRES. See the infants, children and unaccompanied minors page on Flying Together for the full UMNR policy details.

#### Statement on Boeing 737 NG aircraft



The FAA announced it is requiring airlines that operate Boeing 737 Next Generation (NG) aircraft to inspect these older aircraft for structural cracks.

Boeing 737 NGs with more than 30,000 cycles must be inspected within seven days, while planes between 22,600 and 29,999 cycles must be inspected over the next 1,000 cycles of the aircraft.

None of the Boeing 737 NG aircraft in United's fleet have more than 30,000 cycles, so the seven-day inspection requirement does not impact United.

Roughly 80 of United's aircraft fall between 22,600 and 29,999 cycles, and all of those aircraft will be inspected within the required timeframe.

These inspections will not have any impact on United's operation. Safety remains United's top priority and the company will continue to work closely with Boeing and the FAA with the inspection requirements for its 737 NG aircraft.

## Torgy's Travel Tips – November 2019 What In The World Is Going On ...?



There have been several announcements in the last couple of months that impact world travel and many are good ones! Let's take a few minutes to catch up on the latest news.

On the United Airlines front we have good news on several levels. Mileage Plus members now don't have to worry about their accrued miles ever expiring! In the past if there was no activity on an account within a 3 year period, miles would begin to expire, year by year. Now those miles are protected forever. United offers the most low-mileage Y class awards of any global US airline. So remember, for those of you who prefer to fly *confirmed* using the Employee 20% Discount, you accrue miles for all those trips and now they won't expire. If you had miles in your account that expired within the last 18 months, you can buy back those expired miles for a reduced fee, for a limited time. The cost is \$35 if you lost 5000 or less expired miles, \$70 for

up to 20,000 miles. Over 20,000 miles you have some, options: pay a flat \$70 fee provided you either complete a United flight within 90 days on a paid ticket (Emp20 discount is OK to use) <u>or</u> open a MileagePlus credit card and make a purchase, <u>or</u> you pay \$105 for up to 35,000 expired miles with no other action required. Expired mileage between 35,000 and 750,000 miles incur incrementally increased costs. And did you know that you may convert unused gift cards into miles? Over 30 companies like Starbucks, Macy's, Wal-Mart, Target, etc

participate with MileagePlus in this exchange program. There must be an unused balance on the gift card of at least \$15 to be eligible. Learn more on www.giftcardexchange.mileageplus.com.

Another perk associated with MileagePlus is a discount membership in CLEAR. This company digitizes your fingerprints and iris scan into an encrypted code enabling you to enter the TSA screening zone quickly at airports and some other facilities like sports stadiums. (Note: this is **not** the same as TSA Pre√. CLEAR members bypass the TSA document checker line but still must proceed through the normal hand baggage screening line.) Learn more at <u>www.clearme.com/partner/united</u>. Although there was a recent announcement of a United Airlines employee discount, it applies only to those who have a united.com email address, so retirees do not qualify.

Now we all like it when United announces new destinations, so make a note of these new cities and start dates and start making your travel plans. Dec. 7 - CUR Curacao, Dec. 15 - CPT Cape Town SA, May 2 - NCE Nice, May 20 - PMO Palermo, all originating in EWR. In addition, Nov. 1 - DENLHR becomes year-round service. On Mar. 28, a second daily flight will be added from EWR to both FRA and AMS. That same day new service will begin from ORDZRH. SFODEL will also convert to year around from seasonal service. Next summer our seasonal service to ATH, BCN, NAP and OPO will also be lengthened. And speaking of destinations, listings for UA flights can now be made 120 days out, a recent change from the 60 day limit before

On the international scene, a big change effective October 1, 2019 affects travel to New Zealand. Similar to their neighbor Australia, an electronic visa is now required for the majority of visitors. Unlike Australia the new NZeTA (New Zealand electronic Travel Authority) is valid for 2 years and it includes the mandatory IVL (International Visitor Levy) which the country collects to help offset the cost of maintaining and improving visitor sites due to tremendous increases recently in tourism. As the name implies, the visa is electronic, so you complete the entire process online. The official website to use is: <a href="www.nztravel.gov.eta">www.nztravel.gov.eta</a>. (Do not be lured to other websites, as they are merely secondary marketers looking to collect a few extra dollars.) It takes 5 minutes or less to fill out the application and you must include a credit card number to pay the 2 fees: NZD12.00 for the visa and NZD 37.00 for the IVL. If you download the NZeTA app, you save a couple of dollars. You will receive a confirmation email containing your NZeTA number and expiration date. I printed 2 copies of mine to paper, one to keep at home for future reference and the other to put with my passport for my next trip to New Zealand. By the way, if you are boarding a cruise to New Zealand, you <a href="must">must</a> bring a <a href="printed">printed</a> confirmation of your NZeTA to present when checking in. As a reminder, <a href="must">Australia</a> has required an Electronic Travel Authority (ETA) for many years. Go to <a href="www.eta.homeaffairs.gov.au">www.eta.homeaffairs.gov.au</a> to apply. The cost is AUD20.00 and is valid for 1 year.

Now, if you have grandchildren traveling alone on your passes who under the age of 12 you already know they are considered an unaccompanied minor (UMNR). A new policy recently was implemented which limits the maximum number of UMNRs on any flight to 6. When you list your grandchild, you will see a message showing how many UMNRs are already booked. It is up to you to monitor the listing to see if the chances for them making the flight are still good. A further change involves connecting flights. The official policy states: UMNR passriders will be able to travel on connecting itineraries only when they are accompanied by an adult pass rider age 18 or older on all segments. Basically that means the child is really no longer an unaccompanied minor, since they now must travel with an adult. You might just want to go ahead and confirm the child using your EMP20 discount vs. using a pass to take the worry out of the situation.

OK, we all love discounts, don't we? Well check out the new portal for employee discounts we can now use. Access the new site through the Flying Together homepage under Employee Services, then Employee Discounts. You must complete a one-time registration and henceforth it will take you right to the index page. The discounts encompass a wide range of services from car rentals, hotels and theme parks to products such as movie tickets, clothing and flowers. The program is maintained by Perkspots and if you encounter any difficulties, accessing the site you can email for assistance at *cs@perskspot.com*.

And lastly, get used to bringing an empty water bottle along when you head to the airport next time. More and more large venues like airports, zoos and stadiums are no longer selling bottled water in order to reduce the number of discarded plastic bottles. Water fountains with special dispensers for filling your bottle are appearing in many locations, both in the US and overseas. SFO airport is the most recent to ban the sale of bottled water. Look for the special water fountains along the concourses and in the eating areas of several restaurants. It makes sense for us to respect the planet and bring our own vessel to the vessel!

Under the new plan only she would have free Doctors for the balance of the year, I would have to pay off my own \$1,200 out of pocket before being eligible. Last year, the first without her as a beneficiary, I spent less than \$300 out of pocket. The change, if any, in the prescription portion of the plan is yet to be explained. They are offering more drug stores for use but changes have not been addressed. Currently using a drug store, even a CVS local store has a deductible fee to be paid and cost is slightly higher for prescriptions that follow. Using the mail program there is no deductible and costs are good. Everyone still on the UA plan was urged to participate in the conference calls being set up in October and have your questions written down so you remember whatever it is you want explained.

We are looking for a change in our Christmas luncheon for no reason other than we, as a group, would like to try something different.
