### **30,000 employee discounts**



United offers a lot of different reward programs, some of which you're probably very familiar with – travel privileges, for example.

United is announcing its brand new and enhanced employee discounts program, which is powered by PerkSpot. United

has kept all the great discounts you're currently familiar with and added many more. The new program will include over 30,000 discounts from 550 brands, including companies like Target, Macy's, Costco, Sam's Club, Walt Disney World, Samsung, AT&T, DIRECTV, XFINITY, DISH, T-Mobile and Sprint. And in early 2019, United will start to offer local discounts for its international team members.

With the new program, you'll also be able to customize your discount experience to fit your needs and interests. Here are a few of the new features:

- ❖ Design your home page to feature the categories that interest you
- ❖ Access local discounts via an interactive map based on Zip Code
- ❖ Receive optional weekly emails with the latest discounts
- ❖ Recommend companies that you'd like to see added to the site
- ❖ View offers in more than 100 different languages

Contact customer service for assistance locating discounts, maneuvering the site, checking the status of orders or following up on any issues/concerns.

You can add the new discounts site as a favorite on Flying Together. The path is Employee Services > My Rewards > Employee Discounts.

Once you register, you'll start receiving weekly emails, which you can opt out of at any time. If you don't interact with the employee discounts site, the emails will switch to monthly for six months and quarterly after that.

### **Know before you go: HNL-GUM weight restrictions**



Pass travel, while still fun, can be a little tricky. That's especially true in certain markets where aircraft weight restrictions further limit available space for standby passengers.

One route in particular on which this poses a challenge is HNL (Honolulu)-GUM, where

often the planes may already be at or near maximum weight once revenue customers, luggage, food and beverages, fuel and cargo are on board, even with empty seats remaining on the aircraft. Since United doesn't bump cargo for non-rev passengers, you may see open seats on a flight that is in fact loaded to capacity due to the high demand for cargo on this route. Because of this, United may not know how many space available travelers it can accommodate until close to departure.

Through June, United has had the highest load factors in the past five years on the HNL-GUM route, and more than 44 percent of those flights have been weight restricted. United's Load Planning and Employee Travel teams are currently looking at ways to minimize the impact to non-rev passengers and better inform employees when restrictions are in effect. For now, you'll see a notice appear before you complete a HNL-GUM booking in employeeRES, warning travelers to the possibility of limited seats.

### **Retirees, employees celebrate 50 years at SJC**



On August 20, 2018, 50 years to the day after United opened its SJC (San Jose, California) station, dozens of United employees, retirees and elected officials gathered at Norman Y. Mineta San Jose International Airport to celebrate the milestone.

Norman Y. Mineta, a former San Jose mayor, U.S. congressman and secretary of the Departments of Transportation and Commerce, joked that he asked his parents why they named him "after an airport." Mineta referenced his family's long history with United—his wife, Deni, was a United flight attendant for more than 30 years—and said he had watched United grow at SJC over the decades and was proud to see it develop into an important station for the airline.

SFO VP Bryan Quigley noted that he first flew into the area 35 years ago, when he was a U.S. Navy pilot, and later as a United captain. "*San Jose is an important part of our network, connecting Silicon Valley to our midcontinent hubs and to the world,*" Bryan said, "I



want to thank all of our SJC employees for all that you do here.” Several retirees who worked at the station in the 1960s and 1970s were at the event. Mary Rawson, who retired in 2017 after almost 34 years at SJC, noted that her father, Fred Sladek, who was also present at the event, was among the crew who reported for duty on Aug. 20, 1968. *“I worked here with many of the same people my father worked with,” Rawson said. “I love United and wanted to make sure our long history here was celebrated.”*

*“It’s a huge honor to be celebrating 50 years with United at SJC,”* said SJC General Manager Rachael Braggs. *“SJC has a great team, and I am looking forward to our next 50 years.”*

To take to a party I leave in foil and then wrap in several layers of newspaper, and tape shut to keep it hot in transit.

### **Clam Dip in Hot Bread**

Cut off top of round loaf of either sour dough or sheep herder’s bread. Save lid. Tear out inside of loaf of bread, but do leave a little bread on inside wall of the bowl. Tear into bite size pieces. Wrap in foil and set aside.

Mix:

- 3-7 oz. cans of minced clams
- 2-8 oz. packages of cream cheese, room temperature
- 2 teaspoon lemon juice
- 2 teaspoon Worcestershire sauce
- 2 teaspoon Salt
- 6-8 drops tabasco

Pour into empty loaf. Replace lid and wrap tightly in foil. Bake at 250 degrees on baking sheet for 2½ to 3 hours. Serve hot. Put bread pieces that you wrapped in the foil into oven last hour.

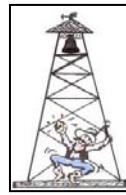
Travel Coordinator **Ginger Dahlberg** has flyers for the 2018 trips. 2019 trips are being set up.

**Judy Fitzpatrick** asked if there is a “magic list” of things that you should have ready to grab should you need to evacuate quickly. There were several suggestions to help with being prepared for “anything”. A big one is to have your important papers together. From there, Dolores suggested that you could copy the first page of things like insurance policies or your Trust/Will, house deed. You might want to keep the full policies in a bank lock box rather in a home safe. Even though they are rated “fire proof” you don’t want to have that one that will fail. Another good idea is to photograph your home. This can be helpful in more than one instance. With pictures you can prove that you had certain items, or have made improvements to your house. The pictures can be put on a thumb drive – also true for the scans that you take of your legal documents. Keep that thumb drive where you feel it will be safe and you will be able to access it. Another thing to consider is keeping survival items in the trunk of your car. Nothing overwhelming, but things like water, maybe granola bars or other foods that don’t take up too much room, can last awhile and still be good. Be sure to switch those things out for fresher ones so they don’t go bad/expire. Oh, if you have pets that you will be taking with you, put in some of their food too!

You can check with your insurance company and ask if they have a “Be Prepared” package that will give you more ideas.

**Tom Kenny** mentioned that they had recently been to the El Dorado Senior Legal Services for some trust help. Other Hangtown Miner members also use this great service. While they don’t charge for their help, they really rely on donations. There’s no “set” amount – just what you can afford or feel they deserve. Apparently their office is being recommended more and more as they are booking appointments about 3 months out and have been receiving enough donations that they are not in danger of being closed down this next year! Keep up the good work!

Speaking of our weekly breakfasts, we will be changing the location of our weekly breakfast meetings to Mimi's Café, 1200 El Paseo de Saratoga in San Jose, starting November 2. After many great years at Holder's Country Inn, we were told that the restaurant would close or be sold at year-end which precipitated the decision to be proactive and find a new location before the year is out.

Our Fall Luncheon at the Scottish Rite Center in San Jose is on September 11 so I will report on this event next month. We are looking forward to a good time together and a moment of remembrance for those who lost their lives on that fateful day in 2001. The RUAEA Cleveland Convention is also coming up in just a couple of weeks and I'll be sharing about that in next month's newsletter as well.

On August 20, Mineta San Jose International Airport (SJC) celebrated 50 years of United's presence at the air-



port having begun service on August 20, 1968. The airfield came to fruition in 1939, mainly to be a general aviation and crop-dusting airport. However, due to aviation restrictions during World

War II, the airport was not constructed until 1945. Just a few years later in 1949, the first commercial aircraft service began with a Southwest Airways (no relation to Southwest Airlines) DC-3, which chose SJC as one of its eight stops between San Francisco and Los Angeles. The airport was renamed in 2002 in recognition of Norman Y. Mineta's role as U.S. Secretary of Transportation and as being a native son. As a child, Mineta's parents used to take him to San Jose Airport, sparking his love of aviation. He enrolled in U.C. Berkeley to study Aeronautical Engineering, but he ended up switching to business administration after taking calculus. Mineta jokingly said, *"I decided for the safety of the country, and my own future, I should find another major."* In fact, the aviation bug runs through his family. His wife, Deni, was a United Airlines flight attendant for 35 years. His son, Stuart, is currently an ERJ-175 captain for SkyWest Airlines. # United Airlines Historical Foundation

## *(Part one of three)*

Omaha, Nebraska - March 9, 1923

From: Jack H. Knight, Pilot - Experimental Night Flying

To: Mr. J.V. Magee, - Special Assistant to the General Superintendent, Air Mail Service, Washington, D.C.

My Dear Mr. Magee:

After several forced landings due to a faulty motor in ship #242, I arrived in Omaha, Nebraska from Dayton, Ohio on February 5<sup>th</sup>, 1923. Numerous repairs to the motor were made from February 5<sup>th</sup> until February 8<sup>th</sup>. On this date, after a test flight in Omaha, I flew the ship to North Platte, Nebraska.

At North Platte, on the night of February 8<sup>th</sup>, I made a flight of slightly over one-half hour, before being forced to land by a broken rocker arm and a "missing" motor.

The 8<sup>th</sup> was a very dark night with no horizon whatsoever. I had an excellent opportunity to test all my lights as well as my new Turn Indicator and Banking Indicator. On take-off it had been simply a matter of turning out all lights - dash lights and navigation lights - and flying the ship by "feel" until I was positive of 1000 feet altitude.

At this altitude, a slight error in judgment does not have the same embarrassing effect on the ship and pilot that it might have at 100 feet.

The ceiling on this particular evening was about 1600 feet and hazy, as well as black. Until my eyes had become accustomed to the darkness, I felt the same degree of accuracy that a person feels in a perfectly strange room which is dark and full of obstacles.

I found that it was comparatively simple to fly toward a light (on the ground) some distance away, because you could check your direction as well as balance, but it was a difficult matter to fly into pitch blackness and maintain an accurate compass course at one altitude.

After flying ten minutes North by my instruments, I flew a credible return trip by the same method., I next flew the ship from my previous altitude to about 100 feet from the ground and cut-in my Wing-tip lights., The lights carried about 3/4 mile ahead and illuminated fairly well, but the "pencil of light" had a tendency to dazzle slightly and after turning them out, had a ten-

dency to blind temporarily until my eyes became accustomed to the dark again. Regaining 1000 feet, my motor started missing badly so I came back to the field and landed OK, with one search light (landing light) burnt out. At this time there were no Boundary lights on North Platte's landing field except two burning Buckets of Gasoline to show the limits.



After taxiing up to the hangar we found the broken rocker arm, so suspended flying for the night. On February 9<sup>th</sup>, I flew #242 back to Omaha for repairs on the motor and to wait for new bulbs for landing lights and also for 10 acetylene "blinker" lights to be sent from Chicago to North Platte.

My motor and ship were fixed up in Omaha in six days. We had considerable trouble with the generator and voltage regulator. The lights for the ship finally came on February 19<sup>th</sup> and I left Omaha for North Platte that same day with mechanic Stafford as a passenger (he has been assigned to Experimental Night Flying). Over Gibbon, Nebraska a cylinder on the left bank cracked-open and I was forced to land at Kearney, Nebraska (fifteen miles further on).

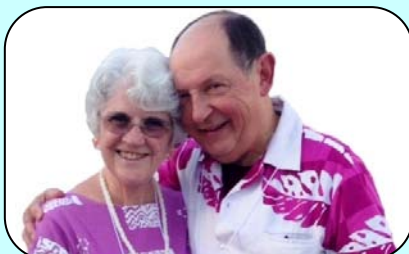
