



#### A letter to United employees from CEO Scott Kirby January 11, 2022



United Team:

Happy New Year - I want to start this message with a thank you.

Our frontline teams continue to put in a tremendous effort during what I know is an incredibly challenging and stressful time - the Omicron surge has put a strain on our operation, resulting in customer disruptions during a busy holiday season. I appreciate your professionalism, creativity, and caring approach – it's really made all the difference in helping us manage the impact on our customers.

In addition to impacting our operation and our customers, I also know that Omicron has affected the personal well-being of our United team. We have about 3,000 employees who are currently positive for COVID. Just as an example, in one day alone at Newark, nearly one-third of our workforce called out sick. To those who are out sick or isolating, we wish you a speedy recovery.

But as difficult as this period has been for you and our customers, there are two pieces of good news:

While we go to great lengths to avoid canceling flights, we worked to get ahead of the impact by acting early to cancel flights when necessary and notifying impacted customers in advance of them coming to the airport — we're also reducing our near-term schedules to make sure we have the staffing and resources to take care

of customers. As a result, we've been able to get a high percentage of our customers on other flights and close to their original arrival time. And considering the impact of Omicron and winter weather, our NPS scores and contact center hold times continue to hold up well. While we hate to ever have any operational disruptions, these results are a credit to all of you and your teams so thank you again.

The second and most important piece of good news is that our vaccine requirement is working - and saving lives. While we have about 3,000 employees who are currently positive for COVID, zero of our vaccinated employees are currently hospitalized. Since our vaccine policy went into effect, the hospitalization rate among our employees has been 100x lower than the general population in the U.S. Prior to our vaccine requirement, tragically, more than one United employee on average \*per week\* was dying from COVID. But we've now gone eight straight weeks with zero COVID-related deaths among our vaccinated employees - based on United's prior experience and the nationwide data related to COVID fatalities among the unvaccinated, that means there are approximately 8-10 United employees who are alive today because of our vaccine requirement.

In dealing with COVID, zero is the word that matters - zero deaths and zero hospitalizations for vaccinated employees. And while I know that some people still disagree with our policy, United is proving that requiring the vaccine is the right thing to do because it saves lives.

Thank you for all you have done as we navigated the unprecedented and unpredictable challenges that COVID has thrown our way. Stay safe and please continue to take care of each other and our customers. ~ Scott

#### New medical plans for the new year January 11, 2022



Many of you enrolled in a new medical plan for 2022, and with the start of the New Year, you're now able to use your new benefits to get the best care from the highest quality doctors.

Here are some helpful tips to keep in mind:

- ❖ Learn about your new coverage: Your Benefits Resources (YBR) and the Alight Mobile app are your go-to places to review your 2022 benefits guide, check your coverage details, learn more about spending and savings accounts, and more.
- New medical ID cards: If you enrolled in a new medical plan for 2022, you should have received a new medical ID card from your new carrier. If you haven't received it yet, contact your health-care concierge (either Accolade, Aetna or your HMO carrier) or visit their website to get a digital copy.

- Finding in-network care: Use the "Find a doctor" tool on YBR to check if your current providers are in-network or to find other in-network providers. You can also contact your healthcare concierge to help you find an in-network doctor.
- ❖ Virtual options for care: Sometimes you need care options without leaving home. Doctor On Demand is available for all Accolade-eligible employees in a PPO or EPO medical plan for virtual non-emergency care 24/7/365.
- ❖ Use your spending accounts for eligible expenses: If you enrolled in a medical plan that comes with a Health Savings Account (HSA), or if you've elected to contribute to a Flexible Spending Account (FSA) for 2022, be sure to use these accounts as payment for eligible medical expenses. Visit YBR to learn more about your spending and savings accounts and understand what expenses are covered. If you're new to the United Savings PPO plan for 2022, be sure to get your annual physical by March 31, 2022, to receive your HSA incentive dollars from United. If you were enrolled in the Healthy Advantage HSA plan in 2021, you needed to get your annual physical by December 31, 2021, to be eligible for your 2022 incentive dollars from United.
- ❖ Covid-19 testing: In-person testing (at a facility) is covered at 100% for all United medical plans. If you have an HSA or FSA, COVID-19 at-home test kits are an eligible medical expense, so use these accounts for tax-free savings. Stay tuned for updates on home testing while we await more information on insurance coverage details.

Watch for your "Welcome to your plan guide" that will be mailed to your home in the coming weeks.

## <u>United Airlines Achieves Fourth Quarter Financial</u> <u>Targets and Reiterates Long-Term Commitments --</u> <u>Despite Headwinds from Omicron Variant</u> January 19, 2022



United Airlines (UAL) today announced fourth quarter and full year 2021 financial results and reiterated confidence in its longer term United Next financial targets. The company achieved every major financial guidance target for the fourth quarter – and set a new Net Promoter Score (NPS) record in 2021 – despite the sharp spike

in COVID-19 cases caused by the Omicron variant. Despite near term volatility, bookings for spring travel and beyond remain strong, which is why the Omicron spike has not altered the airline's confidence in the 2023 and 2026 CASM-ex1 United Next targets announced last year.

The airline starts 2022 with a scaled-back schedule, reflecting the impact of the Omicron spike on demand. However, as the year progresses, United expects to nimbly ramp up capacity by ungrounding 52 Pratt & Whitney-powered Boeing 777s, as demand returns, which will yield improvements in the airline's gauge and aircraft utilization. The airline expects this approach, which continues to prioritize matching capacity to demand, means: 1) the airline will fly fewer available seat miles (ASMs) in 2022 than 2019 and 2) CASM-ex1 will decline significantly over the course of 2022. Most importantly, these 2022 trends will lay the groundwork for successful execution of the multi-year United Next strategy and achievement of the financial targets set for 2023 and beyond.

"The United team has been fighting through unprecedented obstacles to, once again, overcome the new and daunting challenges that COVID-19 is bringing to aviation, and I am grateful to each one of them for their commitment to taking care of our customers," said United Airlines CEO Scott Kirby. "While Omicron is impacting near term demand, we remain optimistic about the spring and excited about the summer and beyond. We look forward to beginning to return the Pratt & Whitney 777s to service this quarter and getting the full airline back to normal utilization — as we ramp up along with demand this year. By investing in innovative technology, focusing on process improvements and implementing a transformative United Next strategy, we're poised to emerge as an aviation leader that's more efficient than before and serves our customers better than ever."

#### Fourth Quarter and Full Year Financial Results:

- Reported fourth quarter 2021 capacity down 23% compared to fourth quarter 2019.
- Reported fourth quarter 2021 net loss of \$0.6 billion, adjusted net loss of \$0.5 billion.
- Reported full year 2021 net loss of \$2.0 billion, adjusted net loss of \$4.5 billion.
- Reported fourth quarter 2021 total operating revenue of \$8.2 billion, down 25% compared to fourth quarter 2019.
- ➤ Reported fourth quarter 2021 Total Revenue Per Available Seat Mile (TRASM) of down 3% compared to fourth quarter 2019.
- Reported fourth quarter 2021 Cost Per Available Seat Mile (CASM) of up 11%, and CASM-ex1 of up 13%, compared to fourth quarter 2019.
- Reported fourth quarter 2021 fuel price of approximately \$2.41 per gallon.
- Reported fourth quarter 2021 pre-tax margin of negative 10.3%, negative 8.3% on an adjusted basis
- Reported fourth quarter 2021 ending available liquidity of \$20 billion.

#### Outlook:

Expects first quarter 2022 capacity to be down 16% to 18% versus first quarter 2019.

- ✓ Expects first quarter 2022 total operating revenue to be down 20% to 25% versus first quarter 2019.
- ✓ Expects first quarter 2022 CASM-ex1 to be up 14% to 15% compared to first quarter 2019.
- ✓ Estimates first quarter 2022 fuel price of approximately \$2.51 per gallon.
- ✓ Now expects full year 2022 capacity to be down versus 2019.
- ✓ Now expects full year 2022 CASM-ex1 to be higher than 2019.
- ✓ Expects 2022 adjusted capital expenditures to be around \$4.2 billion, plus approximately \$1.7 billion in 2021 deferred capital expenditures mainly due to the timing of certain aircraft deliveries delayed to 2022, for a total of \$5.9 billion.
- ✓ Remains on track to achieve long-term financial targets from United Next plan.

#### <u>United Airlines statement On 5G Implementation</u> <u>January 19, 2022</u>



While we anticipate minor disruptions at some airports due to the remaining 5G restrictions, we're pleased the Biden Administration reached a compromise with AT&T

and Verizon to avoid mass cancellations across the aviation industry. We look forward to a higher level of coordination between the regulators, telecom companies and the aviation industry to ensure that customers are not faced with disruptions going forward.

Jan. 17, 2022 Statement ~ The federal government's current 5G rollout plan will have a devastating impact on aviation, negatively affecting an estimated 1.25 million United passengers, at least 15,000 flights and muchneeded goods and tons of cargo traveling through more than 40 of the largest airports in the country annually. When deployed next to runways, the 5G signals could interfere with the key safety equipment that pilots rely on to take off and land in inclement weather.

We won't compromise on safety – full stop. But, governments in other countries have successfully designed policies to ensure the safe deployment of 5G technology and we're simply asking the US government to do the same. Otherwise, the radio altimeters on certain aircraft, which provide information to other safety systems like autopilot, heads-up displays, terrain warning and pitch control, will be compromised and will result in significant restrictions on 787s, 777s, 737s and regional aircraft in major cities like Houston, Newark, Los Angeles, San Francisco and Chicago. Unfortunately, this will result in not only hundreds of thousands of flight cancellations and disruptions for customers across the industry in 2022, but also the suspension of cargo flights into these

locations, causing a negative ripple-effect on an already fragile supply chain. We implore the Biden administration to act quickly and apply the same common sense solutions here that have clearly worked so well around the world.

#### Refunds - Europe Flights - Enrolled Friends Torgy's Travel Tips - March 2022



Refunds are rarely easy to get in the topsy-turvy world of travel these days. At the beginning of the pandemic in 2020, many travel companies and airlines relaxed their traditionally strict rules regarding refunds and/or change fees. Some customers availed themselves of the opportunity to rebook at a later time with no penalty. Others waited for the

tour operator or airline to notify them that their trip was canceled which provided, in most cases, a full refund. Now, we are two years into this ever evolving Covid-19 ordeal and I am seeing the emergence of stricter rules and under-the-radar changes to the fine print. Beware! A case in point involves a couple who booked a tour in 2020 to Normandy, France. The tour got postponed and canceled twice by the tour operator. To be fair, because of Covid restrictions in France it was not the tour operator's fault. The customer finally decided to give up waiting for the tour in late 2021 and requested a full refund. Sounds like a no-brainer, right? Unfortunately, in 2022 the tour operator changed their policy and only offered a credit, good for a future booking, not a refund. Referencing a sentence from their Terms and Conditions, they responded with the sentence, "We reserve the right to cancel or shorten a trip or cruise without notice. Any applicable refunds will be returned to you in a manner to be determined by the Company, including, but not limited to, credit for future travel." The savvy customer looked up their original paperwork and found that the Terms and Conditions when they booked the tour in 2020 did not include the above sentence. The tour operator eventually relented when forced to honor the original terms and issued a refund, less a \$300 cancellation fee. The moral of the story: Always read the fine print, keep a copy of all paperwork with the dates clearly visible and pay by credit card.

Flight refunds in the US are generally refunded to the original form of payment, but in Europe, that is not the case. Let's say you have a flight on Air France between Paris and London and it gets cancelled. You decide to take the "Chunnel" instead of waiting till a seat opens up on another flight. Air France may ask for your bank account information to process the refund regardless if you

paid by credit card. That is legal in the EU and generally is the way most involuntary refunds are processed in Europe.

Speaking of Europe, it appears that many flights within Europe are flying nearly empty yet they continue to operate because of strict EU regulations regarding long term take-off and landing slots. Pre-pandemic, airlines had to use 80% of their slots in order to keep these coveted assets. That slot usage percentage dropped to 50% in early 2021 but will increase to 64% this spring. The Covid crisis is still affecting bookings so the inventory goes unsold. This just wants to make you start packing your bags and use a ZED fare doesn't it?

And my last tidbit this month concerns managing your Enrolled Friends list on FlyingTogether. We all know that as retirees we can have 2 active Enrolled Friends. When you replace a friend during the appropriate open period, the old name falls onto the Inactive List. The system retains a maximum of 4 names on the Inactive List. Eventually you could run into a problem when you attempt to enroll a brand new name but your Inactive List is full. No worries - just go to the Inactive List, highlight an old name and "delete". That will open up a slot for the current active name to fall into and you can then add the brand new name.



Wardle initially created the game for himself and his partner to play, eventually making it public in October 2021. Google has even created a special Google Doodle when one searches for "Wordle", with the site's logo becoming an animated game of Wordle to find the word "Google."

The game was purchased by The New York Times Company in January 2022 for an undisclosed seven-figure sum, with plans to "initially keep it free for all players." Fans expressed worries that the acquisition meant the game would eventually be put behind a paywall. As the game operates entirely using client-side code run in the browser, download the webpage and bookmark it for offline use so you can continue to play the game for free. This will be a series of quarters featuring notable women in U.S. history, commemorating the centennial of the Nineteenth Amendment to the United States Constitution, which granted women the right to vote. The United States Mint will issue up to five designs each year from 2022 to 2025 for up to 20 total designs. The distinguished American women celebrated on the 2022 quarters will be:

- 1. Maya Angelou celebrated writer, performer, and social activist.
- 2. Dr. Sally Ride physicist, astronaut, educator, and first American woman in space.
- 3. Wilma Mankiller first female principal chief of the Cherokee Nation.
- 4. Nina Otero-Warren a leader in New Mexico's suffrage movement and the first female superintendent of Santa Fe public schools.
- 5. Anna May Wong first Chinese American film star in Hollywood.

On January 5, 2022, we learned that our Hangtown Miners president, **Bill Dinette** passed away. Rudy filled all of us in on what happened. Going back to July of last year, Bill started having stomach issues. There were a number of various visits with doctors. A colonoscopy was scheduled but they were not able to do the procedure. Bill continued to have pain and problems. In December he wound up undergoing emergency surgery to correct a hernia that was pinching a portion of his intestines and making the intestines twisted - thus causing the abdominal pain. Bill was in the hospital a bit longer than expected, but was finally allowed to go home with oxygen.

Back in the 60's, Bill was in the Air Force and worked as a crew chief on a weather reconnaissance plane - he was chasing things like hurricanes! He was then reassigned to a helicopter and based in Thailand/Vietnam. His helicopter was outfitted with spray rigging to be used with Agent Orange. In later years, it was determined that he had lost 20% of his lung capacity due to that chemical which forms crystals in the lung. Bill had been going to the VA for breathing problems, but every year his lungs just got worse. What happens with this is that the lungs lose their flexibility so they can't flex properly/efficiently and a person's oxygen absorption drops.

Bill was home (with the oxygen) when he began having severe difficulty breathing and the family took him back to ER. A couple days after being readmitted to the

hospital, Bill stopped breathing. It was about 15 - 20 minutes before they could get him onto a ventilator. Tests showed that there was too much brain damage due to the lack of oxygen and Bill was removed from the ventilator.

Roy Martin shared that he and Bill spoke mid-December while Bill was in the hospital. Bill was told that there was a 40% chance for him to recover and he figured that was better than nothing! Even though he knew he was in "trouble", Bill kept his upbeat attitude. We don't have any information yet on services for Bill. Linda, Aaron and Kevin will let us know when and where.

For general information, a discussion began and JR Heier shared some information for those who have military benefits. If you served in any of our armed forces, you can take advantage of the veterans' final services program. We moved on to important date in history for January 26th, a short summary follows. In 66 the 5<sup>th</sup> recorded passage of Halley's Comet, 1784 Ben Franklin is unhappy that eagle has become America's symbol instead of the turkey, 1837 Michigan became a state, 1871 US income tax is repealed, 1905 world largest diamond found in South Africa the Cullinan 3,106 carats, 1911 Glenn Curtiss pilots the first hydroplane in San Diego, 1926 first TV demonstration in London, 1954 ground breaking for Disneyland, 1956 Buddy Holly's first recording session, 1960 Oakland enters the American Football League, and in 1972, Vesna Vulović survives a 33,000 foot fall without a parachute.



Vesna's story is truly incredible. Vesna Vulović (January 3, 1950 – December 23, 2016) was a Serbian flight attendant who holds the Guinness world record for surviving the highest fall without a parachute: 10,160 m (33,330 ft; 6.31 mi). She was the sole survivor after a briefcase bomb exploded in the baggage compartment of JAT Flight 367 on January 26, 1972, causing it to crash near Srbská Kamenice, Czechoslovakia. The Yugoslav authorities suspected that Croatian nationalists were to blame, but no one was ever arrested.

Following the bombing, Vulović spent days in a coma and was hospitalized for several months. She suffered a fractured skull, three broken vertebrae, broken legs, broken ribs, and a fractured pelvis. These injuries resulted in her being temporarily paralyzed from the waist down. She made an almost complete recovery but continued to walk with a limp. Vulović had no memory of the incident and had no qualms about flying in the aftermath of the crash. Despite her willingness to resume work as a flight attendant, JAT Airways (JAT) gave her a desk job negotiating freight contracts, feeling her presence on flights would attract too much publicity. Vulović became a celebrity in Yugoslavia and was deemed a national hero.

Flight 367 departed from Stockholm Arlanda Airport at 1:30 p.m. on January 26. The aircraft, a McDonnell

Douglas DC-9, landed at Copenhagen Airport at 2:30 p.m., whereupon Vulović and her colleagues boarded the plane. "As it was late, we were in the terminal and saw it park," Vulović said. "I saw all the passengers and crew deplane. One man seemed terribly annoyed. It was not only me that noticed him either. Other crew members saw him, as did the station manager in Copenhagen. I think it was the man who put the bomb in the baggage. I think he had checked in a bag in Stockholm, got off in Copenhagen and never reboarded the flight."

Flight 367 departed from Copenhagen Airport at 3:15 p.m. At 4:01 p.m., an explosion tore through the DC-9's baggage compartment. The explosion caused the aircraft to break apart over the Czechoslovak village of Srbská Kamenice. Vulović was the only survivor of the 28 passengers and crew. She was discovered by villager Bruno Honke, who heard her screaming amid the wreckage. Her turquoise uniform was covered in blood and her 3-inch (76 mm) stiletto heels had been torn off by the force of the impact; Honke had been a medic during World War II and was able to keep her alive until rescuers arrived.

Air safety investigators attributed Vulović's survival to her being trapped by a food cart in the DC-9's fuselage as it broke away from the rest of the aircraft and plummeted towards the ground. When the cabin depressurized, the passengers and other flight crew were blown out of the aircraft and fell to their deaths. Investigators believed that the fuselage, with Vulović pinned inside, landed at an angle in a heavily wooded and snow-covered mountainside, which cushioned the impact. Vulović' physicians concluded that her history of low blood pressure caused her to pass out quickly after the cabin depressurized and kept her heart from bursting on impact. Vulović said that she was aware of her low blood pressure before applying to become a flight attendant and knew that it would result in her failing her medical examination, but she drank an excessive amount of coffee beforehand and was accepted.

There is a lot more to her story if you are interested, just Google Vesna Vulovic.

President Dave continued with some industry news. The 'big' item is that Retiree Parking Returns to SFO MOC. Retiree parking at the MOC has returned with some conditions. First you must have retired from the MOC secondly there is a 14 day time limit on parking. To extend beyond the 14 days you need to contact the security supervisor at 650-874-5718. Permit can be obtained from security at the main entrance by the flag poles. The permit can be obtained after hours by calling security on the phone outside of the main entrance. They will send someone to give the permit. For more information you can call security at (653) 874-3010.

The U.S. air transport system would grind to a halt, stranding tens of thousands of passengers all over the world and further disrupting the supply chain by critically disrupting cargo. At least, that's what the airline industry predicted would happen if AT&T and Verizon pressed ahead with their 5G wireless networks. The telecommunications companies agreed – grudgingly - to a further delay

to let the FAA and the aviation sector work out where interference with radio altimeters might occur and on what aircraft. By the end of last week, most aircraft types and major airports had been cleared, so the crisis was averted, partially. Regional airlines still don't have clarity on much of the smaller airports they operate to and on certain fleet types. So now, the U.S. has a mostly functioning air transport system, but slower mobile internet.

IATA warns high jet fuel prices will push in airline operating costs. In October of 2021 jet fuel was going for \$77.8 a barrel; on January 21, 2022 it was up to \$101.1 a barrel.

Since there was only one birthday for the attendees in January there was no birthday "roll-off" and **Angie Dellinger** was a few dollars richer.


Anniversaries for the month are **Keith & Ann Olthof** and **Dave & Robin Garland**. Congratulations!

Following is another installment of "It Happened To Me – The Big Boom" by Mal Malesardi.

In 1979, as a young mechanic at JFK, I was on the midnight shift. Before going home, I was offered overtime to go out on an engine run. This was for a repair and confirmation of the repair. It was a DC-8 that had an acceleration issue on the #2 engine.

This was going to be a chance to work with the early bird crew. They were on shift from 5am to 1 pm. Very senior and highly experienced. As always, working with them was a chance to learn something new. I told the supervisor, I'm IN.

Then I was instructed to get a tractor and towbar and hook it up. The early birds came out and we pushed the airplane out of the hangar and over to the blast fence. I was then told to get 12 chocks. When he saw my amazement, they said, we have to take #2 engine on an acceleration check to take off. It has to get to takeoff in so many seconds and we don't want the airplane moving. All main and nose gears chocked.

After we were all set up with 2 mechanics in the cockpit, along with me and a supervisor on the ground, a long headset cord was installed to have instant eye contact.

This was for hand signals in case of any problem and could be seen directly out the front windows. Because the DC-8 had to be fully supported (air and electric), the engine was started and equipment was removed. I gave the OK to accelerate to takeoff.

We proceeded with a quick spool up and then, what happened next was the most bone shaking "boom" I have ever experienced, followed by a flame coming out the back of the engine that hit the blast fence and went down into the rental car parking lot on the other side.

With the engine shut down, the team said to tow it back in the hangar and setup for the engine change. After getting a stand up to get the run crew off, they said, "That was pretty loud, wasn't it?" I said "Dad that was the loudest sound I've ever heard". Yes, the mechanic in the left seat was my father. We didn't have to paint any rental cars either.

What brought this memory back was after watching the "Dog Day Afternoon" movie. This movie was based on a true story from a bank robbery gone bad in Brooklyn. The movie was filmed in 1975 and has a scene of the police escort driving down the Belt Parkway at night. The camera was elevated on the airport and shot across hangar 8 and the ramp where this occurred. In the scene are 2 DC-8 (freighters) parked on the freight side of the hangar.

I had the pleasure of working with my father for one year. When I stayed overtime, I would occasionally work with him. Great experience, great memories. Not only did this happen to me, it happened to <u>us</u>.

The scholarship funds are distributed through four partner organizations: The Latino Pilots Association, Organization of Black Aerospace Professionals, Professional Asian Pilots Association, and the Sisters of the Skies. Once these students get their Private Pilots License, that should take about a year, then they can interview for Aviate, the flight training, at United, only one of three training campuses in the U.S. If a person already has his/her PPL, they can apply immediately to Aviate. Then the cost starts at \$18k for private pilot training, \$18k for Instrument Rating, and more depending how much training is wanted and needed. Then they will be ready for the 'big jet' training and applying at United Express, for a start. More years of training involved, this is not easy, not 1-2-3 poof, you're a pilot. 

Normandy Cemetery in France ~ Of the many places Violet and I visited, Holland and the beaches of Normandy in France were always high on our priority list. Holland is special because all of Violet's family was still there with

the exception of her mother, father, and her younger sister Sadie. Traveling in Holland has always been a pleasure. You can speak of its great ports of Amsterdam Rotterdam, its priceless art museums, its canals and waterways, and its magnificent fields of tulips; but in reality, it's the people. Wherever you go, whenever you needed assistance for anything, there was always a smile and speaking in Dutch saying, I can help. The fact that Violet could speak the language fluently helped a lot, but nothing can take away from the good-natured and friendliness of the Hollanders. One other thing, besides the great food, their cheese is still the best, at least as far as I can see, they just make it better.

After our visit as always, we drove from Holland through Belgium into France along the Normandy coast, on our way to the great American Cemetery at St. Laurient St. Mer. That is where my brother Harold who was seven years older than me is buried. I speak of this still with much heartache, even though it has been more than 70 years since my mother was notified that he was killed in action near St. Mer, Eglis, he was only 22. He was with the 79<sup>th</sup> division, and the 315<sup>th</sup> infantry Regiment. Joining the Army in January 1942 shortly after Pearl Harbor, we only saw him twice until he went overseas to prepare for the Normandy invasion. On June 25, 1944 he was reported killed in action. Visiting the cemetery has always been a solemn occasion. As you enter it you can't help feeling a reverential quietness that comes over you as you begin to understand the immense sacrifice by the American army as you move between the crosses and the stars of David.

I always thought it was peculiar that the names on the grave markers didn't face the entrance. I was told by the administration that was deliberate; they wanted all the names to face across the ocean so that a grateful nation will never forget what they did here. On one end of the cemetery, there is a large tile mosaic that explains how the invasion took place; on the other end, there is a small memorial chapel that overlooks "the beach". Inside it says "think not of their passing but remember the glory of their spirit". Nothing says it better.

I have often wondered how my life would have been affected had my brother lived, fate sometimes takes a strange twist. As I reach the twilight of my life, memories of my brother grow dim, still I weep silently for a life that could have been.



Any really smart people know anything about this or how to read it. The text below is what I found on Google.



# A closed circuit TV system was part of the DC-8 Flight Simulator which Link Aviation installed at DENTK.

The system included an accurately scaled 3-D model of terrain and an airport. A camera mounted on a track parallel to the model displayed a picture on the DC-8 simulator screen.

Movement of the cameral was synchronized with the speed, altitude and direction as determined by the pilot's use of controls.

Specifications of the training aid were developed by Douglas Aircraft Company.

The equipment was known as the Link Visual System, Mark IV.
