'How Fa Na' Lagos December 1, 2021



Recently, we inaugurated our new nonstop service to LOS (Lagos, Nigeria) from IAD, marking our official return to the country, which we previously served until 2016. The flight will be operated

three times weekly on a Boeing 787.

IAD-LOS builds on our expansion to Africa and solidifies the leadership position we have taken from Africa to the U.S. Earlier this year, we launched new service between JNB (Johannesburg, South Africa) and EWR, and between ACC (Accra, Ghana) and IAD. This December and upcoming January, we will increase our ACC service from three weekly flights to daily. This month, we will also resume nonstop service between CPT (Cape Town, South Africa) and EWR.

"Our new flight to Lagos reinforces our ongoing commitment to growing our network in Africa and providing more convenient service to the destinations our customers want to fly to most," said International Network Planning and Alliances SVP Patrick Quayle. "This highly anticipated service will provide a key gateway between Lagos and Washington D.C., as well as easy one-stop connections to almost 80 destinations across the Americas, including Houston and Chicago."

This exciting initiative further expands our economic relationship, promotes people-to-people ties, and creates new opportunities for United, travel companies, and customers alike, added U.S. Ambassador to Nigeria Mary Beth Leonard.

This route launch was commemorated with gate celebrations at IAD and LOS.

The first airline in aviation history ... December 1, 2021

To fly an aircraft with passengers using 100% sustainable aviation fuel (SAF). That's right! On December 1st, 2021; we operated Flight 2701 with

100% SAF, marking a turning point in the industry's effort to reduce the rate of climate change.

The flight – on our new 737 MAX 8 – will depart with 115 passengers from ORD to DCA (Reagan Washington National) and will use 500 gallons of SAF in one engine and the same amount of conventional jet fuel in the other engine to further prove there are no operational differences between the two. We hope this will set the stage for more scalable uses of SAF by all airlines in the future. Currently, airlines are only permitted to use a maximum of 50% SAF on board. The SAF used on today's flight is drop-in ready and compatible with existing aircraft fleets.

Scott will be on board the flight, alongside executives from flight partner companies Boeing, GE Aviation, Virent and World Energy, all of whose technology enables 100% drop-in SAF.

"United continues to lead from the front when it comes to climate change actions," said Scott. "Today's SAF flight is not only a significant milestone for efforts to de-carbonize our industry, but when combined with the surge in industry commitments to produce and purchase alternative fuels, we're demonstrating the scalable and impactful way companies can join together and play a role in addressing the biggest challenge of our lifetimes."

Sheila Remes, Boeing Vice President of Environmental Sustainability, added, "Boeing is proud to support United on this historic event as we work together to make aviation more sustainable. As an industry, we are committed to addressing climate change, and sustainable aviation fuels are the most measurable solution to reduce aviation carbon emissions in the coming decades. No one entity can decarbonize aviation alone and it will require partnerships like this to ensure aviation is safe and sustainable for future generations."

Did you know? We are the world leader in the usage

and development of SAF, an alternative fuel made with non-petroleum feedstocks. We have also signed a conditional agreement to purchase one-and-a-half times the size of the known purchases of all global airlines combined — we are surpassing all airlines, including ourselves!

According to the U.S. Department of Energy, SAF has the potential to deliver the performance of petroleum-based jet fuel but with a fraction of its carbon footprint, and the country's vast feedstock resources are enough to meet the projected fuel demand of the entire U.S. aviation industry. Talk about a game changer.

The SAF flight and new Eco-Skies Alliance participants are among the latest accomplishments under our goal to go 100% green by reducing our greenhouse gas emissions by 100% by 2050, without relying on traditional carbon offsets.

Arlington Heights facility to become primary NOC December 3, 2021



Effective April 1, 2022, we will relocate our primary Network Operations Center (NOC) to Arlington Heights, IL, and the NOC in Chicago will become the backup NOC (BNOC) at that time.

The Arlington Heights facility offers crucial advantages, particularly the ability to support the anticipated growth of our airline given the facility's larger size and potential for expansion.

Network Operations Managing Director David Kensick announced the changes to his team on Thursday morning. We've been running split teams at both NOC facilities to prevent severe impact to our operation in the event of an outbreak of illness throughout much of the pandemic. In deploying those solutions, we recognized the benefits a dedicated space like the Arlington Heights facility provides as a primary location. It has operated as our backup facility since fall 2020 and offers some distinct advantages, including enhanced power redundancies from two backup generators. It can even withstand an F2-level tornado.

We remain committed to the city of Chicago – at our headquarters we continue to invest in reinvented workspaces for our Chicago-based teams. This includes substantial investments at Willis Tower, from the 4th floor outdoor terrace to new collaboration space, enhanced virtual and in-person conference capabilities, and upgraded building amenities.

Certain Network Operations functions, as well as David, will remain based at Willis.



CommutAir ERJ-145s getting interior makeovers December 6, 2021



Be on the lookout for a bright, clean new look in the cabins of the Embraer ERJ-145 aircraft on United Express flights operated by our partner CommutAir (C5).

In November, the first com-

pleted aircraft re-entered service after an expansive interior refresh. The reimagined interior of the 50-seat jet will be an exciting change for crew members and passengers alike. Updates include new LED cabin light and passenger reading lights, a redesigned lavatory and new sidewalls, overhead bins, and bulkhead finishes.

Congratulations to the many teams involved in the project as the refresh marks a welcome improvement for our customers and enhances cabin consistency across the United brand.

"United is committed to elevating the customer experience for all travelers flying in our small communities," said Domestic Planning and UAX SVP Ankit Gupta. "We're excited to support CommutAir's efforts to enhance their fleet of ERJ-145 aircraft as they truly complement United's investments to provide more travelers with the modern amenities that matter most to them."

The majority of ERJ-145 interior refreshes are planned to be completed by the end of 2022. We hope you have a chance to experience the new interiors while traveling in the coming months. CommutAir primarily flies out of our DEN, IAD and IAH hubs.

The Writers' Column – Profile Of A Hero, Marvin Olsen By Bob Duensing

Some time ago, I posted an essay that I wrote about a hero that I was fortunate enough to meet. On this 80th anniversary of the beginning of WWII, I would like to repost the essay so that all generations are aware of the sacrifices that this particular gentleman made along with the thousands and thousands of others to ensure your freedom today.

I never worked with **Marvin Olsen**. I met him at a United Airlines retiree Christmas luncheon. His story was so interesting that I interviewed him and wrote about him.

Marvin was a farm boy that grew up in the Arkansas River valley in southern Colorado and joined the Army Air Corps after graduating high school and before WWII began. The army trained him to be an aircraft mechanic.

He was at Pearl Harbor (Hickam Field) on December 7th, 1941 and witnessed the attack. During the attack, a bomb exploded near him and the shrapnel from the explosion wounded him. He was hospitalized for several months.

After recovering and still carrying some shrapnel, he

was sent to Espiritu Santo in the New Hebrides Islands east of Australia. From there, he was sent to Guadalcanal in late 1942 where live fighting was still in progress. After a time, he contracted Malaria and was subsequently sent back to the United States.

Time passed and his Malaria symptoms subsided and he resumed active duty. Since Marvin had already served in combat, he was given the option of staying in the U.S. However, he chose to enter harm's way once again. That speaks volumes about Marvin's character.

The newly produced B29 bomber had been recently placed in service and Marvin became a Crew Chief on the Mary K. They left the US and arrived at their new base just north of Calcutta, India. From that base, Marvin and the Mary K. flew combat missions across the Himalaya Mountains to areas of China, Burma and Indo China.

After a time, a landing strip was built in China and that put them in range of Japan, Formosa (Taiwan) and Shanghai. Marvin flew many combat missions from that base.

After the war ended in 1945, Marvin left the military where he had risen from Private to Master Sergeant. In civilian life he joined United Airlines in Denver, Colorado and spent 39+ years with the company.

Marvin was a true patriot and a shining example of the "Greatest Generation".

Marvin has left us. He was 99.

<u>Stranger Than Truth</u> ~ As a young mechanic at LGA, with less than a month with United, I had a strange encounter.

On the midnight shift, the lead gave me an overnight check on a Braniff 727. These were new airplanes and other than fluid services, or a tire or brake change, there were few gripes.

He said to take the check sheet and take your time, "You can familiarize yourself with the aircraft, it's in the hangar and well lit. This will make you more confident doing the check alone."

Off I go to the hangar and realize I am the only mechanic in there. After a while, I decide to go to the bathroom. The bathroom was located outside the hangar bay. To get there, you had to walk through a room with an industrial washer and dryer; these were used by the cleaners to wash and dry their mop heads and cloths.

As I enter the washer and dryer area, the machines are going and I thought there were cleaners there. I then notice a naked man leaning against the washer. Starting to back up, he tells me "It's OK". I responded, "I'm not so sure". Then I got on a tractor and drove to the terminal. Now to put this in perspective, this is June 1978, there are no door locks, no badges, you can go anywhere.

As I go into the leads area, he says, "Oh you're done?". "Not really", I respond. "There is a naked man

standing in the wash area". "Oh, that's just John Smith (name changed). He got divorced and only has one pair of clothes. While his clothes wash, he has to stand there naked until they are done". The way he said it, this was a normal occurrence. "Oh", I said. "I'll just go to the bathroom here and go back and finish the check".

Yes, this really did happen to me.

 $\underline{\textit{Heat or Cool}} \sim \text{This story did not happen to me personally.}$ It was related to me as a displaced mechanic in LAX.

There were two DC-8 freighters that were unable to continue to their destinations, due to weather. While they were delayed, conditioned air was needed. One had live animals and the other had strawberries. A mechanic was dispatched to put a heater truck on the animals and an air conditioning truck on the strawberries.

As the delays to both aircrafts got longer, the units were fueled and reconnected. They are finally cleared to go and then it is discovered that the units were reversed. This resulted in rotten strawberries and freezing animals.

This story stays in my memory, as my daughters liked to hear it often. Also, when their friends were over, they would like me to tell it to them. One of those stories that I'm glad did not happen to me.





This is a cruise to experience glaciers, fjords, inlets, rivers, streams and wildlife galore. You will sail the Inside Passage, visit Ketchikan and Juneau, cruise Tracy Arm, visit Icy Strait Point, cruise Glacier Bay, visit Skagway and Sitka, and cruise the Misty Fjords and Inside Passage again on the return. You can view all the info on this cruise on the Holland America website at www.hollandamerica.com. In the destination box, select Alaska & Yukon, in the duration box select 9-16 days, and in the departure box select Vancouver. This cruise will be the last one on page 2. Also, as Rich says, this cruise is open to all - friends and family, flight attendants and RUAEA members. The more the merrier and the greater our group discount!

Lake Tahoe is a world famous natural gem right in our own backyard. Google "Lake Tahoe" and up pops a plethora of fascinating information. About three million people visit Lake Tahoe each year. This is comparable to the number of visitors to Grand Canyon National Park (3.2 million) and Yellowstone National Park (2.7million). The surface of the lake is at 6,225 feet above sea level. A maximum depth of 1,645 feet in Crystal Bay makes Tahoe the second deepest lake in the USA, third deepest in North America and 11th deepest in the world. Lake Tahoe is over 2-3 million years old. Tahoe is considered an ancient lake and is counted among the 20 oldest lakes in the world. The year-round resident population is 66,000. Total population can reach 300,000 on peak days.

Due to the ongoing drought, Lake Tahoe's water levels are a cause for concern. The lake is considered full when water levels are roughly 6 feet above the natural rim. Prior to the October 24 storm, the water level was one inch below the natural rim of the basin. When the level drops below the rim, the lake is no longer connected to the Truckee River, its only outlet. During the October 24 storm, water levels at the Tahoe City dam rose almost 6 inches in 24 hours. Although water levels are now five inches above the natural rim, the lake is still far from full.

Lake Tahoe is known for its water clarity. However, the lake is about 40% less clear than it was 50 years ago. Visibility was 63 feet in 2020 compared to more than 100 feet in 1968. The main culprits are sewage, runoff and fertilizer. In spite of this, the water is 99.994% pure, making it one of the purest large lakes in the world. For comparison, commercially distilled water is 99.998% pure.

Lake Cleanup ~ In May, the nonprofit Clean Up the Lake began removing trash from the water along Tahoe's entire 72 miles of shoreline. Growing interest in protecting the environment can be seen in the public support the project has received. Over 300 certified scuba divers applied to participate and hundreds of other people volunteered to help in whatever way possible. Another nonprofit, the Tahoe Fund, raised \$250,000 for the project. Tahoe Blue Vodka offered a donation match up to \$100,000 and that amount was reached and surpassed in just 10 days.

A team of staff and volunteers is scooping up trash from the water's edge to depths up to 25 feet. The group plans to collect trash three days a week, with the goal of covering one mile of shoreline per day. Scuba divers comb the lakebed for trash and put smaller pieces like aluminum cans and clothing in mesh bags. Larger items like tires are hoisted to the surface with help from vessels above. Debris too heavy to be lifted by humans are marked with a GPS coordinate and removed later with the proper machinery.

Once the trash is plucked from the water, every single piece is being counted and classified into 77 different categories—wood, rubber, construction materials,

clothing etc. This information will be used in future ad campaigns to reduce dumping in the lake. As of November 12, the team had cleaned up 44 of the 72 miles around the lake. They have collected more than 18,000 pounds of trash, including a diamond-studded engagement ring, a BB gun, cell phones and vape pens, poker chips and a stapler. The project has been delayed somewhat because of the Caldor Fire and wildfire smoke.

The World Health Organization decided to use Greek letters to avoid public confusion or cause offense to any cultural, regional or ethnic groups. The previous practice of naming a variant after the place where it was detected was deemed "stigmatizing and discriminatory." Variants are named in alphabetical order as they are discovered. Variants of Concern are those that may be more contagious than the original COVID-19 strain and appear to cause more severe symptoms and deaths. There are now five variants that have risen to Variants of Concern: Alpha, Beta, Gamma, Delta and Omicron. Alpha emerged in the United Kingdom, Beta in South Africa, Gamma in Brazil, Delta in India and Omicron in South Africa. Variants of Interest are those that have caused "significant community transmission" or multiple COVID-19 clusters in multiple countries. WHO has identified two Variants of Interest: Lambda (Peru) and Mu (Colombia). Two letters before Omicron were skipped. Nu is too easily confused with "new." Xi was skipped because it is a common Chinese name, particularly in deference to Chinese president Xi Jinping. With 42 members and guests attending, I could not



What is the Charles Taylor Award?

Charles Taylor Master Mechanic Award ~ The Charles Taylor Master Mechanic Award is named in honor of Mr. Charles Taylor, the first aviation mechanic in powered flight. The Charles Taylor "Master Mechanic" Award recognizes the lifetime accomplishments of senior mechanics. Mr. Taylor served as the Wright brothers' mechanic and is credited with designing and building the engine for their first successful aircraft.

Eligibility: To be eligible for the Charles Taylor Master Mechanic Award, nominees must meet the following criteria:

- Hold a U.S. Civil Aviation Authority (CAA) or Federal Aviation Administration (FAA) mechanic or repairman certificate.
- Have 50 or more years of civil and military maintenance experience.
- ▲ Up to 20 years of the required 50 years may be U.S. military experience; or worked as an uncertified person in a U.S. aviation maintenance facility that maintained U.S. registered aircraft, either domestic or overseas; or worked as an uncertified person in the aircraft manufacturing industry in the United States, producing U.S. type-certificated or U.S. military aircraft. The 50 years may be computed consecutively or

- non-consecutively.
- ▲ Be a U.S. citizen.
- ★ Have <u>not</u> had any airman certificate revoked. Revocation of any airman certificate will disqualify a nominee for this award.

Our RUAEA National President and local Chapter President, **Don Burbank**, received this award in July of 2013. There are many other recipients and we want to express our gratitude for a job well done!
