

Alliant Closes Branches, Provides Increased Flexibility through Digital and Phone Banking

Starting in July and ending in October, Alliant Credit Union will be closing most of our branches as part of our continued evolu-

tion to digital banking. We'll continue to provide great rates and superior service to members all over the country, and our members will have 24/7 account access via

mobile, online and phone banking. Alliant's West Touhy Avenue branch, near our headquarters in Chicago, will remain open and fully operational.

Why Alliant is Closing Branches ~ As we examined the low and declining use of our branches, compared to the cost of operating them, we concluded that it was not in the collective interests of our member-owners – the vast majority of whom don't have access to or use branches – to keep them open. Today, nearly all of our members' banking interactions occur online and by phone; fewer than 4% of transactions take place in Alliant branches. By closing branches, we will be able to maintain Alliant's market-leading deposit and loan rates while redeploying resources to enhance online and phone services.

We understand that this change will inconvenience some members who prefer to do their banking in person at a branch. However, we believe it is the right decision for our membership overall.

Without Branches, How Do I Bank with Alliant?

As an Alliant member, you will still have access to multiple easy and convenient ways to manage your accounts and make transactions:

- **Need to make a deposit?** Use our mobile banking app or visit a deposit-taking ATM.
- **Want to pay an Alliant loan or credit card?** Set up a transfer in mobile or online banking, call us, or mail a check.
- **Need to access your cash?** Visit an ATM. We have more than 80,000 in-network ATMs across the country, and Alliant Free Checking Account holders also can receive up to \$20 per month in ATM fee rebates.
- **Want to meet with your Alliant Financial Advisor?** Our financial consultants will still be available locally to assist their Alliant Retirement and Investment Services (ARIS) clients. If you participate in the ARIS program, you should have already received communication from your financial advisor about your ongoing partnership.

If you can see it, you can change it: **How data visualization is keeping us safer**



June is National Safety Month and we're highlighting people, activities and initiatives that remind us about the importance of living and working safely, 24/7/365.

Picture this: In a world of exponential growth in new technologies, expectations of up-to-the-minute information and universes of complex data, companies are always looking for ways to better organize, analyze and decipher the facts about their businesses. Enter data visualization.

Data visualization creates a visual display of the data patterns more traditionally found in statistical graphs and charts, allowing users to see pictures that boil down at a glance overwhelming amounts of data.

Since 2016, United has been using a data visualization model created by its Corporate Safety team in collaboration with its operational groups and college interns from the University of New Haven. Through the end of last year, United has seen a 25 percent reduction in aircraft damage and a 13 percent reduction in injuries overall, culminating in United's best-ever injury and damage performance.


Data visualization makes it easy for departments, operating groups and locations to identify where different types of injuries or aircraft damages have a likelihood of occurring, so the company can focus on avoiding them.

The tool earned United a Green Cross for Safety Innovation Award from the National Safety Council and established United as a pioneer in data visualization in the aviation industry, but its use isn't limited to safety statistics.

Teams across United have adopted the data visualization model to tackle problems or deepen the understanding of a range of issues - from customer satisfaction scores and employee feedback to integrated safety management systems, Tech Ops performance metrics, fuel planning and even United's MileagePlus loyalty program.

Below are four areas in which United is working to target safety improvements.

1. Jet bridge reliability ~ Last year, Corporate



Safety teamed up with the Tech Ops Facilities team to visualize all of the data from the Fleet Focus system.

As a result, the Tech Ops team can now monitor preventative maintenance execution, identify chronically out-of-service gates and even see in real time which gates have out of service jetbridges. This helps expedite investments to repair or replace jetbridges across the system, reducing "problem" areas and providing new, more reliable equipment.

2. Safety Performance Indicators (SPIs) ~ Visualizing data on employee injuries and aircraft damages allows users to dig into the data and identify trends in injuries and damages and also to track their reductions or increases over time. The tool helps pinpoint injury trends, helping United develop action plans to try to prevent or reduce those injuries. For damages, United can also see where they occur on the aircraft, which type of aircraft are involved and at which locations, etc. All this information is compiled and shared with station leaders on a weekly basis by operating group and location, helping target and reduce risks.

3. Hearing conservation ~ Some of United's front-line employees are exposed to loud



noise at work, potentially exposing them to a greater risk of hearing loss.

United's data visualization tool helps the company better manage the audiometric testing process by providing more analysis, allowing stations to manage the testing process themselves and identifying employees at risk of hearing shifts. UA can also use the tool to track changes in employee hearing over time, allowing the company to recognize and address the

shifts in hearing more quickly. In addition the hearing conservation dashboard significantly reduces the processing time required to provide operating groups the status of all coworkers included in the hearing conservation program. This supports United's core4 values.

4. Wildlife strikes ~ Last year, United teamed up



with the United States Department of Agriculture, the centralized reporting mechanism for all wildlife strikes in the

U.S., to visualize that data across the country. To get a complete picture of the impact of bird strikes, the tool allows United to see the cost, out-of-service time, severity and frequency of birds sighted in a particular area. The result has been a partnership with the FAA Airports division to get the full scope of the most common areas for bird strikes, identifying solutions and analyzing how United is analyzing wildlife management.

Welcome Day brings employees and Special Olympics athletes together



The 2018 Special Olympics USA Games kicked off on July 1 with participants representing 49 United States taking part in Welcome Day ceremonies, presented by United.

As part of the weekend's festivities, Oscar joined a group of employees and retirees in greeting nearly 700

arriving athletes, coaches and volunteers at SEA (Seattle), as well as hundreds more at local light rail stations, all of which were decorated with United's Special Olympics superhero campaign banners. Oscar also had the honor of giving Special Olympics athlete Nikki Jones her first in person look at her superhero alter ego Lane Lightning, a moment that was captured on the video.

It was all the culmination of months of planning and preparation by members of our Community Affairs and SEA teams, led in part by SEA Customer Service Representative Lora Bolding and SEA Airport Operations Supervisor Sarah Piper, each of whom were on hand this weekend to root on the athletes. *"When the delegates come off the airplane they are just so excited because of all the cheering and the welcome,"* Lora said. *"It's a special time for them and for us."*

Joining the parade of athletes at the University of Washington's Husky Stadium on Sunday were SEA Line Technician Glenn Cluck, SEA United Club Cus-

tomter Service Representative Patti Bell and SEA Stations Operations Representatives Shannon Olstad and Laura Watts.

Laura was picked to walk with the representatives from her home state of Georgia, something she said she'd never forget. *"I was super excited to have an opportunity to participate in the Special Olympics this year and very proud that United played an integral part in this amazing event,"* she said afterward. *"Entering the stadium with the athletes was a once-in-a-lifetime experience."*

Pass traveling this summer?



Summer travel is here, which can mean busy airports and long lines for pass travelers. Here are some helpful tips to make pass travel just a bit easier.

Travel tips:

- ➔ Join MileagePlus now, and you'll be able to manage your pass travel and all of your United travel with the United app. Start earning miles and enjoying the rewards.
- ➔ Review the Pass Travel Attire policy before heading to the airport to ensure you're comfortable and within the rules.
- ➔ Remember, if you purchased a myUADiscount ticket, you may not cancel your confirmed reservation to revert to a space available listing on the same day, same trip.
- ➔ Purchase your interline tickets ahead of time for travel beyond the United network.
- ➔ Arrive early and anticipate long TSA security lines. Be patient and cooperate with TSA officers. And of course, make sure you're up to date on TSA rules and travel tips.

Don't forget that as United grows as an airline, it means more seats are available for pass travel. During the first quarter of 2018, United saw more non-revenue, space available travel than ever before. In fact, did you know that in April, 82% of pass riders who listed for a flight and checked in were awarded a seat? With all of the pass travel happening across the system this summer, it means United's front-line employees are working extra hard for all of us. Give them a big thank you the next time you travel.





Pay your travel invoice ~ If your taxable pass riders (domestic partner, enrolled friends) flew between February 1 to April 30, 2018, you should have received an invoice (Travel Liability Statement) from United. Do not forget to pay it! Failure to pay an invoice may result in a suspension of your pass travel privileges until the invoice is paid.

The first electronic flight simulator built to “fly” like a DC-6B was completed by the Curtiss-Wright Corporation and delivered to United at Chicago.

Designed to reproduce electronically all flight characteristics of 50 ton DC-6B Mainliners, the simulator was the third of four which United ordered in 1952 at a cost of more than \$3,000,000.

Two Mainliner Convair simulators were already in service at the company’s Flight Training Centers in Chicago and Denver. The fourth simulator, another DC-6B, was scheduled for completion shortly and was to be installed in Denver.

In addition to standard procedures, the devices enabled United to provide advanced types of Pilot Training seldom undertaken in actual aircraft. The simulators were the first to be purchased by a domestic airline and the largest number acquired by any airline.
