



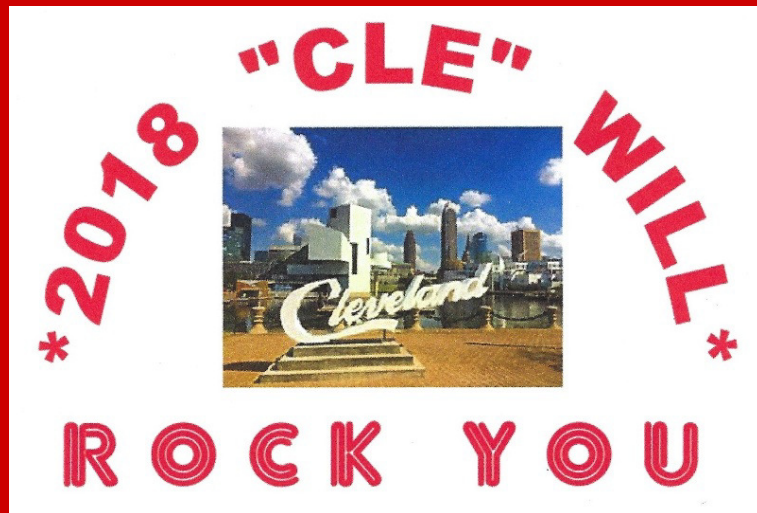

Hey all you baseball fans, we have something special for you. How about a trip to Progressive Field to watch the Central Division rivals, Chicago White Sox play our Cleveland Indians? We have arranged this added event (not seen on our tour schedule) for the game on September 20<sup>th</sup>, start time 7:10 P.M. at the CLE Progressive Field.

The Touch of Class Tour Bus will pick you up at the CLE Airport Marriott Hotel at W. 150<sup>th</sup> Street. We have arranged for the bus to make 2 round trips to the stadium from the hotel. One departure at 5:00 P.M. and the other one at 6:00 p.m. This should be an approximate 30 minute ride each way. Anyone arriving back to the hotel from the Amish Tour will have the 6:00 bus available for their departure to Progressive Field. The right field gate opens at 5:00 P.M. and the rest of the field opens at 6:00 P.M. We need a minimum of 20 people. Your cost for transportation will be \$13.00 round trip per person, with 56 riders. However, more riders can be accommodated.

Also available are discounted baseball tickets. They are offering a \$57.00 ticket for \$40.00. These seats are located in the lower box seat section behind first and third bases. There is also a \$22.00 ticket for \$19.00 in the Family Deck section behind center field. All seats will be reserved.

Please ensure you keep a copy for yourself. Also include the payment for your ticket, based on your seat location of choice and for your transportation. Your tickets will be added to your registration packet for pick up in CLE. Deadline to register is September 4<sup>th</sup>.

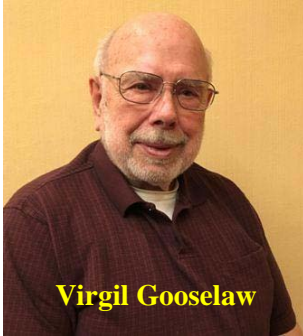

**Having Trouble Switching Enrolled Friends for July-December Flying?**  
**Here is help From Kirk Moore!**



Retirees may change their current Enrolled Friends for July-Dec flying by visiting their Dependent Management System (DMS) screen; access it via FT > Travel > "Manage pass riders". The enrollment period ends June 28<sup>th</sup> at 11:59 PM CT.

1. Can't register a new enrolled friend? You have 4 Enrolled Friends listed in your DMS. Before you can add a new EF you must first remove an "INACTIVE" EF by clicking the purple "i" button to the left of their name. Then click "Remove Dependent" on the screen appearing below. Now add a new EF to your DMS by clicking the blue "+" sign and follow the 5 steps to "certify" them.
2. To add or change your Enrolled Friends for July-December: On your DMS screen, click the "Manage Election" link next to any Enrolled Friend's name (far right) to view the Election page. Current Enrolled Friend(s) will already be checked for the next travel period. If you do not need to make any changes, no action is needed. Current EFs will automatically roll over on July 1. If you want to make changes for the next travel period you must:
  - a. Uncheck current Enrolled Friends in the Jul-Dec column (far right) to leave that slot open to name someone later.
  - b. Or put a check mark in the Jul-Dec column (far right) to any inactive EFs to fly July-December.
  - c. Or add new Enrolled Friends to an available slot by clicking the plus "+" sign.
  - d. Be sure to finish all the steps by clicking SAVE at the end of the process.
3. Don't know who you want as EFs for July-December yet? No problem, just uncheck your current EFs before June 28<sup>th</sup> at 11:59 PM CT; you may add Enrolled Friends to those empty slots later. Keep in mind that once a new travel period begins, your current Enrolled Friends that rolled over can be removed but cannot be replaced within the same travel period.

Remember: we only have two "current" Enrolled Friends at a time, but now we can change them twice per year. The next enrollment period for Jan – Jun 2019 Enrolled Friends opens Dec. 1 through Dec. 28. You'll follow the same steps by going to DMS and click on "Manage Election" next to any EF.

## Proposed Bylaw Changes To Be Voted on in September at the Convention

### **Bylaws**



Bylaw proposed changes: Article VIII Term of Office, Article VII Section 15 Corporate Relations and Section 8 Directors (Appointment to do the Arrears List).

Please note changes are bold type, in italics and underlined.

#### **ARTICLE VII Section 8 Directors (Elected)**

The Directors, in addition to such duties as the President may assign, shall participate as members of the Board of Directors in planning & controlling the affairs of RUAEA. They shall also provide liaison with individual members and their respective Chapters, give advice, disseminate information received concerning RUAEA and the Company (UA), and other items of interest. They shall counsel emerging groups, recruit new members and officers, and generally promote the growth and activities of RUAEA. The area of coverage for each Director will be determined and assigned by the Board of Directors. They will remain in contact with their respective Chapters at least once a year, if feasible, or more if deemed appropriate by the President.

**One Director shall be appointed to monitor the Arrears List that is published by the Membership Manager the first of each month. The Director shall send out a standard letter to any member in arrears stating that they have not paid their dues. (The monitoring of the Arrears List and action taken is an important task and must be consistently accomplished ASAP after the Membership Manager publishes the list)**

#### **ARTICLE VII Section 15 Corporate Relations (Appointed)**

The person/s responsible for Corporate Relations **and Communications**, will be the liaison/s between United Airlines and RUAEA, and will establish a close tie at the corporate level regarding retiree matters **and information disseminated to retirees**. Will provide information as to decisions that may affect RUAEA members and their benefits. The representative/s will be appointed by the President, with the advice and consent of the Board, and report to the President.

#### **ARTICLE VIII Term Of Office**

The term of office for all officers and directors shall be two (2) years and thereafter until their successors are installed. In an effort to maintain experience and continuity, no more than five (5) Regional Directors will be elected in any single year. A onetime change to the By-Laws to stagger the election of Executive Committee Members by voting in the 2017 Business Meeting to extend the term of the VP-Conventions and of the Treasurer for one additional year, with their terms expiring in September 2019. Thereafter, their terms shall be for two (2) years. With the concurrence of the Nominating Committee, officers and directors may run for continual terms. Officers and directors may be nominated, elected and serve in another office even though their current term has not expired. **Upon election to another office, the successful candidate may continue to serve in his/her current office or another office, thus holding multiple offices concurrently, with the recommendation of the Nominating Committee and approval of the Board of Directors.**

### **Invoices For Taxable Pass Travel From February 1, 2018, through April 30, 2018**

Dear United retiree,

At the end of 2017, we began to collect any federal and state withholding taxes that apply to your pass travel income via quarterly invoices. The next invoice will be sent in June for any taxable pass travel from February 1, 2018, through April 30, 2018. Keep in mind, if you do not have any taxable pass travel during a particular fiscal quarter, you will not receive an invoice.

If your eligible taxable pass riders have completed pass travel, you will receive a quarterly invoice via the U.S. Postal Service to the mailing address United has on file. These invoices will request payment of the calculated withholding tax. You will need to pay the invoiced amount by check or money order to the address specified on the invoice, be sure to include your payment coupon from your invoice to ensure timely posting of your payment. Failure to pay an invoice may result in a suspension of your pass travel privileges until the invoice is paid.

It's very important that your mailing address is up to date. If you want to verify or make a change, use the "Update Mailing Address" link in the Detail Summary section of the Dependent Management page. Note: You



will be redirected to the Your Benefits Resources website to enter your changes. See the [W-2 pass travel tax reporting and billing](#) user guide to learn more.

### **Changes coming to Mexico service**



Over the last decade, United has doubled its capacity between the U.S. and Mexico, adding service to new leisure destinations and key business markets. But while United’s Mexico network remains strong, customer demand on certain routes has declined and the flights are no longer financially sustainable.

As a result, United is adjusting flying to several cities throughout the country, including MEX (Mexico City), BJX (Leon, Guanajuato), QRO (Queretaro) and SLP (San Luis Potosi). Additionally, after careful analysis, United has made the difficult decision to discontinue service to HUX

(Huatulco), MZT (Mazatlán) and VSA (Villahermosa).

*“Mexico remains an important piece of United’s international route network,”* said International Network VP Patrick Quayle. *“While the decision to discontinue service to these cities was a difficult one, United will continue to closely monitor demand for travel in the region and look for new flying opportunities for United customers.”*

Here is a summary of the changes coming this summer to United’s Mexico service:

- MEX (Mexico City): Effective October 4, United will increase EWR-MEX service to three times daily and will end service between LAX-MEX. United will reduce IAH-MEX service by one daily frequency starting August 20, resulting in six peak daily roundtrips. Effective June 23, United will no longer offer weekly Saturday service between DEN and MEX.
- BJX (Leon, Guanajuato): United will continue to offer four times daily service between IAH and BJX, and introduce new daily service between ORD and BJX starting October 28. Effective October 4, United will no longer operate twice-daily service between LAX and BJX.
- QRO (Queretaro): Effective December 19, United will increase service to four times daily between IAH and QRO.
- SLP (San Luis Potosi): Effective December 19, United will upgrade IAH-SLP service from the 50-seat Embraer RJ145 to the 76-seat Embraer E175.
- HUX (Huatulco): Effective June 23, United will no longer operate its Saturday-only service from IAH.
- MZT (Mazatlán): Effective August 18, United will no longer operate service between MZT and IAH and ORD.

**Torgy's Travel Tips –**  
**ft.ual.com = The New FlyingTogether Website**



If you've accessed the FlyingTogether website recently you already know that it has a new, updated look and feel. It is mindful to remember that active employees need operational information at their fingertips so much of the main screen was designed to assist them on-the-job.

As retirees, we can find the information we need with a few simple clicks. Read along as I give you a good overview on how to access the most used portions of the website for retirees. It will be helpful if you read this while actually accessing the website so you can visually identify the location and access points herein discussed. *(Please note: Mobile devices show slightly different screen designs. I will give some navigation tips for mobile devices at the end of this article.)*

First of all, use the new shorter title to access the website: [ft.ual.com](http://ft.ual.com), then sign on as usual. You will be greeted by a colorful screen with a personalized banner

across the top:

△ MyWork EmpSvcs News OurAirline Travel ♥ Apps

Notice your home city, the current temperature, your name and lastly, the place to sign out on the top line. The next line contains the symbol for Home (a house) followed by 5 clickable topics: **MyWork**, **Employee Services**, **News**, **Our Airline**, and **Travel**.

At the far right of that line is where you can store/access ♥Favorite pages you frequently use and lastly, the Apps symbol that currently launches the Book Travel app only, but will be expanded to other apps in the future.

Below this banner are features including Headline Stories, UA in the News, Operations Snapshot and Social News and Comments. There is a great, real-time map displaying domestic Weather/ATC delays in the Operations Snapshot section – great for us pass riders to keep an eye on when standing by.

At the bottom of the screen are the phone numbers you might need for assistance with anything from password resets to retiree benefits.

But if you're like me, I most often access the website when I want to travel, whether using a pass, purchasing a ZED fare offline or booking a confirmed UA reservation using the *myUADiscount* program. All of these can be accessed by clicking Travel in the banner line. This topic drops down 4 columns:

Top Hits - Pass Travel - Programs&Policies -Tvl News

Clicking Top Hits reveals 6 choices, basically everything you need to list for UA flights, purchase a confirmed UA ticket using the myUADiscount option, obtain an offline standby ticket, contact the Employee Tvl Center or get a refund. Every topic is clickable and you can navigate between screens by clicking a blue box titled: In This Section located in the upper right corner of each sub-topic or by using the △ Home symbol on the banner line. It couldn't be easier to find what you need, could it? (Well maybe it could, if you *bookmark* your frequently used pages by adding them to your ♥ Favorites. Located at the bottom line of each page is a command you can click that places that page into your shortcut index called ♥Favorites. The next time you want to access that topic, just click ♥Favorites on the home screen banner line and choose your selection.)

If you need to add or change your Enrolled Friend, print out your pass travel usage report, or find answers to pass travel questions just click Pass Travel located next to Top Hits.

Information on types of travel, policies, trusted travel programs and Retiree pass travel is found in Programs&Policies.

Travel advisories and alerts from the CDC are located under Travel News.

Are you looking for Employee Discounts for cars, hotels, cruises, etc.? You will find these back in the banner line of the home screen under Employee Services. When the dropdown menu appears, click on Total Rewards, then View All or click In This Section.

If you are using a **mobile device** to access [ft.ual.com](http://ft.ual.com), the home screen does not have room for a banner line. Instead, use the Menu header at the top left corner to drop down the header topics and then right arrow to open up the sub-topic. And strangely enough, there is no Sign Out command on the home screen for mobile devices! You will find it hidden inside the My Profile topic in the Menu dropdown. Go figure!

You might want to keep a copy of this information by your computer and another in your suitcase until you become accustomed to the new site. You'll be a pro in no time!

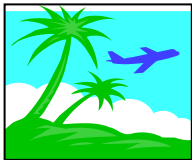

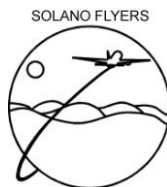

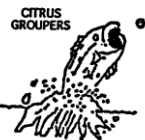

Unfortunately we have some health issues to report: **Marilyn Woods** had a fall in April which resulted in a compression fracture and is currently going to physical therapy. **Sam French** had triple by-pass surgery the end of April.

Our president shared highlights of her recent conversation with NW Director, **Tom Cunningham**: “[flyingtogether.ual.com](http://flyingtogether.ual.com)” has been replaced with “[ft.ual.com](http://ft.ual.com)” – lots less typing! Anyone using the “favorites” tool will be able to import those sites using the button at the bottom of the page. The retired flight attendants website also has some GREAT travel info: “[rafa-cwa.org](http://rafa-cwa.org)”. Effective in June, retirees will be able to change selection of their two enrolled friends in June and December. This ability to change mid-year is a benefit **ONLY** for retirees. All retirees with more with 25+ years of service pay no travel tax fees, other than some transit taxes set by countries. Those that are charged a service fee will now receive quarterly invoices for all taxable travel, instead of waiting for the \$600 threshold. Those that traveled through London or Narita are eligible for a refund of the hefty port tax if you stayed no more than four hours. If you transferred to a non-United flight, be sure to save your boarding pass which will need to be submitted along with the appropriate form to get the refund. Expect construction over the next couple of years when traveling through Chicago, ORD, or NY Stewart Int’l airport, SWF, which is about 70 miles north of Manhattan. Both sites will be undergoing major upgrades over the next 2-4 years. Employees/retirees are allowed 2 free checked bags when traveling to China AND now Hong Kong as well. Employees/retirees are eligible for 20% discount for all onboard purchases. Just show employee ID with credit card at time of purchase.

For Direct TV discount, (only \$3 with employee discount), go online to prepay. You must use the same card on the flight as used for prepay. All prepaid fess will be debited from card once swiped for the first time, i.e. pay \$15 for five transactions, even if swiped only once for current trip. The next 4 swipes will activate viewing, but will not show up as another charge/debit. Basic Economy now on some flights, will impact checking load factors: only allowed ONE carry on of smaller size, no flight changes or refunds, there are definite seat restrictions, no seat upgrades will be allowed, some seats available to choose with an associated fee up to 24 hours prior to flight, but **most** seats will be auto assigned the day of flight. Checking load factors will get even trickier. Looking at empty seats on seating chart can be deceiving. Can indicate either unsold **or** unassigned. With new Basis Econ, there is potential for many more unassigned seats. Look at the number of available seats instead, **much** more accurate.

Real ID Act: currently WA & OR driver license qualify under an extension that will remain in effect until 10/1/2018. If adequate changes not made by state, DL’s will no longer work as ID for TSA. After 10/1, you may need to use passport or go online and complete steps for qualifying valid ID.

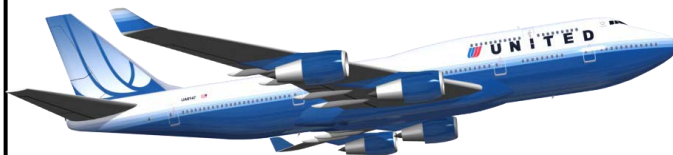

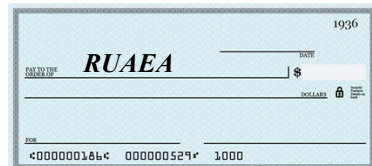
