The Writers' Column

United 727 Project At The Chicago Museum of Science and Industry

Most Chicagoans have been to the Museum of Science and Industry on South Lake Shore Drive, at least once in their life. It's a great place to take your children, grandchildren and even beyond. Heck it's great for us alone! There is a wealth of information in that building. It was built in 1893 during the Columbian Expedition, then it was opened in 1933 during the Century of Progress. My mom still has a little white stick from it, with a red knob on top, and a little sticker on it, 1933, which fell off many years ago. Since then I've been there many times, then took my friends and nephews once they were old enough. Their exhibits are endless, the presentation of the displays are so artistic.

Back around 1992, the Museum invited the 'Hometown Airline', to donate an airplane for their Transportation Gallery. United happily said, yes! Getting it there was quite an ordeal, but as usual, we came flying through. First, we took off from ORD, landed at the now extinct Meigs Field. Boeing plane 7017 was put on a barge to Burns Harbor, Indiana, where it was prepared for the exhibit, and then taken back by barge to the Museum. I understand it was there for about a year. The wings and engines were removed so it could cross Lake Shore Drive, get through the parking lot and into the front door with it's massive columns. They even had to dismantle the columns to get the fuselage through. Traffic was tied up for hours at 57th street and LSD. I taped it on my VCR, from the news at 5, 6, and 10. It even made the national news. I remember looking at the 'in-charge' supervisors' face, who was always so sure of himself, he was probably thinking, 'Now what? What are we doing, how did I get volunteered for this'?

Once it was in place, they attached it to the second floor with three steel I-beams that are built into both the balcony and the plane. The plane itself weighs less than the weight of the parts of the balcony they had to cut

away to make it fit. They had to reattach the right wing on the plane, and have opened doors on the left side so people can walk in and out of the aircraft, from the second floor. The exhibit, 'Take Flight', was opened in 1994, to the delight of thousands of people. Some are afraid of flying, this puts them at ease, they can sit and enjoy without their knuckles getting white. A few times an hour, the plane goes through sounds and motions of take-off, turbulence, and in the cockpit, you can watch the dials and the screens, how other planes are preparing to land. These are the same screens the Air Traffic Controllers can see. The cockpit is surrounded by plexiglass, but you can see all the dials and instruments inside. There are three sections, Aviate, which show the flight instruments, Navigate, navigation instruments, and Communicate, radio instruments. There are buttons on the outside of the plexiglass that we can push to activate lights that shine on all three. That way, when you hit, Activate, the light shines on the altimeter, attitude and vertical gauges. The same goes for the other two buttons.

Inside, the aircraft is divided into three sections. The front shows first class, with the seats from 1964, an orange color cover. The second section is called, Environment, it has information on the walls, showing answers to questions of the weather, turbulence etc. The third section has bare walls showing the structure of the inside of the plane, the 'innards', what goes into the walls between the outside and the nice white walls that we sit next to. Wires, insulation, fun things. Then we have the back stairwell, it actually opens and is used as another exit. Anybody remember D.B. Cooper? The man who threatened a Northwest Airlines plane in 1971, that he would blow up the plane with a bomb. They landed in Seattle; he exchanged the 36 passengers for \$200,000 in \$20 bills. He kept the crewmembers; they took off for Mexico City. Somewhere between Seattle and Reno, he jumped out of the plane from the back stairwell with a parachute and the ransom money. He was never found, some money was recovered years later, but no other sign of DB. On the back of 7017, there is a plaque that says, 'This is where DB Cooper jumped out from a Northwest plane'. Wild story, and it really happened. United put up the plaque so we could see what this man did. Crazy! On a side note on the 727's, if you look on the lower left hand side of the fuselage, there is a vane that is actuated by wind force in flight and it actually locks the air stairs so they can't be opened. It was installed as a result of DB Coopers' escape. The name of the vane? You guessed it, the Cooper vane.

On the floor, parts have been cut away and plexiglass installed so you can see the cargo compartment, and where all your lost luggage is. Even the black box is visible, and outside, the landing gear is operational, twice in an hour. Fabulous show! Our Captain **Ken Voelker**, from ORDFO, is the team leader of other merry men from FO, and they stand in full uniform by the plane, explaining different functions of the 727, answer lots of questions, and hand out pilot-wings to the young visitors. The kids (of all ages) love it. Back in 1964, the aircrafts controls were physically linked to the flaps and other parts by cables and hydraulics. Now, all of those connections are by electronic signals and computers. Progress.

Our own **Oscar Munoz** is on the Board of Directors at the MSI, he walked through the plane recently, and thought, this is showing its age. Nothing had been repaired or updated since the opening. It was definitely looking worn, even Ken could see the deterioration, and told the company. Oscar made arrangements with our Aircraft Maintenance department at ORD, sent three of their finest mechanics and started the ball rolling to upgrade, repair and clean 7017. The exhibit closed in October of 2020, and the work began. **Garrett West**, Managing Director of ORD Maintenance, **Jeff Heisler**, **Jim Fitts** and **Bruce Peleschak**, went to MSI, evaluated what was needed and started their plans. They had to get all those parts working so they could do virtual takeoffs, landings, etc. all the parts were not looked at for 27 years. Many parts were not even available, so they had to manufacture parts at the UAL Hangar.

If you've been to the Transportation Gallery, you know there are other planes hanging from the ceiling, an old locomotive, a gondola that went into the stratosphere, and one of their main attractions, a miniature train that encompasses thousands of feet on the floor, right under our 727 wing. The train ain't moving, and we were not moving tons of our steel, so arrangements had to be made. The museum built scaffolding over the train so our men could reach the engine. Every day they were afraid that they would drop something on those trains, probably worth a million or two. There was a 50 foot ladder attached to the scaffolding so the men could go up and down daily. You can see it in the photos on the back cover. On the Number three engine, they had to set the reverser onto the scaffolding, remove the actuators that were leaking and bring those back to the field to repair, in order to have all those parts moving. They also worked on the thrust reverser. It all weighs about 400-500 pounds. They brought in a flat bed truck, put it next to the plane, and transferred the actuator onto it. Then back to ORD and repair this 57 year old part. As I said, they tried to find parts for the plane, but none were found quickly, so the men built new parts. They made five trips to the MSI, during the pandemic, it was closed for a while, then on Monday and Tuesday, so that's when they could work safely without visitors around. The museum also had a cleaning company come in, they cut the holes in the floor, put in the plexiglass, replaced the

seat coverings, cleaned the cockpit, fixed the lighting, and put in other little extras, a little ‘spit and polish’ to the inside and outside of the fuselage.

After their engine work was accomplished, they had to go back to MSI with all the repaired parts and put them back where they found them. (Just like at home). This was a **big** deal. Jeff mentioned they were glad the repair wasn’t on a thrust reverser in service, since those are filthy dirty, this was nice and clean; Jeff, Jim and Bruce devoted weeks to this project. This was their life, and they are very proud of their work. I hope you can visit and see the new and improved 727, #7017, the 17th plane Boeing built in 1964. At least you know all the work that went into it. Thanks to Oscar, Garrett, Ken, and ‘the boys’. Jeff, Jim and Bruce, our pride and joy display there is beautiful again. I can hardly wait to see it in all its glory. It’s been over 27 years, since the grand opening. Now my nephew, Chris, whom I took there numerous times, can take his twins, and enjoy it, just like we did.

I’d like to thank **Edie Heisler**, EXOCA, for telling me about this major repair project that her son, Jeff, and team, were part of. This is a great story that I’m so proud to pass on to you. The more I mentioned what I was writing about, more people were so willing to share anecdotes of this ‘honey-do’ job.

Hope you can visit, there are so many other exhibits to see. At Christmas, in the main Gallery, they have trees decorated from all over the world, it’s so spectacular. Right now, they have an exhibit of Marvel comic books, even the original magazine, and costumes from some of the Heroes movies on display.

Uniting the world at supersonic speeds

June 3, 2021



As part of our continued strategy to invest in innovative technologies that will build a more sustainable future of air travel, we're excited to announce a commercial agreement with Boom Supersonic, a Denver-based aerospace company redefining commercial air travel by bringing supersonic flight back to the skies – making us the first U.S. airline to sign a commercial agreement with the company.

Under the terms of the agreement, United will purchase 15 of Boom's "Overture" airliners, with an option for an additional 35 aircraft once Overture meets our demanding safety, operating and sustainability requirements before delivery.

Once operational, Overture is expected to be the first large commercial aircraft to be net-zero carbon from day one, optimized to run on 100% sustainable aviation fuel (SAF). The aircraft is slated to roll out in 2025, fly in 2026 and expected to carry passengers by 2029. United and Boom will also work together to accelerate production of greater supplies of SAF.

"United continues on its trajectory to build a more innovative, sustainable airline and today's advancements in technology are making it more viable for that to include supersonic planes. Boom's vision for the future of commercial aviation, combined with the industry's most robust route network in the world, will give business and leisure travelers access to a stellar flight experience," said Scott. "Our mission has always been about connecting people and now working with Boom, we'll be able to do that on an even greater scale."

Capable of flying at speeds of Mach 1.7 – twice the speed of today's fastest airliners – Overture can connect more than 500 destinations in nearly half the time. Among the many future potential routes for United are:

- ▲ EWR-LHR (London-Heathrow) in just three-and-a-half hours
- ▲ EWR-FRA (Frankfurt) in four hours
- ▲ SFO-NRT (Tokyo-Narita) in just six hours

Overture will also be designed with features such as in-seat entertainment screens, ample personal space, and contactless technology.

“The world’s first purchase agreement for net-zero carbon supersonic aircraft marks a significant step toward our mission to create a more accessible world,” said Blake Scholl, Boom Supersonic founder and CEO. “United and Boom share a common purpose—to unite the world safely and sustainably. At speeds twice as fast, United passengers will experience all the advantages of life lived in person, from deeper, more productive business relationships to longer, more relaxing vacations to far-off destinations.”

Torgy’s Travel Tips – July 2021 **Rules, Regulations and Responsibilities**

Yes, it’s true, travel is opening up! You’ve seen it on the news and all over the internet. The vehicle backups to the departure deck at airports nationwide look refreshingly like those in pre-pandemic days. Advertisements for cruises, tours and hotel packages fill your inbox and your mailbox. But are you as confused as I am about “the 3Rs” - the rules, the regulations and the responsibilities of traveling? Read on for an explanation. As always, be aware that this information was current as of June 7th and modifications by international, national and local governments and industry leaders are constantly evolving.

US Travel: Masks are required for all passengers over age 2 onboard all US commercial aircraft as well as within all US airport terminals. Removal of the mask is allowed only while actively eating or drinking. The same regulation applies to all US trains, buses and their respective terminals. This federal mandate is set to expire September 14, 2021. Proof of a negative Covid-19 test is required for entry into the US for all passengers, including US citizens, regardless of vaccination status.

US Theme Parks: Disneyland and Disney California Adventure are planning on reopening to non-California residents on June 15th, but some onsite hotels will not open until July 2nd. Reservations and tickets are required in advance. Masks are required for ages 2 and older. Similarly, Florida's Disneyworld requires the same reservation, ticketing and mask requirements. Parades, shows and fireworks in both states may remain closed, as well as some services and amenities. Go to www.Disney.com for all pertinent information. Universal Theme Parks have a more relaxed policy. Vaccinated guests are not required to wear face masks – however, they do not require proof of vaccination! If you are considering a long-awaited trip with your grandkids who are not yet eligible for the vaccine, be forewarned. Universal Orlando's website www.universalorlando.com states "Any interaction with the general public poses an elevated risk of being exposed to Covid-19, and we cannot guarantee that you will not be exposed during your visit".

Cruises: Some good news for the cruise industry occurred when the Alaska Tourism Restoration Act passed Congress in late May. Since Canada has banned all large cruise vessels until 2022, the cabotage provision of the US Jones Act had prevented foreign-flag cruise ships from resuming summer cruising to Alaska. With the temporary lifting of the requirement to stop at a Canadian port during a voyage, cruising may begin out of Seattle and Anchorage in late July. Passengers aged 16 and older must be fully vaccinated and that age requirement drops to 12 effective August 1st. Departures from ports in Florida and Texas are also beginning preparations for mid-July sailings to the Caribbean. Vaccination requirements are different than Alaska cruises. Recent legislation in the state of Florida prohibiting companies from requiring proof of vaccination runs counter to the CDC's Conditional Order of Sailing and may postpone the resumption of cruises as cruise lines focus on avoiding onboard Covid-19 breakouts. Effective July 1st, a \$5000 per passenger fine can be imposed upon cruise lines departing Florida if passengers are required to provide proof of vaccination before boarding. Cruise operators are fervently working to resolve this huge issue. Cruise lines sailing wholly within Europe are expected to resume departures in mid-July. Transatlantic cruises are still somewhat in limbo, but a departure from Barcelona to the US on Royal Caribbean's Rhapsody of the Seas is tentatively scheduled for November 30, 2021. Onboard experience on all ships will be considerably different than in the past: No more self-serve buffet dining and a higher concentration of shipboard activities (bingo, art auctions, trivia contests) and entertainment. Disembarkation at ports-of-call will be limited to those who purchase ship-sponsored shore excursions guaranteeing a safe "travel bubble" experience.

Vaccine Passports: No firm plans yet exist for implementing a US Vaccine Passport, but work continues by private corporations towards a Vaccination Certificate. Until then your white CDC Covid-19 Vaccination Record Card provided to you when you received your vaccination is all we, in the US, have. The European Union, however, is proceeding with a July 1st target date for a Digital Covid-19 Certificate for its 27 member community which will greatly ease travel for those folks crossing EU borders. On June 4th, the EU decided to maintain prohibition on US, UK and other non-EU countries from non-essential entry to EU member countries. A proposed recommendation to lift this ban starting Jul 1st would allow entry to travelers who are fully vaccinated at least 14 days before their arrival in the EU. Bottom line: Check the entry requirements on United.com before making any travel plans outside of the US.

So, yes travel is opening, but we all have a responsibility to protect ourselves AND others for a while longer. No one wants to repeat another year like 2020. And as for me, I want to be around to fly on United's newly ordered Boom supersonic jet "Overture" in 2029!

Calling All Woodworkers, Carpenters, and Avid Readers ~ Have you heard of Little Free Library? This nonprofit is the world's largest book-sharing movement. Their mission is "Building Community, Inspiring Readers, and Expanding Book Access for All." See their website at www.littlefreelibrary.org. There is a wonderful picture of a little boy opening the door of the Little Library to get a book. The little libraries are like small cupboards mounted on a post and put in your front yard. People are encouraged to take a book, bring it back or share it with someone else, and donate a book if they want. You register your Little Free Library on the website so others can find it, and you can see if there are others already in your neighborhood. The website has the libraries for purchase as well as plans to build one yourself. My friend in rose society loves woodworking and he built one as his spring project. He painted it the same colors as his house, with the trim on the little library matching the color of his front door. He posted a picture on Facebook with the little library surrounded by roses, and it is stunning. He reports that the neighbors love it!

More Turtle News ~ I've been on a turtle roll lately and this month is no exception. I support the Galapagos Conservancy and their newsletter and updates are very interesting. Visiting Antarctica and the Galapagos Islands is at the top of my Bucket List, but until I do, the articles will have to suffice. Many years ago, one of my friends, who traveled the world as TV correspondent, said that seeing the Galapagos Islands was her most memorable trip ever. I'll never forget her saying that if you only take one trip in your lifetime, go there.

In 2019, a lone female Giant Tortoise was found on Fernandina Island during a joint expedition of Galapagos Conservancy, the Galapagos National Park Directorate (GNPD) and Animal Planet. The team was confident that this female, named Fernanda of course, was a Fernandina Giant Tortoise, thought to be extinct for 115 years. Fernanda's blood sample was sent to geneticists at Yale University to determine how closely she is related to the only other tortoise ever found on Fernandina Island, a now-deceased large male found in 1906.

On May 19, 2021 the Galapagos Conservancy announced that the scientists have confirmed genetic similarity between Fernanda and the male found in 1906. Starting in September, GNPD and Galapagos Conservancy will launch urgent expeditions to Fernandina Island to find a mate and save this species from extinction. There is hope because park rangers have found tracks and scat from at least two other tortoises on Fernandina Volcano. Fernandina Island is dominated by this active volcano which makes expeditions very challenging. If a male tortoise is located, he will be united with the lone female at the Galapagos National Park's Giant Tortoise Breeding Center in Santa Cruz. Scientists will then oversee the breeding, raise the young safely in captivity, and eventually return them to Fernandina Island. The Restoration Of Notre Dame Cathedral ~ It seems hard to believe that it has been over two years since fire severely damaged this beloved landmark. On April 15, 2019, stunned Parisians, with tears streaming down their faces, watched the spire burn and fall to the ground. I'll bet that a majority of us have been to Paris and have seen all the major landmarks—Notre Dame, the Eiffel Tower, the Louvre, the Musee d'Orsay, the Arc de Triomphe and Sacre Coeur. One of my favorite memories of Notre Dame is attending an evening organ concert in December 1969. I was one of a handful of tourists there and everyone else was a local.

French President Emmanuel Macron would like to have Notre Dame restored by Summer 2024 when Paris hosts the Summer Olympics, but this may not be realistic. Even if it is open to visitors, it probably will not be fully restored by then.

The first step for Notre Dame's roof and spire reconstruction was the safety phase, which started in the summer of 2019 and lasted until November 2020. Scaffolding was built around the cathedral to restore the spire, tarp was installed above the vaults, gargoyles were wrapped, and the flying buttresses were reinforced.

Construction paused for three months when the pandemic hit but resumed June 8, 2020. Workers then removed more than 300 tons of burned scaffolding that surrounded the spire, which took until December 2020. To remove the scorched scaffolding on the roof, a secondary structure of metal beams was built on three levels to help prevent the collapse of the church. Workers had to dangle on ropes to access the heart of the scaffolding.

In September 2020, as part of European Heritage Days, carpenters demonstrated medieval building techniques and wowed the crowd as they lifted a three-ton truss by hand.

As of April 2021, the date of this article, all the burned timbers have been removed. Workers have now started the next major phase, installing scaffolding inside the cathedral and building a replica of the destroyed spire. There are 200 workers on site every day.

The spire will be made of more than 1,000 donated oak trees from public and private forests from all over France. The trees are being cut and collected this spring before they sap and will be stored for 12 to 18 months to prepare them for the reconstruction phase which starts in the fall of 2022. The goal is to store the wood at a low humidity level (below 30%). Each tree must be long enough to fit an overhead curve of 65 feet long to restore the roof's framework (its nave and choir). Some of the trees are over 200 years old, according to Bertrand Munch, the director general of the National Forestry Office.

If you Google "the restoration of Notre Dame" you will see interesting pictures of the damaged areas and the reconstruction in progress.

The very best Birthday wishes to all of them and hopes for another great year!

Everyone should have read the last RUAEA Newsletter and are getting as excited about the RUAEA Convention as we are. The RESANS team is working hard to make this special. We have been separated from each other for so long, we want this to be a great reunion for all of us. It's not too early to start making travel plans.

Last month I talked about Mission Trails Regional Park and this month I am going to talk about the interesting native plants we have in the Park. Many of these are the same you will see in any of the other parks you may visit on your stay here.

Of the most common and most often seen is Chaparral and the Coastal Sage Scrub. They are shrub plants that can withstand drought and fire and exist together with animals and varieties of other plants. They are specific to Mediterranean type climates and during the dry season, they appear to be dormant but after just one day of gentle rain shades of green can appear in areas that were previously brownish gray.

Some of the most common plants in the Chaparral family are the California Sagebrush, which has fragrant leaves similar to that of dill weed. Black sage has larger leaves and of a darker green color with pale lavender flower clusters and turn into dark spheres as they age. White sage has a downy almost white foliage with white to pale lavender blooms. Lemonade berry is a member of the sumac family and produces a sticky fruit with a sour taste. The native Indians made a soothing drink from the berries. The coastal golden bush is a member of the sunflower family which blooms in late spring and into late fall. Their bright yellow flowers dominate the hillsides and trails of the Park.

The rarest oak in California is the Engelmann and is found in only one known location with Mission Trails Park. It can be seen along the Oak Grove Trail near the Visitor Center; they are characterized by their longer leaves and longer, slender acorns. Other Oaks to be found in and around the area are the scrub oak which is smaller and thrives on the drier hillsides and is smaller than the Engelmann Oak.

If you are interested in wildflowers that grow around Mission Trails and other parks in the San Diego area, stop by the Visitor Center and buy the colorful brochure, "Flowering Plants of Mission Trails Regional Park". Over 60 varieties are clearly identified along with good photos and when they are in bloom. There is always something blooming in the Park due to our Mediterranean climate.

Some of the same can be found in the other parks around San Diego. If you visit Torrey Pines Park you will see many that will be familiar to you from your adventure in Mission Trails Regional Park.

Next month I will talk about another interesting place you may want to visit while in our lovely city.

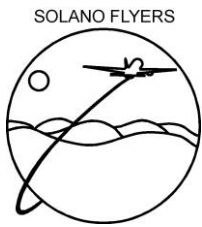

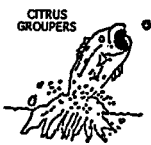

The paper started in 1847, was destroyed by the big fire, rebuilt, and continued in the reins of Robert McCormick and Joseph Patterson. Over the years they bought other papers, in LAX, BAL, BDL, NYC. Unfortunately, they over extended themselves, and filed for bankruptcy in 2008. Sam Zell, Chicago investor, bought out the Tribune with intentions to take the company private. Because of a sharp downturn in advertising revenue, the paper had a debt load totaling \$13 billion. It took over four years to exit from Chapter 11. Oaktree Capital, JPMorgan Chase and Angelo, Gordon & Company assumed control of the Tribune. In 2013, they cut 700 jobs from the paper. For many years, it went back and forth to different owners and even buying other papers for their Tribune Publishing Company. In 2019, Alden Global Capital, a New York City based hedge fund acquired 32% of the Tribune. During the Covid 19, in 2020, they closed many of their newsrooms in NYC, BDL, Orlando, and others. Then in May of 2021, the Trib was acquired by Alden, a company that's known for severe cost-cutting. They immediately let go 30% of the staff, then offered a buyout to non-union employees. Other regional holdings include the Naperville Sun, Elgin Courier-News, Post Tribune of Northwest Indiana, Daily Southtown Pioneer Press and the monthly Chicago and Naperville magazine. If a person's buy-out was approved, they were gone within the week. The CEO left the day Alden walked in. They are presently \$278 million in debt, with people getting their news on the internet, no wonder the advertising income is down. With writers leaving, who knows how this will end, no writers, no news. I remember my grandfather sending me to the newsstand after church on Sundays. I'd get the Tribune, Sun Times and the Daily News. Those were heavy to carry home, but my family read all of them. The News is gone, the Times is in a similarly sad situation, now my favorite, the Trib, is definitely in trouble. My Aunt Gen used to write for the Tribune for 31 years, so we always had the paper around the house, it was special to us. Thanks for letting me ramble on, but this is just one more thing leaving our world, Marshall Field's, Carson's, Macy's, Penney's, Sear's, my God, Sear's? I won't even mention the restaurants. It's a whole new world out there, the pandemic sure didn't help. I guess that's why I push us all to get out and enjoy. Someday we'll get closed down, too.

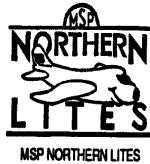

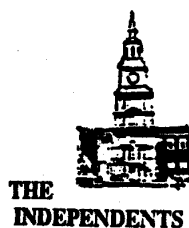

Further details will be available toward the end of July via this column (in the August issue) and a special mailing to chapter members. It is expected that members will discuss the possibility of resuming chapter meetings in the fall.

Last October our own **Lilly Kodama** (SEAMD) appeared on TV with re-elected Washington Governor Jay Inslee, a Bainbridge Island neighbor. Prior to her retirement, Lilly was the nurse in the United Airlines Medical Office in the Administration Building at SeaTac Airport.

Lilly has occasionally attended our chapter luncheons, but it's a long trip over and back from Bainbridge. She recalls that some years ago she was on a United flight when a loud-speaker announcement noted it as a historic flight, with an all-female cockpit crew – a real milestone.

In retirement, Lilly has spent her spare time volunteering at the Bainbridge Island Historical Museum as a docent and a speaker on the incarceration of West Coast Japanese Americans during WWII, a subject much in the news over the past couple years. Lilly and her family were taken away from their home, as were many others, and relocated to a California internment facility under President Franklin Roosevelt's Executive Order 9066 covering the years 1942-1945. When asked to tell more about what happened during World War II, Lilly responded with the following narrative:

"I now live in the house my grandfather originally owned, and subsequently my parents. I was their first born and now I am back living in the house where I started my life. The Bainbridge Island Japanese were the first group to be removed from the West Coast even before the larger populations of Japanese of major cities such as SFO, LAX or SEA.

There are many different viewpoints about why this was so. American incarceration camps were yet to be constructed and we were taken to Manzanar in California where there were a few barracks already constructed to accommodate a group as small as our Bainbridge community, which happened to be located between Seattle and Bremerton. As more barracks were constructed families from California began to be brought in. I am relating this to explain why our story is such a large part of Bainbridge Island's history ...

...The Bainbridge Island Review' editorialized at the time against our incarceration, pointing out that these are our friends and neighbors and that the entire episode was unconstitutional. It was the only West Coast news media to do so and they were honored for it years later.

All during the relocation the Review published articles sent in by reporters from camp with news of special events, births, deaths, and the usual small-town news of that era. With the Review's efforts like this the remaining Islanders who were not taken away did not lose track of us and after the war ended it is said that the highest percentage of returnees to their original homes was on Bainbridge Island. I feel so strongly about my hometown and how important friends are and how we are human beings first.

I felt that my working in Medical at SeaTac was just perfect and was the work community I loved."

Now we are in the middle of the second "Summer That Was," though 2021 is quite an improvement over 2020. Here's to a safe and sane 4th of July, as we like to say. Wave the flag and count your blessings, especially those allowing us to live in a free country, where citizens can (and sometimes actually do) work together to defeat the enemy, whether a foreign military power or a life-threatening medical issue. Here's to the Red, White and Blue!
