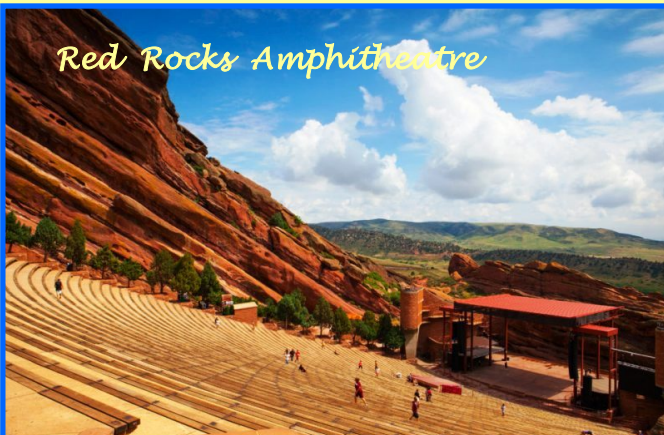

### **Debt Stress**

The average American owes \$59,580 in debt. Of that \$59,580, \$41,830 is from mortgage debt, \$5,640 is from student loans, and \$5,470 is from auto loans. Little wonder that money worries can be a major cause of stress.<sup>1</sup>



**The Link Between Stress and Health** ~ Humans have an innate response called “flight or fight.” It is nature’s way of launching our bodies into action; consider the physical responses we feel during moments of stress—faster heartbeat, accelerated breathing, tightening of muscles, and increase in sweating.

These are response mechanisms that prepared our ancestors to run from, or confront, a danger on the savanna. But they can be less useful in more modern times.

In the short term, stress can manifest itself in physical symptoms, such as headaches, fatigue, difficulty sleeping or concentrating, an upset stomach, and general irritability.

These brief episodes of stress usually do not cause lasting harm to personal health.

However, debt—and the stress it causes—is often a persistent problem. If your stress system stays activated over longer periods of time, it can lead to serious health problems, such as weight gain, fatigue, anxiety, depression, headaches, and sleep problems.<sup>2</sup>

**Managing Stress and Debt** ~ If you are experiencing debt-related stress, you should consider attacking the root of the problem. Generally, it takes time to work down debt, but that doesn’t mean you can’t manage the stress during the interim period.<sup>3</sup>

Developing a strategy to eliminate your debt is the first step to lowering stress since the sense of control that a strategy gives you might furnish you with hope and optimism.

It’s also important that you keep your debt worries in perspective. Remind yourself that debt may not permanently ruin your life. Writing in a journal can be helpful as an outlet for the worried thoughts that can cycle endlessly through your mind. Seek social support—knowing that family and friends are in your corner can be a great source of strength.

Finally, find time for laughter and extending small kindnesses—each unleashes wonderfully positive chemical reactions that are good for the soul and the body.

**Air to Jet Fuel: United Announces Investment  
in Power-to-Liquid Fuels Company Twelve  
May 6, 2025**

United today announced an investment in Twelve, an innovative low carbon fuels company that uses a process similar to photosynthesis to transform CO<sub>2</sub> and water into sustainable aviation fuel (SAF) using renewable energy.

This investment by the United Airlines Ventures Sustainable Flight Fund follows Twelve’s \$83 million Series C funding round and project financing for its first SAF production facility, AirPlant™ One, located in Moses Lake, Washington. The facility is expected to begin production this year and plans to produce 50,000 gallons of SAF annually.

Last year, Twelve secured a SAF purchase agreement with a large European-based airline company. Under the 14-year contract, Twelve will supply 260 million gallons of SAF to support its five airlines. This long-term agreement, combined with the development of Twelve’s first plant, underscores the demand for the company’s innovative technology and SAF.

The SAF Twelve plans to produce once its plant becomes operational, is expected to be a lower-carbon alternative fuel with the potential to reduce lifecycle emissions by up to 90% compared to conventional jet fuel.

*“Scaling the SAF industry is the major hurdle air travel needs to clear in order to increase the supply and reduce the price of lower carbon fuels,”* said Andrew Chang, head of United Airlines Ventures®. *“Twelve has differentiated themselves through the capital they have raised and the SAF contracts they have secured, providing them with the flexibility to commercialize their technology and grow their operations expediently.”*

*“United’s Sustainable Flight Fund’s investment reinforces our momentum at a pivotal moment as we move from innovation to implementation,”* said Nicholas Flanders, co-founder & CEO of Twelve. *“With AirPlant One launching imminently and a strong collaboration with United, we’re not just envisioning the decarbonization of air travel—we’re actively building it. Because we have the capability to deliver our E-Jet® sustainable aviation*

*fuel at scale, Twelve is proudly creating a realistic pathway to carbon-neutral aviation that meets both operational demands and climate goals.”*

Twelve’s advanced technology uses renewable energy to combine carbon captured from air and hydrogen obtained from water into the basic building blocks that make fuels, plastics and other materials. By using renewable electricity, captured carbon and water, the process reduces the reliance on fossil fuels, lowering lifecycle greenhouse gas emissions, including the emissions associated with production of fuels and in manufacturing.

UAV Sustainable Flight Fund ~ The UAV Sustainable Flight Fund<sup>SM</sup> is a first-of-its-kind investment vehicle designed to leverage support from cross-industry businesses in order to support start-ups focused on decarbonizing air travel. **A Message from United CEO  
Scott Kirby to our Customers  
May 2, 2025**



For many years, United has been very clear and vocal about the need to fix the Air Traffic Control system in EWR. While we enthusiastically support the efforts under-way to permanently and structurally fix the FAA, the long-simmering FAA challenges boiled over this week.

In the past few days, on more than one occasion, technology that FAA air traffic controllers rely on to manage the airplanes coming in and out of Newark airport failed - resulting in dozens of diverted flights, hundreds of delayed and canceled flights and worst of all, thousands

of customers with disrupted travel plans. Unfortunately, the technology issues were compounded as over 20% of the FAA controllers for EWR walked off the job. Keep in mind, this particular air traffic control facility has been chronically understaffed for years and without these controllers, it’s now clear – and the FAA tells us – that Newark airport cannot handle the number of planes that are scheduled to operate there in the weeks and months ahead.

United is committed to doing absolutely everything in our power to minimize the impact that this will have on customers and so we are unilaterally canceling 35 round-trip flights per day from our Newark schedule starting this weekend. It’s disappointing to make further cuts to an already reduced schedule at Newark, but since there is no way to resolve the near-term structural FAA staffing issues, we feel like there is no other choice in order to protect our customers.

These challenges are not new to Newark. United has been urging the US government for years to use its authority to effectively limit the number of flights to what the airport can realistically handle. Past failure to make those changes had led to the circumstances that United and, most importantly, our customers now face.

I spoke with Sec. Duffy this afternoon and appreciate his immediate response to my call. We’re pleased that the new administration has put together a proposal for a large, systemwide investment in FAA technology, infrastructure and staffing. In the medium to long term, it’s the only way to solve the systemwide problem. Now, we’re encouraging them to apply this decisive leadership to the difficult situation they inherited at Newark, too – by designating it as a slot controlled, Level 3 airport.

Newark is an incredible airport and takes our customers to 76 different US cities and 81 international destinations. I want to thank the dedicated United team that’s been working hard – especially over the last few days – to take care of our customers at this difficult time. There are also highly skilled professionals at the FAA, including air traffic controllers, who are persevering through technology and staffing shortfalls to ensure that the tens of thousands of people traveling through Newark every day get to their destinations safely. By using the authority it has, the FAA can help Newark fulfill its incredible potential to be a safe, reliable and efficient gateway to the world for the American traveling public.

**Reimagined United Polaris® Lounge Opens in Chicago with 50% More Space and Crate & Barrel Decor  
April 29, 2025**

United today opened its newly renovated and expanded United Polaris lounge at Chicago O’Hare International Airport, offering travelers more space, a modern design and elevated amenities. The United Polaris lounge in Chicago is now 50% larger and features nearly 25,000



sq.-ft. of lounge space, including more than 350 seats for travelers, 50 seats across a larger dining space, a second bar, six additional restrooms, private spaces for relaxation or work, and a range of

products curated along with Crate & Barrel – the first and only airline collaboration for the whole home retailer.

United was the first U.S. airline to debut a premium lounge exclusively for international business class travelers with the launch of the United Polaris lounge in 2016 and currently has six of them in the U.S. – more than any other U.S. airline.

*“Our vast international network is one of United’s unique strengths, and our United Polaris lounges help set the tone for business class travelers before or after their long-haul flights,”* said Aaron McMillan, United’s Managing Director of Hospitality Programs. *“Customers are going to love our new Chicago lounge because it gives them more of all of the things they want most—more space, more amenities, and more dining options—and we’ll carry this new elevated design into future lounge openings and renovations across our United Polaris lounge portfolio.”*

The reopening of the United Polaris lounge in Chicago marks the airline’s latest investment in its network of clubs and lounges. Since 2022, United has opened or renovated a total of nine United Club<sup>SM</sup> locations across its system, including the recent opening of United Club Fly in Houston. In 2025, the airline will open a new dining room in the United Polaris lounge in Newark and a renovated and expanded United Club in Denver’s B West Terminal, which will complete its plan to redesign every United Club. Internationally, United plans to reopen the United Club in Hong Kong. In 2026, United will open a new United Club in San Francisco and its largest-ever United Club in Houston.

In addition to a la carte dining, customers can enjoy a hot buffet with breakfast, lunch and dinner menus, mezze station with lemon honey whipped ricotta, flatbreads and more, and snacks served at both bars like premium nuts, mediterranean olives and a charcuterie board.

**Chicago-Inspired Design and Decor from Crate & Barrel** ~ Inspired by the local region, the renovated United Polaris lounge reflects the Chicago area by celebrating the city’s architecture and unique geography. United worked with Johalla Projects, an art curatorial collective in Chicago, to showcase artwork from nine Chicago-based artists on a range of pieces, including print photography, paintings, collages and more that highlight the region.

To elevate the lounge experience, dinnerware and decor is provided by Crate & Barrel. Marking Chicago-based Crate & Barrel’s first-ever collaboration with an airline, United worked with the retailer’s in-house design and business sales teams to curate timeless pieces that elevate the traveler experience. From Crate & Barrel’s classic Marin dinnerware and new Tuscan Marble collection, to colors of Le Creuset that are exclusive to the retailer, every detail was chosen to enhance both form and function.

**United’s Continued Investment in Clubs and Lounges** ~ United is the world’s largest airline\* with the most extensive international network, offering approximately 500 daily flights to and from 150 international destinations for travelers around the world. As part of the airline’s commitment to grow its network and bring travelers to new destinations, United is investing in renovating and expanding its portfolio of United Club locations and United Polaris lounges.

United is Chicago’s Hometown Airline®, a central hub for nonstop connections across the globe. As demand for international travel continues to grow in Chicago, customers can enjoy the upgraded United Polaris lounge when traveling nonstop to 15 destinations in Europe, as well as nonstop to Asia and South America – continents where United offers the only U.S. carrier service. **United Invests in Next Generation  
Blended Wing Aircraft Start-Up JetZero**  
**April 24, 2025**



United today announced an investment in blended wing body (BWB) aircraft start-up JetZero. The company is creating an aircraft design that has

the potential to deliver jet fuel efficiency and a greatly enhanced customer experience. The investment includes a path to order up to 100 airplanes and an option for an additional 100. The conditional purchase agreement is based on JetZero achieving development milestones, including flight of a full-scale demonstrator in 2027, among other conditions, including that the aircraft meet United's safety, business and operating requirements. JetZero's innovative design reduces drag and produces lift across the entire wingspan, which could lead to as much as 50% reduction in fuel burn per passenger mile compared to a similar sized aircraft. The technology could potentially help United lower its carbon emissions while reducing the cost of operations. In 2023, the U.S. Air Force announced a \$235 million contract to JetZero to fast-track the development of JetZero's full scale demonstrator. The JetZero Z4 airplane is designed to accommodate 250 passengers and fly on conventional jet fuel, with propulsion systems able to utilize sustainable aviation fuel blends. *"If successful, JetZero has the potential to evolve our core mainline business by developing aircraft with a bigger, more comfortable cabin experience for our customers while increasing fuel efficiency across our network,"* said Andrew Chang, head of United Airlines Ventures (UAV). *"United Airlines Ventures® was created to support our efforts to find innovative companies that can enhance the customer travel experience and help the airline lower its carbon footprint, and we believe JetZero reflects that philosophy."*

*"United's investment in our company signals the industry's belief that new, innovative technology is needed in order to achieve the efficiency and cost savings that will be required to meet the continued growth in demand for air travel across the globe,"* said Tom O'Leary, CEO and co-founder of JetZero. *"JetZero is focused on one key technology – the airframe – that enables us to address all of the barriers to growth. This program is the only one in development today that promises efficiency and an elevated customer experience."* Both the airplane's shape, and the way JetZero plans to enter the plane into service, address industry pain points. The design contributes to a more efficient operation due to its shape and the higher altitude at which it will fly. For instance, a flight from New York/Newark to Palma de Mallorca, Spain would use up to 45 percent less fuel compared to the

twin-aisle aircraft that operate that route today. The airplane also is expected to integrate readily into today's airport infrastructure, requiring no new accommodations for jet bridges, runways or taxiways.

The aircraft design has the potential to also offer improvements to the passenger experience like flexible seating options, larger seats across all classes and dedicated overhead bin space for each seat. Additionally, the design streamlines the boarding process with a main boarding door that is wider than that of a comparably sized aircraft, leading to multiple aisles and passenger cabin bays for more efficient passenger distribution. It may further enhance accessibility by featuring wider aisles and handicap-accessible lavatories, creating a comfortable travel environment for all passengers and in-flight crew.

JetZero's agreement with the Air Force focuses on advancing airframe technology and capabilities, showcasing its potential, and providing the Department of Defense and commercial industry more options to reduce fuel consumption and emissions. Several military aircraft configurations can be made with this design, including air transport and refueling tanker variants, which collectively account for approximately 60% of the Air Force's total annual jet fuel consumption.

United's corporate venture capital fund, United Airlines Ventures, enables the airline to invest in emerging companies that have the potential to influence the future of travel. UAV has made investments in start-ups developing innovative technologies that have the potential to revolutionize aerospace developments, create value for customers and United's operation and complement United's goal of net zero emissions by 2050. UAV has made a number of alternative aircraft investments including:

- ❖ Hybrid-electric
- ❖ Hydrogen-powered
- ❖ Electric Air Taxis (eVTOLs)

About JetZero ~ JetZero will deliver the world's first commercial all-wing design airplane. With up to 50% lower fuel burn compared to existing commercial airliners, JetZero's Z4 offers the aviation industry a clear path to delivering a 250 passenger airplane with 5,000 nautical mile range, using conventional engines while reducing its carbon footprint. Working alongside the US Air Force, NASA, and the FAA, and backed by decades of investment and research into blended-wing technology, JetZero looks to enter commercial service in 2030.

**United Airlines Reports Best First-Quarter  
Financial Performance in Five Years**  
**Despite Challenging Macroeconomic Environment**  
**April 15, 2025**

United Airlines (UAL) today reported its best first-quarter financial results in the past five years, despite a challenging macroeconomic environment.



United reported a first-quarter profit, with record revenue of \$13.2 billion, and total revenue per available seat mile (TRASM) growth of 0.5% year-over-year. The company had first quarter pre-tax earnings of \$478 million, with a pre-tax margin of 3.6%; and adjusted pre-tax earnings of \$391 million, with an adjusted pre-tax margin of 3.0%. The company also achieved diluted earnings per share of \$1.16 and adjusted diluted earnings per share of \$0.91, within the guidance range provided at the start of the quarter.

United continued to build brand loyalty in the first quarter and saw strong growth across its diversified revenue streams. Premium cabin revenue rose 9.2%, business revenue was up 7.4% and revenue from Basic Economy was up 7.6% year-over-year. International travel remained strong, with Atlantic RASM up 4.7% and Pacific RASM up 8.5% year-over-year. Other revenue streams such as cargo and loyalty remained resilient and were up 9.7% and 9.4% year-over-year, respectively. Forward bookings over the last two weeks have remained stable, with premium cabins up 17% and international up 5% year-over-year. United believes our proven ability to win brand-loyal customers is a competitive advantage and will make United resilient in any economic environment. In response to the current demand environment, United is removing 4 percentage points of scheduled domestic capacity starting in the third quarter of 2025. United is also continuing to make prudent adjustments to the utilization rate of its fleet, including ongoing reductions in off-peak flying on lower demand days. The airline expects to continue this approach into the fourth quarter of 2025. Additionally, as previously announced, United will retire 21 aircraft earlier than previously planned.

*“Our strategy coming out of the COVID pandemic was simple: Build the best airline in the world to attract brand-loyal customers. The people of United Airlines have executed and built that airline,”* said United CEO Scott Kirby. *“United Next is on track and we will continue to execute our multiyear plan that has allowed United to thrive in any demand environment. It has given us industry-leading margins in the good times and we expect to expand our lead further in challenging economic times. Our ability to win brand-loyal customers and the resiliency of our business is a competitive advantage, and we are accelerating our investments in our product, service, technology and experience to further expand that lead.”* Ongoing investments include the six additional gates at Chicago O’Hare expected to be awarded to United this fall based on a preliminary assessment by the Chicago Department of Aviation, due to United’s continued growth and commitment to Chicago and O’Hare. The airline is also expanding at San Francisco and plans to have the fastest WiFi in the sky with Starlink installed on its entire two-cabin United Express fleet by the end of this year. Customers will also continue to benefit from our technology investments such as new,

more detailed connection information in the United app to help customers make their connection, and Spanish translations that led to increased digital check-ins for international travel.

United’s operation started 2025 stronger than any previous year since 2021. In the first quarter, the airline flew the largest schedule by available seat miles in its history, carrying a record of over 450,000 customers per day on average. United achieved the best on-time arrival and departure rate for a first quarter since 2021 and cut its seat cancellation rate in half compared to the first quarter of 2024. Running a safe, reliable operation continues to be United’s top priority.

At every meeting, we have a raffle for money and door prizes. We pay two dollars for three tickets. The door prizes are whatever people are inspired to bring. **Dee Moreci** won the money, **Jan Soderstrom** won a bottle of wine, and **Carla** won a small stuffed

animal. Next month, we will have to make up for the paucity of door prizes and remind everyone to bring something!

We tried something new at our meeting and I think it was a great success. Instead of sitting at one long table, we broke up into a table of four and another table of five. My best friend is a retired audiologist from the VA and together we devised this plan. Most of us have hearing issues of some kind. I am totally deaf in the left ear. I tell the person on my left to tap my arm when they say something to me, and then I turn sideways in my chair to hear them. When you sit at a long table, the only people you are facing are the one to three directly across from you. However, when sitting at a table for four, or five, everyone is facing each other and you can not only hear but lip read, which we all probably do whether we realize it or not. The conversation flowed freely and in terms of hearing things, I think it was our best meeting yet. I'd love to see other RUAEA chapters try this at their meetings. Another advantage of multiple tables vs. one long table is that people can move about freely from one table to another to socialize. Once you are seated in the middle of a long table you are stuck there until the meal is over!

If you have not read my article in the May 2025 RUAEA newsletter, please do so. I wrote a PSA blurb about things we seniors can do to protect ourselves, especially those of us who live alone or live with a disabled person. This blurb was triggered by one of our members, **Tom Johnson**, falling in January and lying in his house for 2-3 days until a friend came to check on him. I listed actions we can take to ensure that we get help when we fall or are otherwise incapacitated. After our meal, **Rich Bouska** told us what he has done to ensure he gets help if he is incapacitated (his wife **Georgia** is disabled and could not call 911). He has given house keys to a neighbor and his two children. He is supposed to text his neighbor morning and evening at specific times, with just an OK message. The neighbor then texts back OK so Rich knows the neighbor has seen his message. One day Rich got busy doing something and forgot to text at the required time. A few minutes later, there was a knock on the door. It was the neighbor, with key in hand, ready to come in and check on them. What a good plan and what a great neighbor!

I followed **Russ Kennedy**'s advice and bought a cell phone holder which I can put around my neck or wear as a cross body holder. I got it on the Wal-Mart website for \$8.99. It has one section for the phone and another section for a few other things like driver's license or credit cards. One side is clear plastic so you can use the phone without taking it out of the holder. Be sure to measure your phone and check the specifications to make sure it will fit in the holder. This one fits my iPhone 14 Pro perfectly. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. The one and only birthday is **Peter Wronetzki** who will be celebrating his special day on June 29<sup>th</sup>.

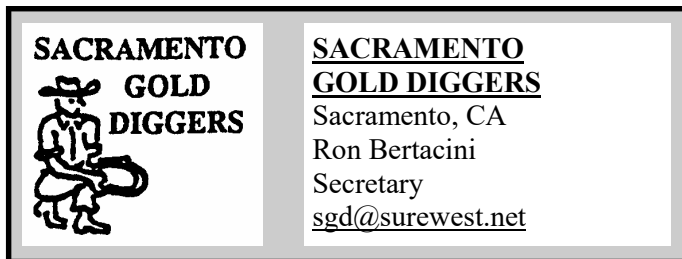

Being a history buff I would like to add some aviation events for April 30: 1969 in Norway, the first woman airline pilot in the West, Turi Wederoe makes her first scheduled flight as a first officer for SAS. She was certified as co-pilot on the Convair 440 and became the first female pilot in a large airline in the Western World. She also flew SAS first jet aircraft the Caravelle and the DC9 before she ended her flying career.



1962 Joseph Walker, NASA Chief Research Test Pilot flew the X-15 rocket plane. The X-15 was dropped from a modified B29 at 45,000 feet. The rocket burn time was 81.6 seconds. The plane achieved a speed of Mach 4.94 (almost 5 times the speed of sound) and an altitude of 246,700 feet.




Also in 1962 the first flight of the Lockheed A-12, the predecessor of the SR-71. This plane achieved a speed of Mach 3.02 at 75,000 feet. The plane would be used for



reconnaissance with a service ceiling of between 84,500 and 97,700 feet. Finally, on this date in 1962 the last flight of a B36 took place. One of the last of the B36's is on display at Wright-Patterson AFB in Dayton, Ohio. There is an A-12 on display at the San Diego Air Museum in Balboa Park.



Finally there were some special events on April 30th for our Nation's History. 1775 the battle of Lexington and Concord that sparked the American Revolution; 1789 George Washington is sworn in as President of the United States at Federal Hall NYC; 1798 The United States Department of the Navy is formed; 1803 Robert Livingston and James Monroe sign the Louisiana Purchase Treaty in Paris for 15 million dollars and this doubles the size of the USA; 1975 Saigon falls ending the Vietnam War. One other event in April ... on the 14<sup>th</sup>, President Abraham Lincoln is shot at Ford's Theater in Washington DC and died early the next day.



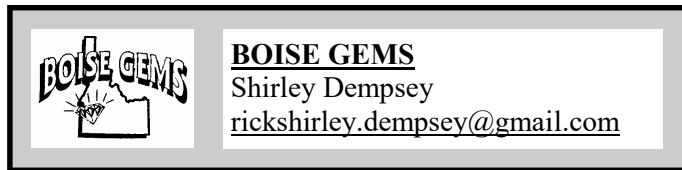

Do you remember **Dale Harper**? He sent out the Daily Operations report to many of us until ill health came his way. Last month, I wrote to his son, he said Dale was holding his own, but with a few problems. He was always so kind to send out that report. Maybe he could use a few prayers from us.

More UAL news. They are removing 4 percentage points of scheduled domestic capacity starting the third quarter of 2025. We're also continuing to make prudent adjustments to the utilization rate of our fleet, including ongoing reductions in off-peak flying on lower demand days. They intend to continue this approach into the fourth quarter of this year. However, international travel is growing about 5% and bookings for premium cabins have gone up 17% compared to last year. I am so glad I did my traveling years ago, doesn't sound very promising for us! We could always drive to Iowa, Indiana, Wisconsin and Michigan. Trains are still running, aren't they? Hey, at least we're still in business! I think we agree we worked during the best years. Sure, we had strikes, problems, lost money, can't forget ESOP, bankruptcy and the ever popular Alegius fiasco. Still shake my head on that one. Didn't they spend like \$2,000,000 to come up with that name? I don't even want to remember what genius decided that one.

They are also considering retiring the older Boeing 767 and 777 jets that we received in the 80's. Doesn't seem that long ago, does it, but it is. I remember when the first 767 came to ORD, we all went out to look at it, now they're saying they are too old, and looking at new models. I found an article that says UAL ordered 50 Boeing 787-9's and 60 Airbus A31neos, with delivery starting in 2028 to 2030. They're calling this, 'United Next' strategy, which focuses on modernizing the fleet and improving the passenger experience. They better hurry, if the other ones are getting old. Jet Zero, an aircraft company, received

orders for their new jets from United and Alaska. They have 250 seats and are called a blended wing body plane. It looks like an F-15 or similar. They are fuel efficient and hope to be an enhanced customer experience. But as of now, they are building a model for the U.S. Air Force. United won't see a model until after that. That should be interesting; we'll see how that idea works out.

This problem will hopefully be settled by the time you read this, but Newark Airport is having their share of problems. They are doing construction on one of their three runways, and the other will have wind slow-downs or stop-pages for weeks. United is cutting 35 round-trips per day from our ORD-EWR schedule. Also, there is a shortage of air traffic controllers. Last year the FAA said they were short 3,000 controllers. They are trying to hire more, but they have strict rules regarding age, ability to handle stress and working extra hours because of the shortages. Scott Kirby said there is nothing else he can do because if he doesn't cut flights, it could cause a serious safety issue. You probably heard of some of the cities affected. The runway is supposed to be closed until mid-June. All airlines are affected and are working to move the flights to the other NYC airports, LaGuardia and JFK.

Of all the things I've lost, I miss my mind the most.

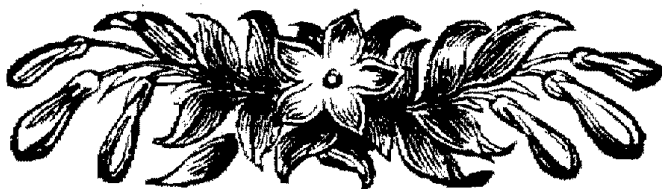

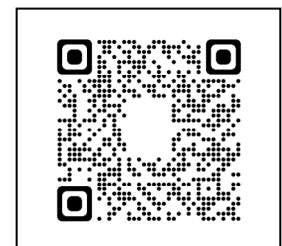

## United Airlines Historical Foundation

"Preserving the Past,

**To:** Mr. J.V. Magee, - Special Assistant to the General Superintendent, Air Mail Service, Washington, D.C.

**From:** Jack H. Knight, Pilot - Experimental Night Flying, Omaha, Nebraska - March 9, 1923

*My Dear Mr. Magee:*

*After several forced landings due to a faulty motor in ship #242, I arrived in Omaha, Nebraska from Dayton, Ohio on February 5<sup>th</sup>, 1923. Numerous repairs to the motor were made from February 5<sup>th</sup> until February 8<sup>th</sup>. On this date, after a test flight in Omaha, I flew the ship to North Platte, Nebraska.*

*At North Platte, on the night of February 8<sup>th</sup>, I made a flight of slightly over one-half hour, before being forced to land by a broken rocker arm and a "missing" motor.*

*The 8<sup>th</sup> was a very dark night with no horizon whatsoever. I had an excellent opportunity to test all my lights as well as my new Turn Indicator and Banking Indicator. On take-off it had been simply a matter of turning out all lights - dash lights and navigation lights - and flying the ship by "feel" until I was positive of 1000 feet altitude.*

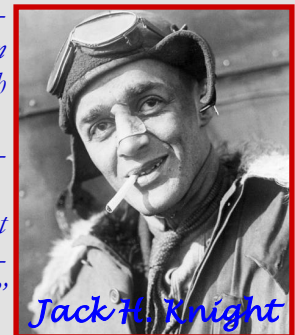
*At this altitude, a slight error in judgment does not have the same embarrassing effect on the ship and pilot that it might have at 100 feet.*

*The ceiling on this particular evening was about 1600 feet and hazy, as well as black. Until my eyes had become accustomed to the darkness, I felt the same degree of accuracy that a person feels in a perfectly strange room which is dark and full of obstacles.*

*I found that it was comparatively simple to fly toward a light (on the ground) some distance away, because you could check your direction as well as balance, but it was a difficult matter to fly into pitch blackness and maintain an accurate compass course at one altitude.*

*After flying ten minutes North by my instruments, I flew a credible return trip by the same method. I next flew the ship from my previous altitude to about 100 feet from the ground and cut-in my Wing-tip lights. The lights carried about 3/4 mile ahead and illuminated fairly well, but the "pencil of light" had a tendency to dazzle slightly and after turning them out, had a tendency to blind temporarily until my eyes became accustomed to the dark again. Regaining 1000 feet, my motor started missing badly so I came back to the field and landed OK, with one search light (landing light) burnt out.*

*At this time there were no Boundary lights on North Platte's landing field except two burning Buckets of Gasoline to show the limits. ■*
